## Senator Kimberley Kitching asked:

**Ms Cosson:** Leading into the Christmas period, Defence, DVA and some other agencies looked at a range of different policy options and we presented those to government. Certainly, with the Attorney-General's being announced as the lead, responsible for developing the office of the national commissioner and also the legislation, as part of the normal government process of consultation, we have been involved throughout that process.

**Senator KITCHING:** What other departments or agencies were involved?

**Ms Cosson:** Defence, the Department of Veterans' Affairs, Attorney-General's, probably Prime Minister and Cabinet, and Finance. There would have been a range. I'm sorry, I don't have them all, off the top of my head.

**Senator KITCHING:** If you could take that on notice and give a complete list, that would be helpful.

### **Answer**

The Departments of the Prime Minister and Cabinet, Defence, and Veterans' Affairs, with input from other relevant agencies, developed initial policy options for consideration by the Government. Various options were later considered by Cabinet prior to the Prime Minister's announcement of the National Commissioner on 5 February 2020. Documents related to this process are Cabinet-in-confidence.

## Senator Kimberley Kitching asked:

**Senator KITCHING:** If you could take that on notice and give a complete list, that would be helpful. How many recommendations of the report of the previous Senate Foreign Affairs, Defence and Trade References Committee inquiry, The constant battle: suicide by veterans, have been implemented?

**Ms Cosson**: In regard to The constant battle recommendations, we provide a regular update on our website, which gives feedback on each of the recommendations and the status of the implementation of those recommendations. I believe The constant battle had 19 recommendations, and 15 have been implemented. If you like, I can make sure that the committee has access to the links to the reports, because there was not only The constant battle; there was also the joint inquiry into Jesse Bird's suicide, for which we have an independent review on the status of implementation of those recommendations. That's also on our website. Similarly, there was an ANAO report into the operations of the department, for which we've given an update on all those recommendations. I'm happy to provide the links to the committee.

Senator KITCHING: Thank you.

### **Answer**

In relation to the Senate Foreign Affairs, Defence and Trade References Committee inquiry, *The Constant Battle: Suicide by Veterans* (The Constant Battle), the implementation of 22 of the 24 recommendations have been assessed as complete or substantially complete. Work on the remaining two recommendations is ongoing and relates to the continuing implementation of veteran centric reform. The implementation of 15 of the 19 recommendations of the Joint Inquiry into the facts surrounding the management of Mr Jesse Bird's case (the Joint Inquiry) have been assessed as complete or substantially complete. The remaining four recommendations relate to longer term projects and initiatives, with three assessed as partially complete and one in progress. **Senator LAMBIE:** I have just one last question. Can I clarify an answer that the Attorney-General's Department gave to Senator Kitching before: are you saying that the government never asked for a costing of a royal commission on veteran and Defence suicides before developing this bill?

**Mr** Anderson: That's not what I said to Senator Kitching. What I said was that the Attorney-General's Department was given responsibility for developing this when the government made the decision to go down the path of the national commissioner, so the costing that we developed, in conjunction with the Department of Finance, was the costing for the national commissioner.

**Senator LAMBIE:** So you did not cost a royal commission. That's what I'm asking.

**Mr Anderson:** We weren't asked to cost a royal commission, because we were asked to cost the national commissioner. That was the model that we were asked to implement.

**Senator LAMBIE:** Thank you. I have no further questions.

**Senator KITCHING:** Just to clarify that: is Defence, DVA or A-GD's aware of whether Finance costed it?

**CHAIR:** I invite them to take that on notice.

Senator KITCHING: Thank you.

**CHAIR:** Does anybody have an immediate answer? No? Alright. Take that on notice.
