

A submission to the Senate Inquiry into the Impact of Mining in the Murray Darling Basin

Australia needs an immediate legislation change for all NEW COAL MINES Australia wide.

1. EIS required by all mining companies before entry on any privately owned properties.
2. All states must develop a mining policy so people know where mining will likely to be developed in the future in the same way that cities have regional development plans.
3. Change Legislation as it currently favours coal mines – please change this immediately to get rid of bullying tactics by coal mining companies.
