Question Taken on Notice – APVMA Response 1

Ms KEAY: I want to just expand on that a little bit because, in relation to hitting the target for assessments leading up to, I think, the September 2016 quarter, we've received some evidence that it was quite strong. You were getting about 80 per cent plus. Then there seems to be, after that quarter, huge decline down to last year. Why would that be the case?

Dr Parker: From memory, I think what you're highlighting is in one class of the applications that we do, which is pesticides for that quarter. I'm happy to find the exact figures, but I'm pretty sure I know the figures. That's in one class of our applications.

Answer:

The table below gives the percentage of applications completed within the statutory timeframes for the period June 2015 – December 2017.

Ms KEAY: until picking up, I think you said, in December 2017.

Dr Parker: December of this quarter, yes.

Ms KEAY: So over those 18 months from September.

Dr Parker: Certainly, we're very happy to provide you with the total staff on and off in that period, yes.

The timeframes for the different application types that the APVMA assesses are set by Schedules 6 and 7 of the *Agricultural and Veterinary Chemicals Code Regulations 1995*. These are described in tables 1 and 2 in the following link apvma.gov.au/node/599.

If the APVMA gives a notice to the applicant under section 159 of the *Agricultural and Veterinary Chemicals Code Act 1994*, the timeframe is extended as outlined in the link provided.

Mr KEOGH: I understand, so it doesn't affect their super or anything like that?

Dr Parker: No, it's a simple cash bonus if you like.

Mr KEOGH: And what's the average APS in the agency?

Dr Parker: The ASL?

Mr KEOGH: Is the average a level 4 or level 5?

Dr Parker: I don't know. We'll provide that to you. I don't have that.

Mr KEOGH: And the average salary?

Dr Parker: Correct.

Answer:

The average salary of our staff is \$97,772.

The APVMA is not able to provide an average APS classification – the most appropriate comparator is the mid-point (median) classification of our staff (that is that there are equal numbers of staff below and above this classification level). The median classification is APS 6.5.

Mr FITZGIBBON: That's pleasantly surprising: 240 of them were regulatory scientists. It looks like your supply of regulatory scientists is stronger than some might think.

Dr Parker: I think I made that point before. I think one of the advantages of being such a public organisation at the moment is that everyone knows who we are and what we do. I was really encouraged by the large number of people who applied for that bulk round. We've employed a number of people from that. We made a merit list and we employed a number of them off that.

Mr FITZGIBBON: How many?

Dr Parker: I believe we've employed 12, but I'd have to double-check the number.

16 new regulatory scientists were engaged from the May 2017 bulk regulatory scientist recruitment round.
