REFERENCE: Question on Notice (Written Questions, 18 June 2021)

QUESTION No.: 1

1. In respect of the 81 retention leases mentioned by Mr Waters:
 - a. How many of the 81 retention leases are owned by foreign owned companies either directly or indirectly through wholly owned Australian companies. Which leases are owned by which companies?
 - b. Of the retention leases how many are older than 15-20 years old, 20-25 years old, 25-30 years old, 30-35 years old and older than 35 years. In each category please list the owners and provide title details with a map showing their location.
 - c. What specific problems can Mr Waters see for himself and other decision makers in NOPTA if the proposed object clause in the Bill became law. Please provide examples.
 - d. The term 'public interest' appears 22 times in the OPGGS Act 2006. How does NOPTA interpret 'public interest' where required to do so? What is the difference in difficulty between interpreting 'public interest' and 'benefit to the Australian community'?

ANSWER

 - Attachment Map 1: 15-19 years old (14 leases)
 - Attachment Map 2: 20-24 years old (3 leases)
 - Attachment Map 3: 25-30 years old (6 leases)

There are currently no leases in the categories of 30-35 years old and older than 35 years.

- 1(c). In relation to retention leases, **the Titles Administrator is the technical adviser to the relevant Joint Authority**. The Joint Authority is the decision-maker on titles decisions relating to retention lease grant, renewal, variation, suspension, extension, exemption, surrender, cancellation and revocation.

As the technical adviser to the Joint Authority, NOPTA undertakes an assessment of a retention lease application against the legislative criteria set out in the *Offshore Petroleum*

and *Greenhouse Gas Storage Act 2006* (the OPGGS Act) and any relevant regulations and/or published guidance material.

The Bill proposes introducing an additional object into the object clause of the OPGGS Act “to ensure that the exploitation of these natural resources is for the benefit of the Australian community”. The following issues with the proposed amendment are noted.

i. **The proposed amendment is vague and unquantifiable**

The wording in the proposed amendment is vague and it is unclear what “benefit” is being measured and how it could be quantified. If the benefit being measured is a fiscal one, **the OPGGS Act is the incorrect piece of legislation to be amended** as it does not provide taxation or fiscal returns to the Australian community.

Due to the vague, broad-natured wording of the proposed amendment, **it is unclear how the Titles Administrator would undertake an assessment against this as a criterion**. As a technical adviser who is required to undertake assessments of titles applications against the specific legislative assessment criteria for that application, it is unclear how the Titles Administrator would ascertain which benefit to assess, how to assess it and how to quantify it in order to make a recommendation.

It is also unclear how this criterion would interact with existing legislative assessment criteria for titles applications. For example, if a benefit to the Australian community is said to be derived by a petroleum resource progressing to production; but the resource does not meet the legislative criteria in the OPGGS Act and consequently triggers a legislative requirement for the Joint Authority to refuse the application.

A further example relates to optimum recovery of the petroleum – it may be the Titles Administrator’s assessment that more wells or infrastructure are required in order to ensure optimum recovery of the petroleum from the field. This would increase project expenditure and potentially reduce associated taxation payments under taxation legislation but would ensure optimum recovery of the petroleum.

ii. **The proposed amendment may increase challenge and/or review of titles-related decisions by third parties**

An outcome of the proposed amendment becoming law is a likely increase in review and/or challenge of titles-related decision under the OPGGS Act by third parties. These reviews and/or challenges may be based on a range of factors, some of which are likely to be unrelated to the legislative criteria for the titles decision.

Other comments on the operation of the OPGGS Act:

iii. **The OPGGS Act does not deliver taxation benefits**

The Explanatory Memorandum to the Bill and Senator Hanson’s comments appear to focus on a benefit being derived through increased taxation returns on petroleum projects. **The OPGGS Act is not a taxation mechanism and does not impose fiscal (taxation) obligations on petroleum titleholders**. It only imposes cost recovery fees and levies associated with the administration by NOPTA and NOPSEMA of petroleum titles and activities.

Therefore, the proposed amendment to the OPGGS Act will not deliver an increase in taxation returns to the Australian community.

iv. **PRRT returns do not usually derive from retention leases**

The Explanatory Memorandum to the Bill and Senator Hanson's comments appear to focus on retention leases. A retention lease authorises the lessee to explore for petroleum in the lease area; to recover petroleum on an appraisal basis in the lease area; and to carry on such operations, and execute such works, in the lease area as are necessary for those purposes (section 135 OPGGS Act).

It is an offence for a titleholder to carry on petroleum recovery operations under the authority of a retention lease (section 160 OPGGS Act). A retention lease holder may only recover petroleum on an appraisal basis which, if subject to PRRT, would be very minor. PRRT and royalty returns are primarily derived from commercial petroleum recovery operations which may only be carried out under the authority of a petroleum production licence.

Therefore, a focus on retention leases does not result in an increase in taxation returns to the Australian community.

v. **The OPGGS Act does not consider the nationality of an applicant**

The OPGGS Act does not consider the nationality (domestic or foreign) of an applicant. In our view, requiring an assessor (NOPTA) or decision-maker (the Joint Authority) to consider the nationality of an applicant for a retention lease would be an irrelevant consideration under the OPGGS Act.

- 1(d). 'Public interest' is a common term applied in legislation and senior case law exists on its interpretation and application to a wide range of legislative enactments. When interpreting the term 'public interest' in the OPGGS Act, the Titles Administrator applies the relevant case law precedent and has regard to the relevant scope and purpose of the part/s of the OPGGS Act in which the term is used.

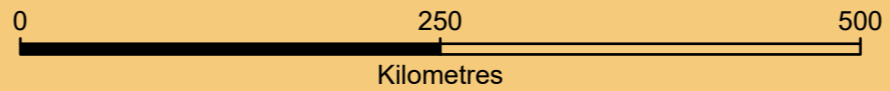
