CONTAMINATED WATER, AT THE BOTTOM OF
LAKE COCHRAN, WILL SEEP INTO THE SAND AQUIFERS
FOREVER, CONTAMINATING GROUNDWATER FOREVER,
UNLESS THE LAKE IS REMEDIATED.

ALSO, LAKE COCHRAN, DRAINS AT THE SURFACE,
VIA DAWSONS DRAIN, TO FULLERTON COVE, WHERE
CONTAMINATION HAS BEEN FOUND. SO THE LAKE IS

CONTAMINATING AREAS, THROUGH CONTAMINATION, SEEPING INTO THE SAND AQUIFER, CONTAMINATING GROUND WATER & THROUGH SURFACE RUN OFF EG, VIA DAWSON'S DRAIN ETC SURFACE RUN OFF IN TIMES OF HEAVY RAINS IN THE AREA.

AS EXPRESSED, LAKE COCHRAN IS HEAVILY CONTAMINATED & UNLINED:-

- NB IF CONTAMINATED PRODUCE WAS SOLD EG, PRAWNS FROM FULLERTON COVE, WHERE WERE THOSE PRAWNS DISTRIBUTED TO & SOLD AT? THE PUBLIC HAVE A RIGHT TO KNOW.

- YOU OFTEN HEAR ABOUT THE HIGH INCIDENCE OF CANCER AMONG FIRE FIGHTERS, IS THAT BECAUSE THEY HAVE ALSO BEEN EXPOSED TO PFOA

AND PFOS?..

— SEVERAL PEOPLE LIVING IN THE WILLIAMTOWN RAAF BASE AREA, HAVE DIED FROM BRAIN & BOWEL CANCERS, SHOULDN'T, FOR EXAMPLE, BLOOD TESTS BE DONE FOR PFOA & PFOS ON RESIDENTS, AT LEAST SOME ^{PEOPLE} IN THE CONTAMINATED AREAS?.. AT LEAST THIS WILL REVEAL WHETHER THEY HAVE THE CONTAMINANTS IN THEIR BLOOD &/OR TESTS, OF THEIR FATTY TISSUE IN THEIR BODY, WHERE CONTAMINANTS CAN ACCUMULATE.

THESE TESTS ^{TO BE} DONE, IRRESPECTIVE OF THE LACK OF EQUATING THE LEVELS IN ^{THE} BLOOD, TO THE RISKS OF SICKNESS, ILLNESS & DEATHS.
