CHAIR: I am going to the speech written by PM&C where you provided some advice on 31 March 2023 to the Prime Minister. The Prime Minister said:

... I knew I could pick up the phone and Qantas would swing into action, getting Australians to safety.

Is that something the department wrote, or is that something the PMO wrote?

Ms Luchetti: I'd have to take that on notice. I don't have the speech here.

CHAIR: You don't have a copy of the three event briefs in your folder?

Ms Luchetti: I don't a copy of the briefs, nor do I have a copy of the speech. I'd have to go back and see what version we sent from the department up to the office.

CHAIR: I'd appreciate your tabling what you sent up to the office, and then we can understand who's got whose mobile.

Answer:

A draft speech was provided by PM&C to the Prime Minister's Office on 28 March 2023. It included the following line:

"I was the minister responsible for aviation for many years. I learned whenever there's a crisis, you pick up the phone and Qantas will be there."
