Mr Chalmers: I can certainly provide that. Senator REYNOLDS: Have you got it here now?

CHAIR: I don't think we are going to fill time by reading out a list of projects.

Mr Chalmers: I can take it on notice.

If you add those two figures together, 102 projects out of 171 are either delivering services or have reached completion.

CHAIR: That makes sense. The figure I used of 63 out of 171 was right as far as it goes, but that was infrastructure. There is an additional group of service projects. If you could take on notice an update on the projects, that would be helpful. I understand that some of them are still being reviewed by the government to see whether they are even feasible Senator REYNOLDS: On that information, are you able to confirm which federal seats they went to?

Senator REYNOLDS: Thank you; that was very helpful. The chair mentioned the expressions of interest before this. Can you confirm who those EOIs went out to? My understanding is that they went to states and territories, community organisations and PHNs; is that correct? Ms Pratt: The EOIs, on 24 December 2018, only went to states and territories. In early January, the 2nd, they went to primary health networks. There was no EOI process for nongovernment organisations.

Senator REYNOLDS: They went to states, territories and PHNs. As we just clarified, decisions for these went through cabinet and budget processes, as appropriate, according to the different program. They were announced in the 2019 budget; correct?

Ms Pratt: Yes.

Senator REYNOLDS: They did go through that process. The chair was trying to allude earlier to it being just the minister who may have unilaterally made those decisions. Just to clarify—

Ms Pratt: It went through the correspondence process at the end of the budget process.

Senator REYNOLDS: Correspondence, but still through the cabinet process—

Ms Pratt: Yes.

Senator REYNOLDS: and into the budget process. I am trying to work out the numbers you have given me. Correct me if my maths is wrong: 90 per cent of the service delivery projects are underway or complete?

Ms Pratt: Of the service delivery projects—

Mr Chalmers: Of the service delivery projects, 39 are underway. I don't have a breakdown here of which ones are which.

Ms Pratt: Of the service delivery projects, there are 25 services commenced and 42 are complete.

Senator REYNOLDS: So 42 are complete. Perhaps you could take on notice how many are complete, in terms of absolute numbers of projects, plus the dollar value that sits underneath that.

CHAIR: I am trying to be helpful here. Why don't we just put one comprehensive request in for the projects? All of the service delivery—do we want to step that together?

CHAIR: There is a bit of flexibility in there. I was consulting with the Deputy Chair. We've each asked for some information on the way through. Can I have a go with your agreement or concurrence now that we're all friends again? So, just to perhaps restate our information request, which might supersede some of the requests along the way. If it was possible to get a table—and I think these headings would suffice; if you then wanted to confirm with the secretariat so that we're commissioning the right information in one go rather than a whole lot of wasted effort—that set out the project, whether it was approved or identified through an EOI or some other process? So, which program it was from, if there were a couple of subprograms? There are conflicting dollar figures, \$2 billion and \$7 billion. So, which program or stream was it from? Was it for services and infrastructure? Was it being delivered via a national partnership agreement or a grant? What was the approved dollar value? What was the expected completion date, and a status update? If it's completed, was it completed on budget and, if it's not completed, what's our sense of the status? And the federal electorate as at 2019, I presume, or whenever you have that recorded. There have been boundary changes in a bunch of states since then. I think that wraps up all of our information requests

Senator REYNOLDS: I think that does, yes.

CHAIR: It will be far more coherent for us. I'd presume from some of the media reporting that some of the project statuses are still under review, but you'll make that clear going forward?

Ms Pratt: Yes.

## Department of Health and Aged Care Joint Committee of Public Accounts and Audit Inquiry into probity and ethics in the Australian public sector

Ethical behaviour of the Department of Health and Aged Care

#### Question:

According to the Department of Finance, probity is evidence of ethical behaviour, and can be defined as complete and confirmed integrity, uprightness and honesty in a particular process. While agencies can often demonstrate the absence of fraud, corruption, illegal activity or conflicts of interest, does a mere absence of illegality, fraud, conflicts or corruption actually indicate probity? How does the Department of Health and Aged Care (Health) assess whether it is acting in a way that is right and proper, not just in a way that is technically and legally correct?

#### Answer:

The Department of Health and Aged Care's (the Department) Assurance Framework (the Framework) provides guidance to all staff on ensuring outcomes are being met in an efficient, accountable, and ethical manner. The Framework identifies areas of assurance need, advice on conducting assurance and communicating findings to the Department's Executive. The Framework has improved assurance literacy in the Department, promoted a culture of probity and increased the frequency of and value derived from, assurance reviews. More information is provided on the Framework in IQ23-000105.

The Department has a risk-based Internal Audit Work Program (IAWP) that is developed through an annual assurance mapping process. The effect of the IAWP is to hold all staff accountable and promote ethical decision making as well as legislative compliance. Since 2020, the IAWP has included internal audits examining the controls in relation to fraud management, public interest disclosure, and physical and cyber security. In addition, the IAWP has considered conflict of interest through the Department's conflict of interest framework including in relation to procurement, the membership of boards and

committees, and the procurement and contract management of IT contractors. More information is provided on the IAWP in IQ23-000105.

The Department's approach to internal assurance and audit is supported by independent external assurance such as the *Halton Review of COVID-19 Vaccine and Treatment Purchasing and Procurement* and recent Australian National Audit Office (ANAO) audit activity where procurement and conflict of interest have been examined. This included the recent audits into the National Medical Stockpile and the COVID-19 vaccination program. The Department actively monitors the implementation of all internal and ANAO recommendations to promote a culture of improvement in relation to compliance. The progress of recommendations is reported to the Audit and Risk Committee and Executive Committee.

The Department ensures all staff are aware of their legal and ethical obligations through its 'Essential Learning Program'. This program includes two modules focused specifically on integrity and ethical conduct, titled 'Fraud Essentials' and 'Integrity Essentials'. These cover topics such as: the APS Code of Conduct, identifying and managing conflicts of interest, and responding to fraud. As outlined in the Department's Essential Learning Policy, staff must complete these modules within 30 days of commencement and every 24 months thereafter. Staff receive automated notifications before this learning is due to be completed. The Department's Executive Committee consider Essential Learning compliance each quarter, and all Departmental SES officers have access to real-time compliance reporting.

Underpinning the above frameworks and programs is Department's Integrity Framework of policies, procedures, programs and committees designed to promote a pro-active integrity culture which supports ethical behaviour in the discharge of our roles and responsibilities.

The Department's Integrity Framework is informed by the Commonwealth Integrity Maturity Framework, which is a set of 8 integrity principles derived from key Commonwealth integrity laws, policies and procedures. Examples of the Department's integrity approach, including tools and policies, against each of the integrity principles is set out below.

- 1. Values and Code of Conduct
  - Performance (PDS) Policy includes values and behaviours and is supported by the performance Management Toolkit and Managing Underperformance Policy and Procedures
  - Guidelines for Handling Suspected and Determined Breaches of the APS Code of Conduct
  - Procedures for determining breaches of the APS Code of Conduct and Deciding Sanctions (Section 15(3) of the Public Service Act 1999)

#### Question:

The ANAO has found evidence the Australian public sector regularly fails to comply with both the intent and the requirements of its regulatory frameworks. How does Health evaluate how it is positively acting according to the intent of the law and thus demonstrating probity?

#### Answer:

The Department of Health and Aged Care (the department) has several mechanisms to ensure it is acting according to the intent of the law. In addition to the matters referred in response to IQ23-000104, the department has a risk-based Internal Audit Work Program (IAWP) which is informed by a comprehensive assurance mapping process. The IAWP has the capacity and flexibility to add topics where emerging high-risk areas are identified. The IAWP hold all staff accountable for compliance with business rules and legislation as well as ethical and accountable behaviours in the conduct of business. The department also actively monitors the implementation of audit recommendations to embed a continuous improvement culture. The progress of all recommendations are reported to the Audit and Risk Committee (ARC) and Executive Committee (EC).

The department's Assurance Framework (the Framework) promotes an effective system of risk management and internal control to support the achievement of outcomes. The Framework provides guidance to all staff on identifying areas of assurance need, conducting assurance, implementing any recommendations identified, and communicating this to the department's Executive. The Framework is supported by the department's service offering supporting business areas to engage an Internal Audit and Assurance provider to undertake 'real time' assurance advice and guidance.

The department's approach to grants administration has been strengthened by several recent improvements. These include strengthening the content of guidance and templates to support compliance with the Public Governance, Performance and Accountability Act 2013 and the Commonwealth Grants Rules and Guidelines 2017 (CGRGs) as well as meeting ethical standards in the administration of grants. The Accountable Authority Instruction and Finance Business Rules in relation to financial obligations and accountability have also been updated to clarify officials' financial management responsibilities. In addition, the Grants Assurance Program reviews grant administration against mandatory requirements and the principles set out in the CGRGs with the results reported to the EC.

The department operates a responsive financial governance framework, which promotes the efficient, effective, economical, and ethical use of resources. The department minimises non-compliance through layered and integrated controls, including training and guidance, extensive financial reporting and tiered governance, the publication of legislation and rules, regular review of delegation schedules and Accountable Authority Instructions which are available to staff to inform decision making. The department's financial framework includes comprehensive internal assurance programs over procurement and grant processes, which are supported by regular internal and external audit activities. This is a risk-based approach to compliance, with a combination of self-reporting and focused review. All identified instances of non-compliance are reported to both the Audit and Risk Committee and the Executive Committee. The department is also currently conducting a Review of Financial Controls and Assurance to identify further opportunities for improvement in relation to identifying, assessing and reporting non-compliance with finance law. The review is scheduled to be completed by the end of March 2024.

The department has procurement controls including providing business areas with guidance on ensuring probity throughout the procurement process. In addition, it is mandatory that procurement activities over \$80,000 engage with the department's Procurement Advisory Service (PAS) from the planning phase to ensure compliance, probity and value for money considerations are appropriately made. The Procurement Assurance Program tests a sample of procurement activities on a quarterly basis against the procurement framework, including the adequacy of the Probity Plan and probity register, with the results reported to the EC.

When the department receives third party reviews of how it complies with legal, probity or ethical obligations it assesses the review and implements changes to address the issues raised. This includes judgments and decision of courts and tribunals, statutory reviews of its programs by entities such as the Auditor-General and reviews undertaken by consultants.

#### Question:

#### Answer:

The PGPA Act and Commonwealth Performance Framework require the Department of Health and Aged Care (the department) to measure and report on the performance of its programs to demonstrate to the public and the Parliament whether the use of public resources is achieving meaningful results.

The department's Performance Measurement and Reporting Framework provides a strategy to guide effective performance measurement and reporting of programs and policies in the Department. The Framework, along with a range of supporting material, provides guidance to officers in fulfilling the department's legislative obligations to measure and assess performance in achieving its purpose. This includes ensuring that program managers, accountable authorities, Ministers, the Parliament and the public are able to use performance information to draw clear linkages between the use of public resources and the results achieved.

#### The Framework:

- outlines the department's approach to performance measurement and reporting, based on statutory requirements and good practice, focusing on compliance with section 16EA of the PGPA Rule
- provides guidance on how to measure and report on the performance of departmental programs, projects and activities

- establishes a protocol for the department to appropriately measure and report on performance at all levels
- supports the department to fulfil internal and external accountabilities; and
- facilitates continuous improvement to performance measurement and reporting.

The department's Performance Measurement and Reporting Framework is designed to promote and ensure compliance with all legislative requirements.

In designing and delivering programs to achieve their intended purpose, the department seeks at all times to abide by relevant laws. The frameworks and mechanisms to ensure this happens is outlined in other responses, including IQ23-000105; IQ23-000109, and IQ23-000111.

#### Question:

- 6 How are senior staff held to account for driving ethical performance in Health?

#### Answer:

5: The Department of Health and Aged Care (the department) takes its obligations in relation to internal fraud, corruption and other misconduct allegations seriously and has processes in place to ensure all allegations are appropriately managed and investigated. Further processes and delegations are now in place to ensure compliance with section 33 of the *National Anti-Corruption Commission Act* (NACC) in making mandatory referrals to the NACC where potential serious or system corruption is identified or reported. This includes having in place an accountable SES officer to oversee coordination and briefing of the Secretary and Chief Operating Officer on internal fraud and corruption matters, as well as referrals to the NACC. Information about alleged misconduct by employees is handled on a need-to-know basis. Relevant members of the Department's executive are briefed on matters involving senior staff.

The *Public Governance, Performance and Accountability Act 2013* (PGPA Act) requires the accountable authority of entities to ensure the proper use and management of public resources (section 15), and to establish and maintain an appropriate system of risk oversight and internal control for the entity (section 16). Proper use in relation to use or management of public resources means any such use must be efficient, effective, economical, and ethical (section 8).

The department's controls and assurance frameworks have been developed to identify and assess non-compliance with finance law, specifically the requirements of the PGPA Act. The frameworks include instructions, business rules, guidance, systems and business controls,

programs of assurance and responsibility on all officials to self-report. Instances of non-compliance are recorded in a centralised system which prompts corrective advice to be provided on key aspects of the non-compliance (including proper use).

Instances of non-compliance with finance law identified through the controls and assurance frameworks are assessed by the department's Chief Financial Officer (CFO) and reported to the department's Audit and Risk Committee (ARC). Advice provided includes an assessment on instances which may be considered 'significant' non-compliance with finance law (this includes not meeting ethical requirements in the use and management of public resources, if applicable). Upon review by ARC members advice is provided by the CFO to the department's Executive Committee for consideration.

6: SES employees are employed under Section 22 of the *Public Service Act 1999*. SES employees' terms and conditions of employment are generally provided through a Section 24 (1) determination under the *Public Service Act 1999* which outline SES employee obligations to observe, and encourage others to observe, the APS Values and Code of Conduct as provided for by the *Public Service Act 1999*, the *Public Service Regulations 1999*, the *Public Service Commissioner's Directions 2016* and departmental procedures and policies including the SES Performance Framework.

The department's SES Performance Framework (the Framework) applies to all substantive SES and equivalent (Medical Officers Level 5 and 6) employees in the Department, as well as employees who have been acting in an SES role for at least three (3) months. The Framework sets out the standards of behaviour expected of SES employees including:

- the APS Values
- the Secretaries Charter of Leadership behaviours which includes specific expectations in relation to integrity, and
- understanding and abiding by the legal principles of good financial management and building a culture of compliance with finance law across their area of responsibility.

SES employees are formally assessed against these performance expectations twice a year.

The department is currently reviewing performance procedures and policies to further strengthen how these processes drive SES performance and behaviour.

SES officers are required to make an annual declaration of interests. Any conflicts, actual or apparent, are managed in accordance with the requirements of the department's Conflicts of Interest Policy. SES employees are also required to complete the department's Essential Learning Program and retrain in the Integrity and Fraud modules every 24 months.

Any failure in relation to ethical behaviour is considered both in terms of how frameworks, policies or procedures can be improved to support ethical conduct, and whether the behaviour could be a breach of the APS Code of Conduct and/or the obligations outlined in section 35(3) of the Public Service Act 1999.

The department treats all reports or allegations of suspected misconduct seriously. For incidents involving SES officers, consideration is given to engaging an independent, external person to undertake a preliminary assessment of any issues to determine whether there is evidence of conduct which gives rise to a suspected breach of the APS Code of Conduct. That person will make recommendations as to whether and, if so, what action is required to be taken (e.g. instigation of a Code investigation, workplace investigation, counselling, formal warning or administrative action such as coaching or training).

In accordance with the department's obligations under section 64 of the *Public Service Commissioner's Directions 2022*, the Secretary (or his delegate) is required to consult with the Australian Public Service Commissioner before commencing a Code of Conduct process involving an SES employee. Where the department initiates a Code of Conduct process in relation to an SES employee, the department will engage an independent, external person to undertake the investigation and consider the need for independent, external people as breach decision-maker and sanction delegate.

#### Question:

What are the nature of the significant breaches that have been reported to the Minister under section 19 of the PGPA Act (over the past ten years), and how did the accountable authority determine the breach was 'significant'?

#### **Answer:**

The Department of Health and Aged Care (the department) has reported instances of significant non-compliance with finance law in the Department's 2022-23 Annual Report (refer page 116 and 117). This is the first occasion where instances of non-compliance have been assessed as 'significant' in the past ten years (i.e. since the commencement of the PGPA Act).

The nature of the significant non-compliance instances reported relate to:

- the Commonwealth Grants Rules and Guidelines requirement that Grant Opportunity Guidelines must be in place before a grant is awarded. The grants were executed in 2019-20 and relate to the Community Health and Hospital Program.
- Section 83 of the Constitution which provides that no amount may be paid out of the
  Consolidated Revenue Fund except under an appropriation made by law. It was
  identified that programs established by the department (and delivered through
  Services Australia as the payment agency) made payments in breach of section 83 of
  the Constitution. Design and implementation of the programs or elements of
  programs (Medicare Easyclaim, Aged Care Subsidies and fees, and verbal assignment
  of Medicare benefits (Telehealth)) did not appropriately consider the risk of noncompliance with section 83 of the Constitution.

• In 2020-21 the department identified and commenced rectification activities to correct administrative errors in the Medical Rural Bonded Scholarship program. In 2022-23 the department waived \$51.8 million in debts as part of rectifying past administrative errors.

The Department of Finance provides relevant advice in Resource Management Guide (RMG) 214 Notification of significant non-compliance with finance law to support an assessment process. RMG 214 sets out criteria for significant non-compliance noting high volume, high value and/or systemic issues and consideration of risk, in particular reputational risk.

The department's accountable authority accepts the actions taken and/or administrative errors made by officers of the department did not meet public expectations.

#### **Answer:**

- 8. The Department of Health and Aged Care (the department) notes it is common for the Government to make an explicit decision to fund an organisation for a particular purpose. Announcements are often made as part of a budget process or through an election commitment. In these instances, the announcement may precede the development of Grant Opportunity Guidelines. The Commonwealth Grants Rules and Guidelines (CGRGs) apply to specific decisions to fund an organisation for a particular purpose in the same way as they apply to other funding programs. As such the department undertakes grants processes in line with the CGRGs, including the development of Grant Opportunity Guidelines.
- 9. Grant Opportunity Guidelines are developed for all grant opportunities in accordance with the CGRGs. To facilitate this, Grant Opportunity Guidelines are drafted using Department of Finance mandated templates and in line with the requirements of the CGRGs. Guidance materials are designed to support officials undertaking grants processes (including where the recipient has been announced) to ensure that the Commonwealth is achieving value for money and that the proposed grant(s) represent an efficient, effective, economical and ethical use of public resources.

Developing culture of compliance with finance law

#### Question:

- a) Why did Health not have 'a strong culture of compliance with finance law'? Who was responsible for this cultural failure?

#### Answer:

The Department of Health and Aged Care (the department) operates a responsive financial governance framework which promotes the efficient, effective, economical, and ethical use of resources.

The department's financial framework includes comprehensive internal assurance programs over procurement and grant processes, which are supported by regular internal and external audit activities. The department's financial governance framework operates on a risk-based approach to compliance, with a combination of self-reporting and focused review. All identified instances of non-compliance are reported to both the Audit and Risk Committee and the Executive Committee.

Following the Commonwealth Auditor-General's independent performance audit of the Department of Health and Aged Care on the *Administration of the Community Health and* 

Hospitals Program, the Department has taken further action to strengthen the financial governance framework and culture of compliance with finance law.

The Financial Literacy Program aims to address the identified need for improved financial literacy amongst leaders. The Program includes a set of self-paced information sessions aimed at empowering staff with the necessary knowledge to better understand their financial responsibilities at work and build financial management skills. The program provides an overview of the three pillars of Health's financial management framework which are outlined in the department's Finance Strategy:

- A strong financial controls and assurance framework;
- Providing credible and consistent financial information and advice; and
- A financial governance framework which promotes the effective and efficient use of resources.

The financial literacy training has been made available to all staff through the Department's online learning and development portal. Additional financial literacy modules are currently being developed which include Financial Delegations and Instructions, and Managing Administered Funds. Once completed these will be formally promoted throughout the Department.

The department has also engaged an external provider to conduct a Review of Financial Controls and Assurance to identify further opportunities for improvement. The Review commenced on 1 September 2023, and is being governed by a Board which meets monthly.

Introductory meetings have been held with subject matter experts across key functions. The department will review and action recommendations on a rolling basis. The review is scheduled to be completed by the end of March 2024.

**CGRG** compliance measures

#### Question:

Departmental officials involved in the assessment and development of funding recommendations to government formally certified their agreement to be bound by the requirements of the assessment plan and CGRGs (pg 50). Given Health was unable to provide records for several grants demonstrating CGRG compliance, including documented grant assessments, financial viability assessments, evidence supporting the consideration of constitutional and legislative authority for grants, and the basis for assessments of value with relevant money, how could departmental officials formally certify assessments were bound by the requirements of the CGRGs?

#### **Answer:**

The Department of Health and Aged Care (the department) acknowledges failures of process with respect to the recording of Community Health and Hospitals Program (CHHP) grant assessments and funding recommendations. The department's conduct at the time was not motivated by malintent, improper purpose or personal bias.

The department has since revised and significantly enhanced internal grant processes, policies and guidance over the five years following the implementation of the CHHP program. In addition, the department has strengthened both its capacity to provide complex grant advice and the range of training resources that are available to staff involved in the design and delivery of grant programs. These enhancements are designed to both promote compliance with the Commonwealth Grants Rules and Guidelines and to improve the quality of grant program delivery.

The department has also implemented a comprehensive grant assurance program. The assurance program undertakes sample testing on grants awarded by the department to ensure compliance with both internal grant policies and the broader Commonwealth Grant Policy Framework.

#### Question:

The ANAO report details occasions where Health sought and/or was provided advice by the Department of Finance (September 2019) and the Australian Government Solicitor (June 2019) but did not act on the advice (see pgs 40-41, 44-46, 48-50, 52). On what basis does Health determine how to act upon advice from the Department of Finance and the Australian Government Solicitor?

#### **Answer:**

The Department of Health and Aged Care (the department) approach is to seek advice from the Australian Government Solicitor (AGS) on the constitutional authority and legislative basis for a spending initiative, in accordance with section 1.14 of the Budget Process and Operational Rules (BPORs). In providing this advice the AGS considers amendments to program design, amendments to legislation or regulations, or other factors that could influence the constitutional and / or legislative basis for spending. Under standard practice the AGS advice would inform the development of the New Policy Proposal (NPP) for consideration by Cabinet, and subsequent briefs to the Minister on the approach to undertaking the grant. Where risk is assessed as high, section 1.14 (b) requires that the NPP 'incorporate a strong case for not further mitigating constitutional risk and include an outline of the strengths and weaknesses of the options which would mitigate risk.'

Prior to publishing a grant opportunity, the Department of Finance (Finance) requires the development of a Self-Assessed Risk Assessment (SARA). The constitutional authority and legislative basis for a grant program is included in the SARA which is provided to Finance along with the Grant Opportunity Guidelines. Finance provides advice to support compliance with the mandatory elements of the Commonwealth Grants Rules and

Guidelines (CGRGs) and to promote better practice in grants administration. Feedback provided by Finance on the content of Grant Opportunity Guidelines is considered and acted on to ensure compliance with the CGRGs. Once a risk rating has been agreed by Finance the Grant Opportunity Guidelines are provided for approval by the Finance Minister (where the risk rating is high or medium) or the Portfolio Minister (where the risk is assessed as low).

Section 3.6 of the CGRGs requires that before entering into an arrangement there must be legal authority to support the arrangement. The department's briefing template for commitment approval includes identifying the legal authority for the grant, which is based on the advice provided by the AGS.

#### Question:

In November 2022, Health provided to the Minister for Health a letter for his signature addressed to the Minister for Finance. The letter suggested the creation of an additional category of grant in the CGRGs to 'support timely delivery of published and explicit decisions of Government', and the development of 'program level grant guidelines that can be re-used over subsequent years and funding rounds' (page 42). The ANAO found Health had used the rationale 'decisions of government' to administer grants in a manner that did not meet the requirements of the CGRGs and as the basis for not responding to advice from the Department of Finance (see pages 43, 44-46). On what basis could this type of additional category of grant support probity and ethics in decision making?

#### **Answer:**

The Department of Health and Aged Care (the department) considers that it is possible both to strengthen and streamline the grant policy framework. Enhancements to the grant design process could ensure that it was less administratively burdensome for funding recipients and administrators while maintaining and improving safeguards at the government decision-making level. The suggested changes were proposals only and it was not the intention of the department to rely on this approach. The department is continuing to engage in the current Department of Finance led review of the Commonwealth Grants Rules and Guidelines.
