Submission in regard to the Public Governance, Performance and Accountability Amendment (Vaccine Indemnity) Bill 2023

My name is Neil Skilbeck, I am a retired Chiropractor and Osteopath and have worked in the health field for over 50 years in private practice. During the last 15 years I formed a college to train both students and practitioners in both established methods of diagnosis and treatment as well as my newly discovered methods. While I am not a biologist, scientist or medical practitioner I have an above average grasp of the human body and medical ethics and believe that I am qualified to give an opinion on what transpired during the last 2 years regarding the Covid vaccine issues.

The major terms of reference found in the above named bill are as follows:-

61A Vaccine indemnities

- (1) The Finance Minister must not grant an indemnity on behalf of the Commonwealth to a manufacturer of a vaccine in relation to the use of the vaccine.
- (2) A corporate Commonwealth entity must not grant an indemnity to a manufacturer of a vaccine in relation to the use of the vaccine.

I am in support of these terms of reference for the following reasons:

1. <u>Time required for a proper research to be conducted was not followed</u>

All therapeutic products need to be well known and researched thoroughly before being introduced to humans for use. I quote the following from the New York State department of Health "The creation of a vaccine involves scientists and medical experts from around the world, and it usually requires 10 to 15 years of research before the vaccine is made available to the general public."
