nothing we can do and you are just grandparents . Yes I am a grandparent  
they are grandchildren of a Forgotten Australian so it ok to let them be abused.

I am forced to relive my whole childhood through seeing what has being  
happening to my Grandchildren. My daughter is a lost cause because I  
could not get the help that I needed to help and support her.

I have lost all contact with my granddaughter she is going on to 3 years old  
and she is a yo-yo child just like I was and being abused.

but is ok to make more Forgotten Australian because of abuse.

I was told the same thing on the day of the National Apology last year the  
same has happen with my quest for the abuse and harm caused by the  
Queensland police still nothing I was told the same once again at the  
the Apology incorrectly placed into mental institutions as children by Deputy  
Premier Paul Lucas i was given a card and told ring him I asked my wife to  
set this up for me to be told send a email.

I do NOT read properly nor can I WRITE let alone put a email address into a  
computer I DO NOT know how to use computer properly.

Redress

what a joke all it did was to bring out more traumatic memories to come out no help or support just live with it. never mind what happened to them as children, horrors that happened whilst in institutions or Foster care, never mind re traumatizing yourself and your family .When speak with Paul Lucas I told him what I felt of the dollar vale-you that QLD government put on us as children for child prostitution. I was lucky enough to have being given enough to buy the tow truck I now have and still trying to get my own business off the ground. They way people where treated was wrong the so called panel of experts would not have a clue what we went through as children how can some one that has not lived like we had to say who was more harmed. my paper work was lost and if it was not for Allan Allaway I would never got my few dollars. There where many people mistreated badly and made feel dirty. With this Inquiry I hope you do not put people through so much pain we have had enough of being abused. with what is all ready take from the people in Queensland redress use that information of impact statements . Make sure there are heaps of councilors ready . have support people to come to the homes. Forgotten Australians Family's suffer too .

I feel the gold Card should be given to all of us we have bad health problems our Wives/husbands partners / children all suffer stress problems because of our abuse as children.

we need in home caseworkers so they can see the need for support in the places it is needed. we need help to work with Centerlink housing many of us do not read or right nor understand many of what is so called law we do not need to have our children to keep being stolen and abused.

I can not even get a support letter for Centerlink to show why I do some things like sitting still for too long or being in small rooms why I do not take medican .

I could not even get help in do this submission and the things
