

Australian Government response to the Senate Legal and Constitutional Affairs Committee report:

Migration Amendment (Prohibiting Items in Immigration Detention Facilities) Bill 2020

Recommendations

Committee Recommendations

Recommendation 1:

2.74 The committee recommends that the government make administrative arrangements that ensure detainees have access to communication facilities that will reasonably meet their needs, and enable timely, and where appropriate, private contact with friends, family, and legal services.

Response:

Recommendation 2:

2.75 The committee recommends that the Senate pass the bill.

Labor Party Senators' Dissenting Report

The ALP dissenting report recommended that the Bill not be passed unless the below recommendations were agreed to.

Recommendation 1:

Labor Senators recommend that the Government either withdraw the bill, or significantly amend the Bill to address these concerns and ensure that the bill is focused on the specific risks and does not impose broad sweeping measures that punish detainees who themselves may be at risk from other, high risk detainees.

Recommendation 2:
Labor Party Senators recommend that the bill be amended to define 'prohibited thing' more clearly and that it be defined in legislation to enable appropriate parliamentary oversight.
