

## Proposed Marine Parks

Dear Members of the Senate Committee.

I wish to put in an objection against the proposed Marine Parks for South Australian waters.

My reasons being:

For hobby fisher people like us who have invested in a shack, boat, tractor (to get the boat to the water) so we can have our holidays here in South Australia (keeping money in the country). We enjoy having family and friends spend time with us and taking them fishing. There is nothing like having a fresh feed of fish for dinner.

If the Marine Parks go ahead I see the following happening:

1. It will become dangerous for novice fisher people to go out so far just to catch a feed of fish. Who will take responsibility for rescues at sea or even deaths because of weather changes and being out so far. Will the Government put more money into the Sea Rescue Operations to cover these rescues?
2. What will happen to all the seaside towns if Marine Parks go ahead? The way I see it businesses will go under, as there will be no tourists coming when you have made it so hard and affordable for these people to enjoy a fishing holiday. There will be no services for the shackies, locals and tourists. So that will be the end of all small seaside towns.
