There is no specific Price Guideline item recommended for purchasing Sexual Activity Supports. We are working with internal stakeholders to ensure NCC staff are supported to provide accurate information in relation to sexual activity supports.

As there is no specific item for sexual supports, the question was asked to determine what specific line items the NDIA is recommending to be used?

The NDIA answer was provided on 14th July 2023. In subsequent calls to the National Call Centre on 10th August 2023 and 27th September 2023 we discovered inaccurate information is still being shared.

There is no Price Guide line item aligned with the provision of Sexual Activity Supports. Therefore, it is not possible to provide data on the number of Sexual Activity Support providers. Following the WRMF decision the National Disability Insurance Agency (NDIA) has updated their policy and operational settings.

Touching Base Note:

The question did not ask for data about the number of Sexual Activity Supports providers but was specifically asking what work has been done on developing a policy regarding sex services.

If the NDIA policy and operational settings have been updated following the WRMF decision, they have occurred without consultation, let alone co-design, with relevant stakeholders and do not appear to have been made available to National Call Centre staff.
