The building industry is screaming out for workers. I worked in the building industry for over 20 years, after a fairly significant time out of the industry I thought I would go back given that they are so desperate for workers (I don't need to work). Because of my age and that I've been out of the industry I did not get a look in. Agent said I had amazing experience, still did not get a look in.

When I was applying for jobs as I had for many years in the UK none of these discrimination factors EVER surfaced. In the UK I was always in work, always paid well equal to my experience - not my age, not my gender, my experience, always employed after having time off for travelling.

Overseas workers

The government need to establish a database of CV's of those seeking employment here in Australia. If companies apply for workers in that industry they should be referred to the list on the database and asked why they are not employing these people.

ABC

I was appalled with ABC reporting of older workers. On one hand saying that they are discriminated against and in the next breath ABC are discriminating and making the situation worse saying that older workers want flexible hours working from home! This may be true of those in retirement wanting additional work it is not true for over 50s wanting full time employment!!!!

Types of Unemployment

There has to be a distinction for different types of unemployment and the benefits they receive.

Those who don't want to work and will never work, generations of dole bludgers, these people should have no benefits as far as I'm concerned and at the very least whatever they are getting now should NOT be increased. There is plenty of work out there if people want to work.

Then there are those who have worked, who have contributed to society, have paid their taxes and are unable to get work

Why are people collecting benefits pandered to? Can't travel too far, can't be away from family, can't be away from friends, can't relocate to find work to take up employment.

This country would not be where it is today if people did not leave their country and move to Australia and people all over Australia sacrificed their lives to be employed for us to have the infrastructure and the buildings and everything else that we have in Australia today if it were not for people making sacrifices to enable them to work in ANY job.

Again, I do not need to work but I felt so sorry for the desperate farmers that I thought I will go and work on the farms and then I thought I am not going to if people are sitting on their backsides, doing nothing, can't put themselves out to go and get work, why the hell should I.

Unemployed people in Australia if they want to continue to get benefits they should be made to go and get a job on these farms at the very least. What happens is they get to the farm's they do such a bad jobs that p

farmers don't want them there and if this is the case then they should be taken off benefits.

People will not work on there because they have such high standards and high expectations completely unreasonable as to where they will live on the farms it's it is so appalling that people are so fussy in this country I would let them starve which they will soon enough because there will be no one in the country to pick the produce.

You allow foreign workers from the Pacific to come over and work, why is the pay and the living standards acceptable for these people but not people in Australia?

Why are we paying New Zealand security guard workers and police to come over and work in Australia in Aboriginal communities and towns with larger Aboriginal people and prisons paying for all expenses and huge wages all at the expense of taxpayers.
