Proof Transcript of Evidence, page 52:

Mr Ferrar: In most jurisdictions maximum bets are unlimited.

Senator XENOPHON: It would be helpful to me, and I hope to the committee, if you would provide, perhaps on notice, details of those jurisdictions where they are unlimited. That would be so you would have adequate time to provide that.

Typically, the maximum bet on gaming machines is not regulated. For example, attached is a list of 55 regulatory jurisdictions in the USA – 43 of which have no regulated limit.

The GTA has commissioned a World Count of Gaming Machines survey regularly since 1999, in order to estimate the number of gaming machines legitimately operating worldwide at that time. The most recent survey was completed in February 2012 and includes a summary of available maximum bet information¹.

It is noteworthy that, in addition to a \$2.50 maximum bet in New Zealand's clubs and hotels, an unlimited maximum bet applies to gaming machines operating in casinos.

It is also noteworthy that in July 2011, 'Category A' games were defined in the United Kingdom with an unlimited maximum bet (in addition to 11 other categories whose maximum bet ranges from 10p to £100). At March 2011, the UK had 157,070 gaming machines of which 31,484 had a £100 maximum bet (known as Category B2 games).²
