Senator DUNIAM: Thank you, Mr Schofield, for those remarks and answers to the chair's questions. I go back to the points you were making around Australia continuing to be a leader in the Antarctic science space and all of the other functions it has. I accept the points you make there. One of the answers you provided to Senator Whish-Wilson was that no other treaty partner or member has made a point to the Commonwealth of Australia about any concerns around perceived or other reductions in funding or support for Antarctic science. That's correct, isn't it?

Mr Schofield: As far as I'm aware, that's correct.

Senator DUNIAM: Can you check, on notice, that that is correct?

Mr Schofield: We can certainly check that.

#### Question

Senator DUNIAM: DFAT is the outward facing entity. On behalf of the Australian government it is interacting with foreign nations and their governments, getting an understanding of what is happening. You just said yourself then that, in preparation for CAMLR meetings, that's a great way to understand what other nations are actually doing. Can you give me any analysis of what other nations are doing in Antarctica, on the back of what you've just said.

Mr Schofield: If you would like a more detailed response, we'd be happy to take that on notice and come back to you with some points as far as that goes. One thing I would say is that, late last year, the Assistant Minister for Foreign Affairs attended a polar summit in France. That was an opportunity to engage with other countries in relation to not only the Antarctic but also the Arctic, given it was a polar summit, and to discuss some of the issues they were focused on. It won't be any surprise to you that climate change is a key issue being considered at the moment. You will have noticed that, in our submission, we have made reference to what's known as the Helsinki Declaration on Climate Change and the Antarctic. That was an important outcome of the most recent Antarctic Treaty Consultative Meeting.

Senator DUNIAM: I appreciate that, and I would appreciate any detail you can provide on notice because that level of information is important when making a claim that Australia remains a leader in the Antarctic space.

#### Question

Senator DUNIAM: In addition to the question I placed on notice earlier, on details around specific activities: particularly with regard to those two countries, I'd be interested in what information we have. It would be helpful for us because a lot of the respected individuals we've been able to interact with as part of this process have pointed in particular to their activities; I think you alluded to it yourself. I agree with the point you make around the need to uphold the rules based order and the key principles, themes and aims of the Antarctic Treaty system; I think that's an admirable pursuit. But there are those who don't necessarily seek to play by the same rules. Did either the Prime Minister or the foreign minister raise with the People's Republic of China and their representatives any concerns around Antarctic activity in their visits or meetings with those officials?

Mr Schofield: Thank you for that question. I'd have to take that on notice. I'm not aware of whether or not that issue was discussed.

#### **Answer**

The Australian Government engages with all States Parties to maintain and strengthen the Antarctic Treaty system, particularly its rules and norms of freedom of scientific investigation, international cooperation, environmental protection and non-militarisation.

The Foreign Minister has emphasised the obligation of all States to adhere to international law and norms in her meetings with Chinese counterparts.

The Department of Foreign Affairs and Trade does not provide details of the Prime Minister's discussions with foreign leaders.

Following on from that, could I ask what input DFAT provided, as the lead coordinator with regard to Antarctic policy on a whole-of-government level, relating to Antarctic matters for the Defence strategic review; if none, why none was deemed appropriate to provide; and, if it was provided, why it then wasn't included in the review? Please take those questions on notice.
