## Senate Finance and Public Administration Committee

I am writing to you of my concerns on how the native vegetation laws and legislated greenhouse gas abatement measures will affect the landholders of Australia.

I do not work the land but have many friends who do and the hours they work each and every day to try to make a living is amazing. there is no doubt that these farming families are on the land because they truly care and want to provide food etc for the country.

These people are the true land owner and land holder and they need as much support and respect as given to any other worker. These new measures undermine the fact that they own the land freehold, with all the "fee simple" land rights.

These changes will impact greatly on the earning capacity of these farmers, with prices down and farmers unable to expand production due to the inability to develop their land, will only further limit their earnings. This will further add to the hardships such as flood, drought, market prices, that the landowner has to deal with on a day to day basis.

These restrictions and regulations will cause many problems to these families, leading to arguments, fights, health problems and not to mention suicide. No wonder the suicide rate is so high among the farming communities.. Long working hours,, regardless of the weather, or the time factor combined with the ever increasing paper work, courses etc that the government imposes onto the farmer with no regard to his or her commitments are a constant battle. The government changes the rules and each times takes more away from the farmer, whilst adding more restrictions.

To live solely off the land is difficult and many farmers need to find work off their farms to make ends meet only adding to their difficulties and yet these people continue to try to keep maintaining their dream or their promises to long gone family to keep working the land that they have inherited.

Farmers have to respect the land, it is their livelihood, their income, their life, and they should be given back their rights to work or clear their land as they need whether in time of fire threat or just to farm, the farmer should be able to do so when he / she deems necessary.
