



## ECB MEDIA ACCREDITATION 2009 - Terms & Conditions -

### General:

ECB Terms & Conditions relate to the 2009 ECB International Media, County Season and International Match Passes issued for npower Test Matches, NatWest Series and NatWest International Twenty20 matches ('International Matches'). The International Matches will be played in England during the 2009 season.

Accreditation will be subject to the applicant complying with the following Terms & Conditions. Failure to abide by such Terms & Conditions could result in the applicant or the employer's accreditation being revoked for the duration of the International Matches.

### Key Obligations:

The applicant will:

- Abide by and comply with any terms of entry into the grounds as prescribed from time to time by the ECB or the ground authority, to the extent those terms of entry do not directly and materially conflict with the rights attaching to the accreditation.
- Abide by all reasonable directions of the ECB whilst in the grounds, including, but not limited to, places and times of access to the grounds.
- At all times whilst in the grounds:-
  - wear such identifying pass and/or bib or armband as may be provided by the ECB. Such pass and/or bib or armband must be visible at all times; and
  - not tamper with any of such items or do anything to obscure any part of them.

### Indemnity:

- The applicant and the employer (if any) jointly and severally hereby indemnify and hold harmless the ECB against any loss (including consequential loss) or damage to the ECB or their employees, officers and agents resulting from a breach of these Terms & Conditions by the applicant or the employer or resulting from the revocation of accreditation by the ECB.

**Accreditation not Transferable:**

- The applicant and the employer (if any) acknowledge that any accreditation granted in respect of the applicant is personal to the applicant and may not be transferred or assigned to any other person.

**Grant of Request:**

- The ECB may grant or reject the request for accreditation in its absolute discretion and after imposing such further terms and conditions as it sees fit. Once granted, the ECB may revoke accreditation at any time in its absolute discretion without being liable to compensate the applicant, the employer or any other person.
- The ECB or its representative may ask an accredited member of the media to substantiate the work being undertaken at the International Matches by requesting evidence of their work. If requested, this evidence must be provided as soon as is practicable and no later than 24 hours after the initial request. Should this material not be provided, the ECB may withdraw this accreditation.

**Conduct:**

- The applicant agrees to conduct his/herself in a way that will not bring the International Matches and/or the game of cricket into disrepute. The applicant agrees not to interfere with other media or spectators.

**Anti-corruption:**

- The applicant acknowledges that the International Cricket Council, of which the ECB is a member, has policies and procedures in place to eradicate conduct of a corrupt nature that is prejudicial to the interests of the game of cricket. By accepting ECB accreditation, the applicant agrees that any information he/she receives on the basis of this media accreditation shall be for the sole purpose of media reporting. The information obtained through accredited media status shall not be used or disclosed by the applicant for the purposes of obtaining financial gain, directly or indirectly, from gambling, betting, gaming or any other form of financial speculation.
