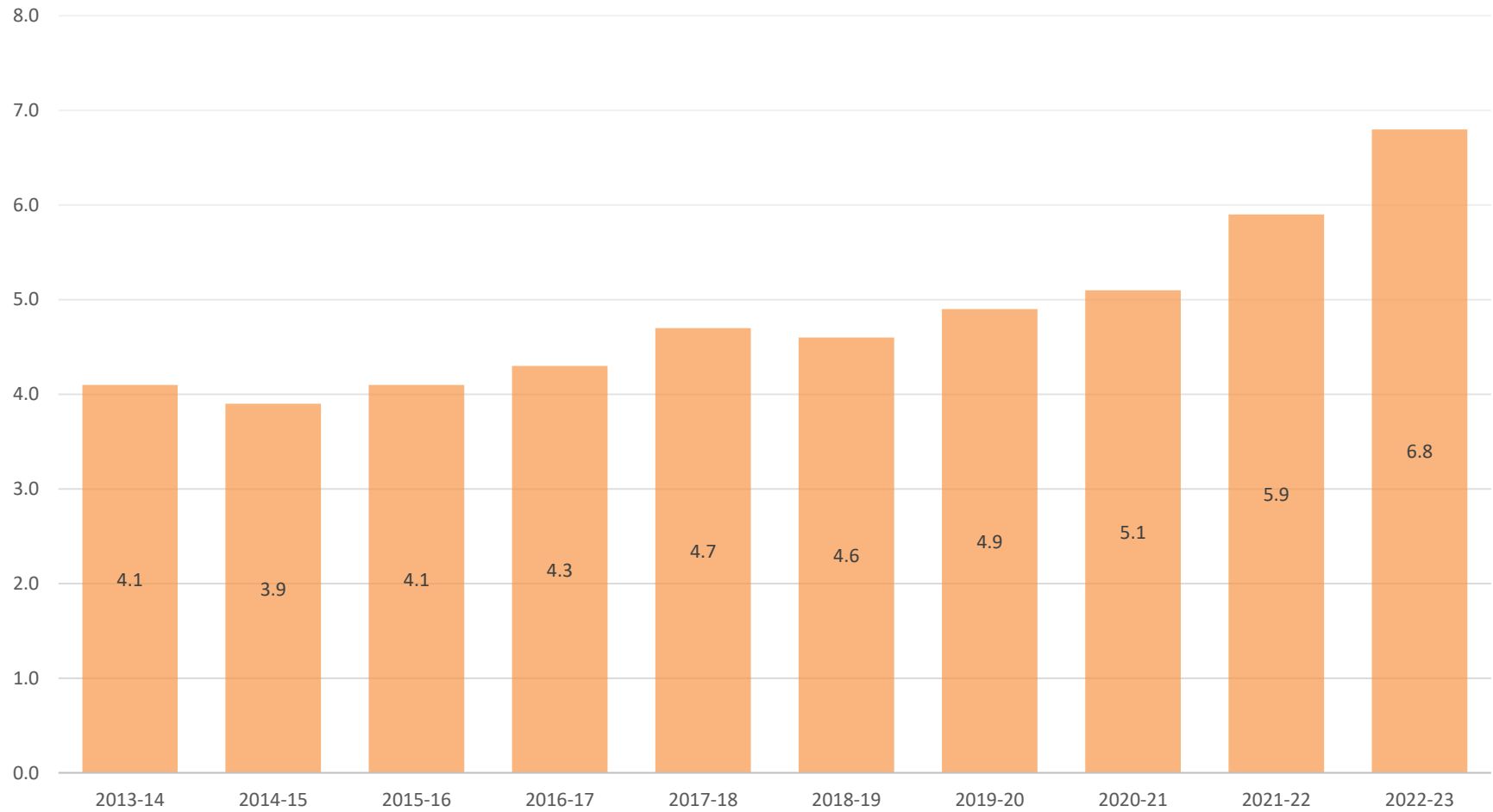


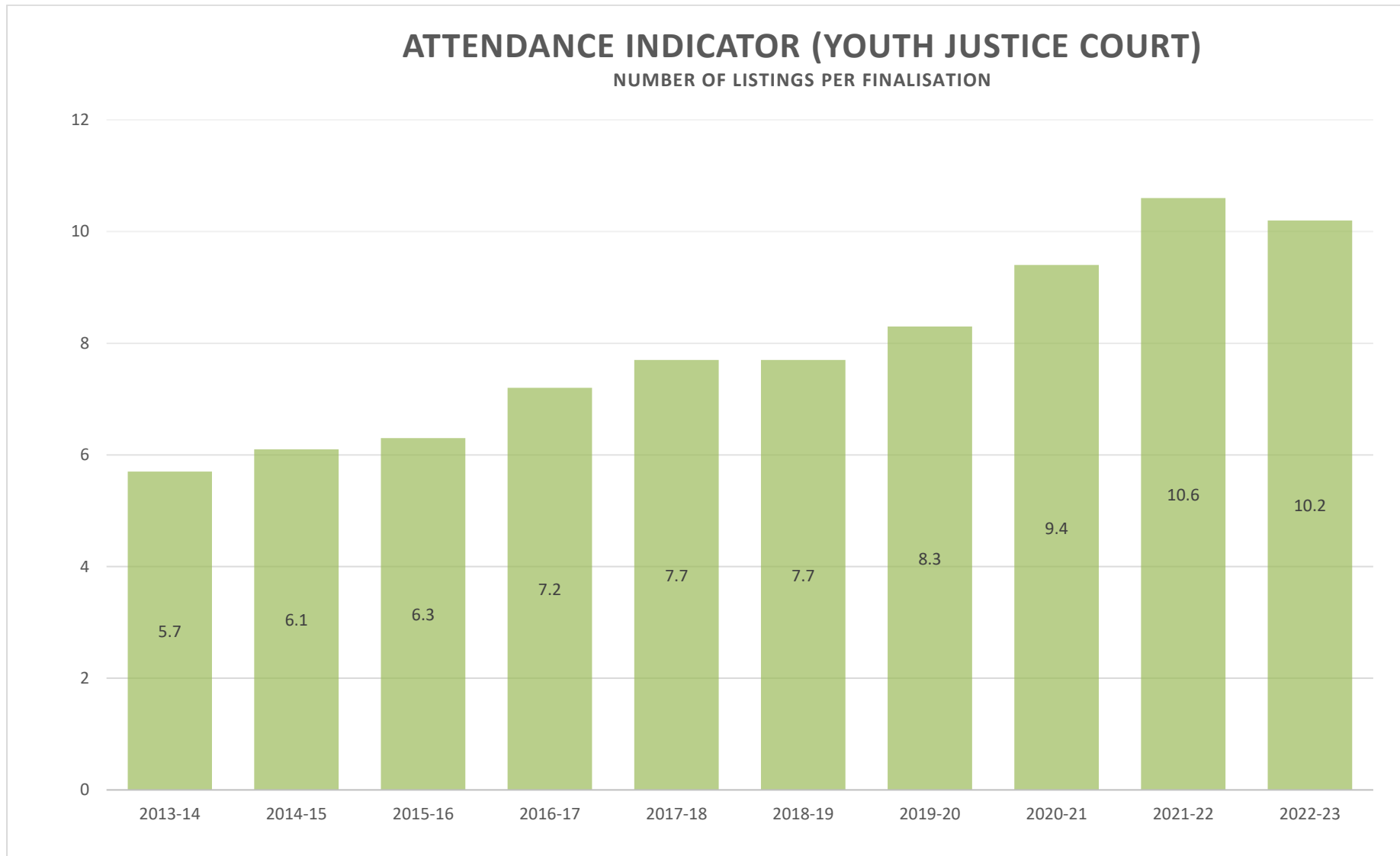




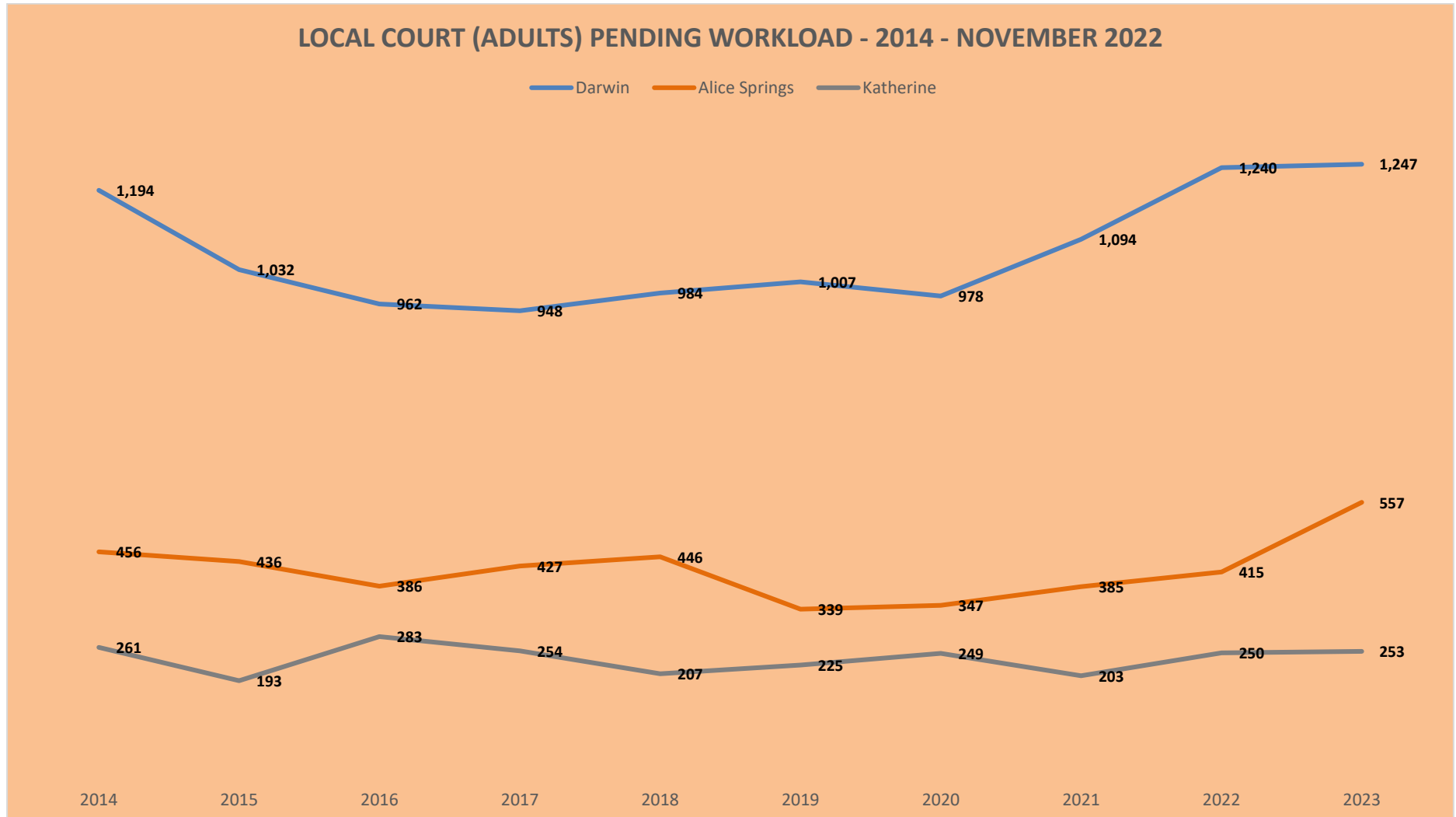
## ATTENDANCE INDICATOR (LOCAL COURT)

NUMBER OF LISTINGS PER FINALISATION



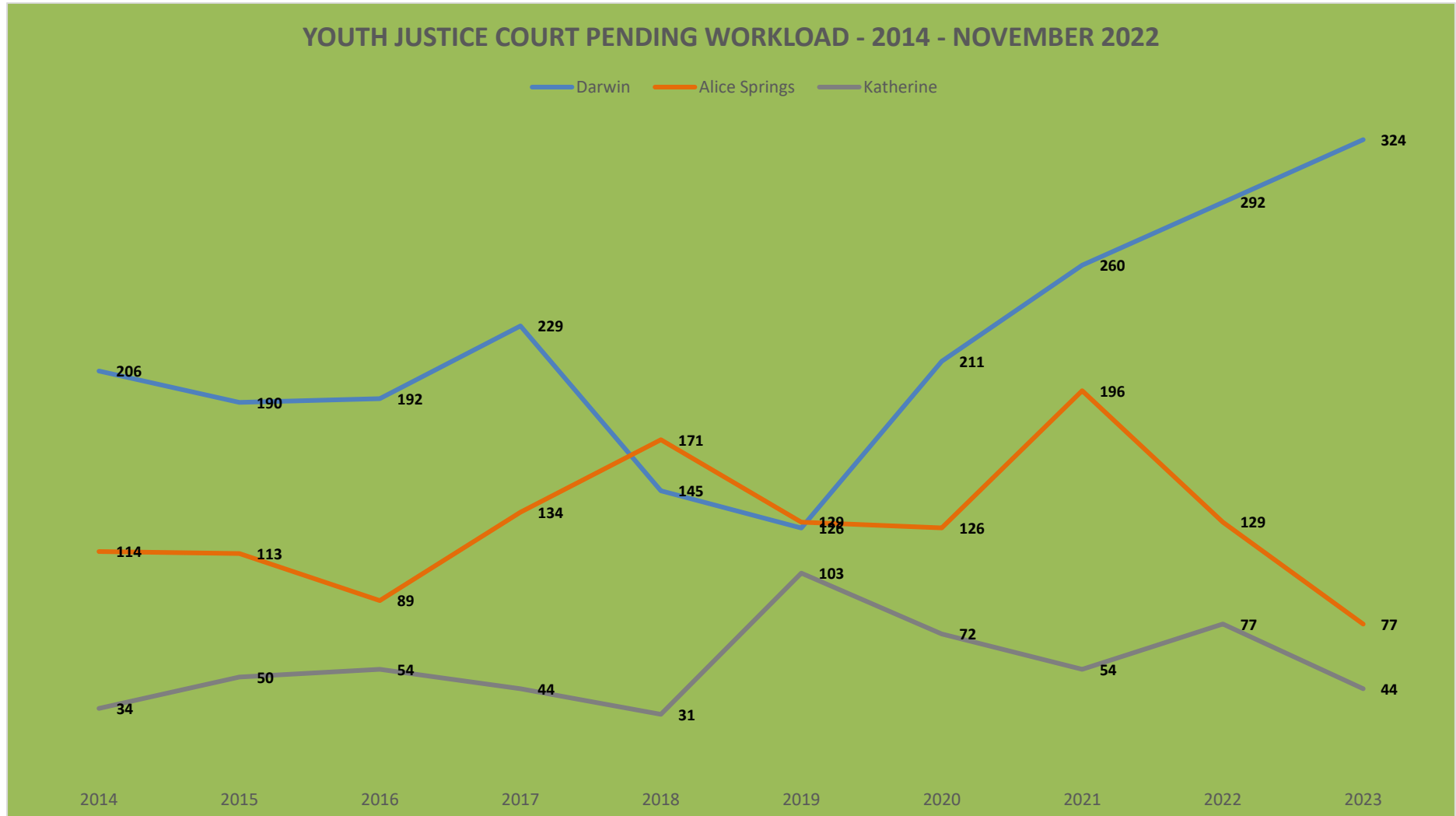




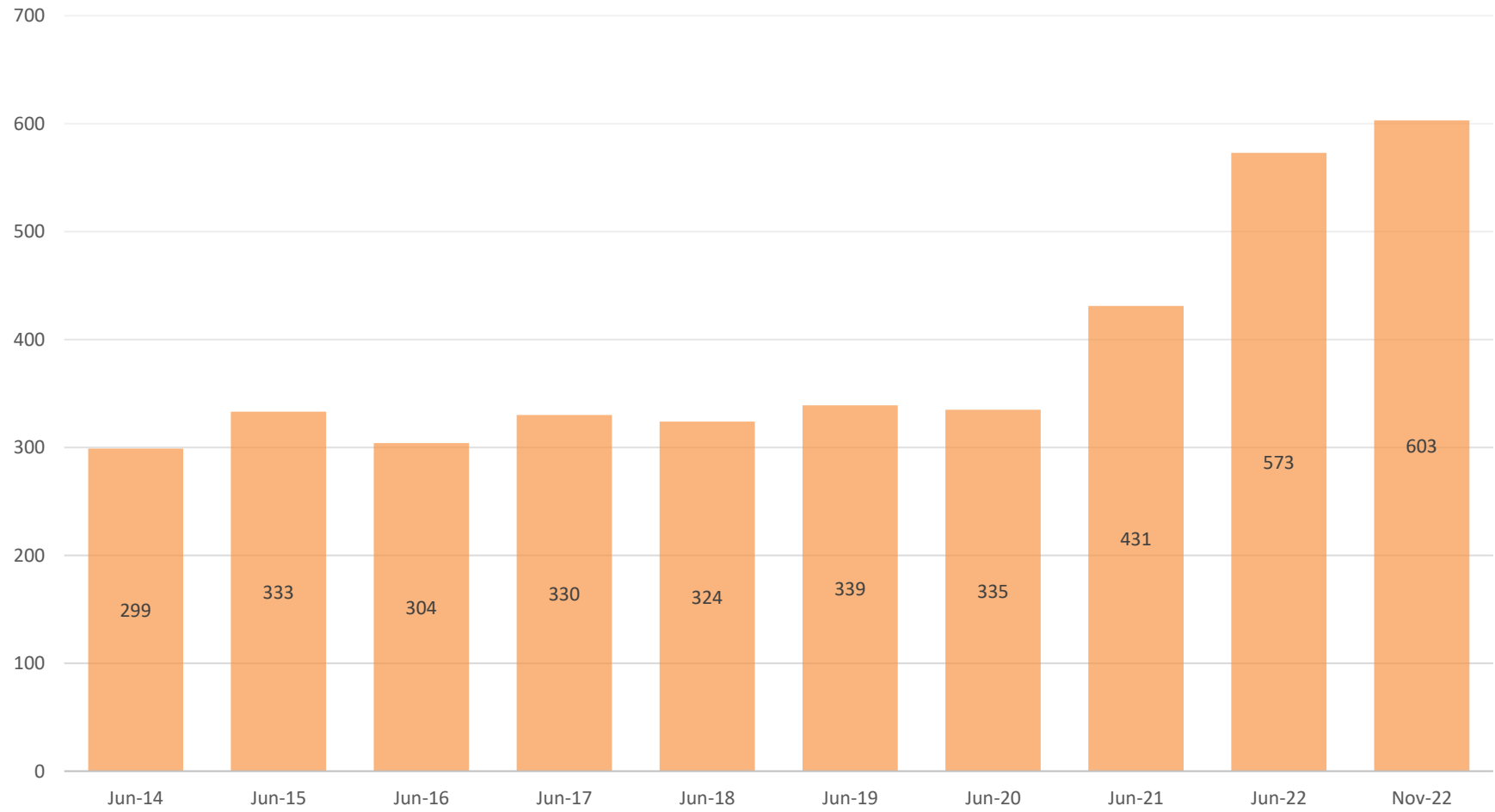


### YOUTH JUSTICE COURT PENDING WORKLOAD - 2014 - NOVEMBER 2022

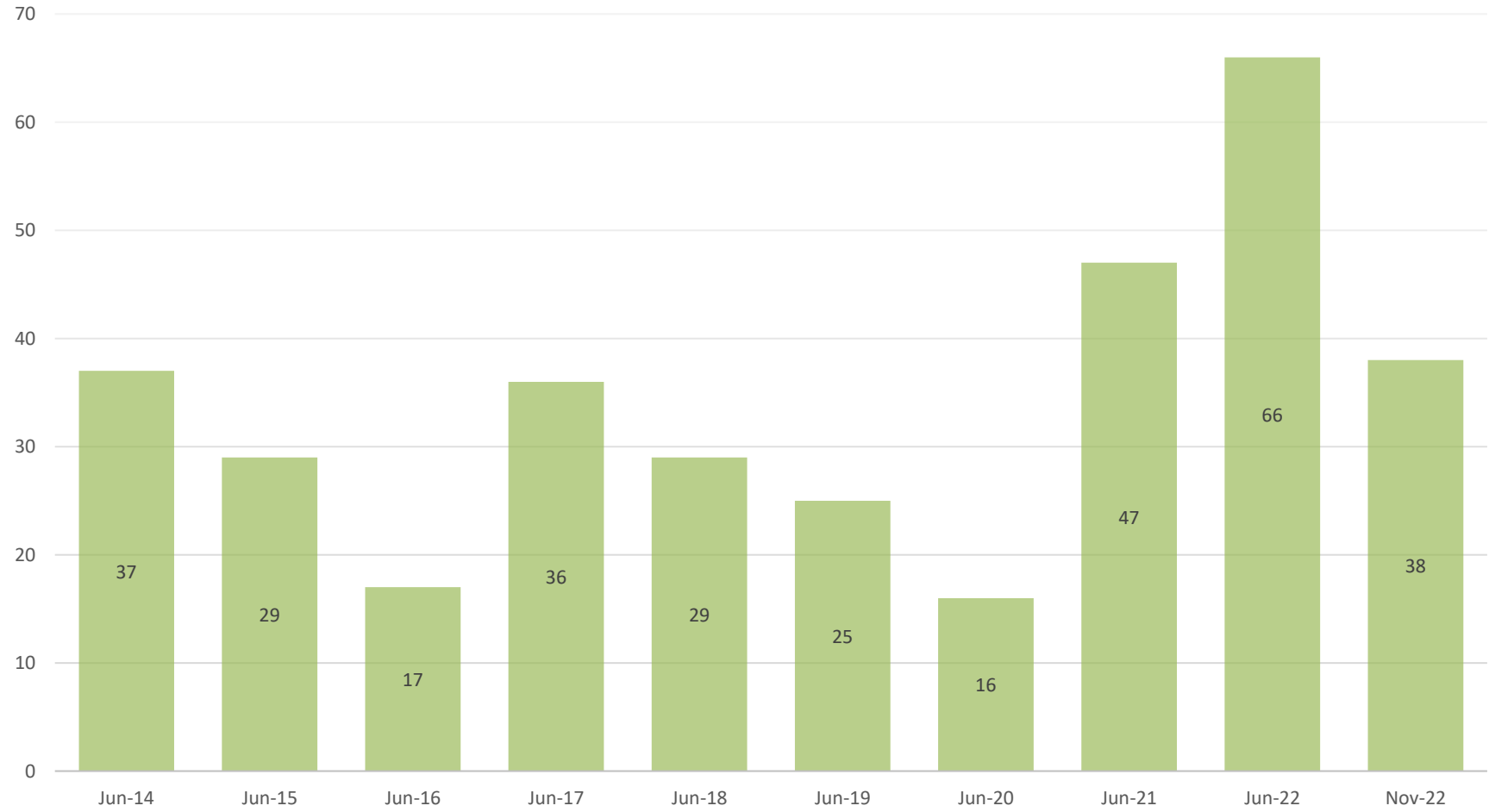

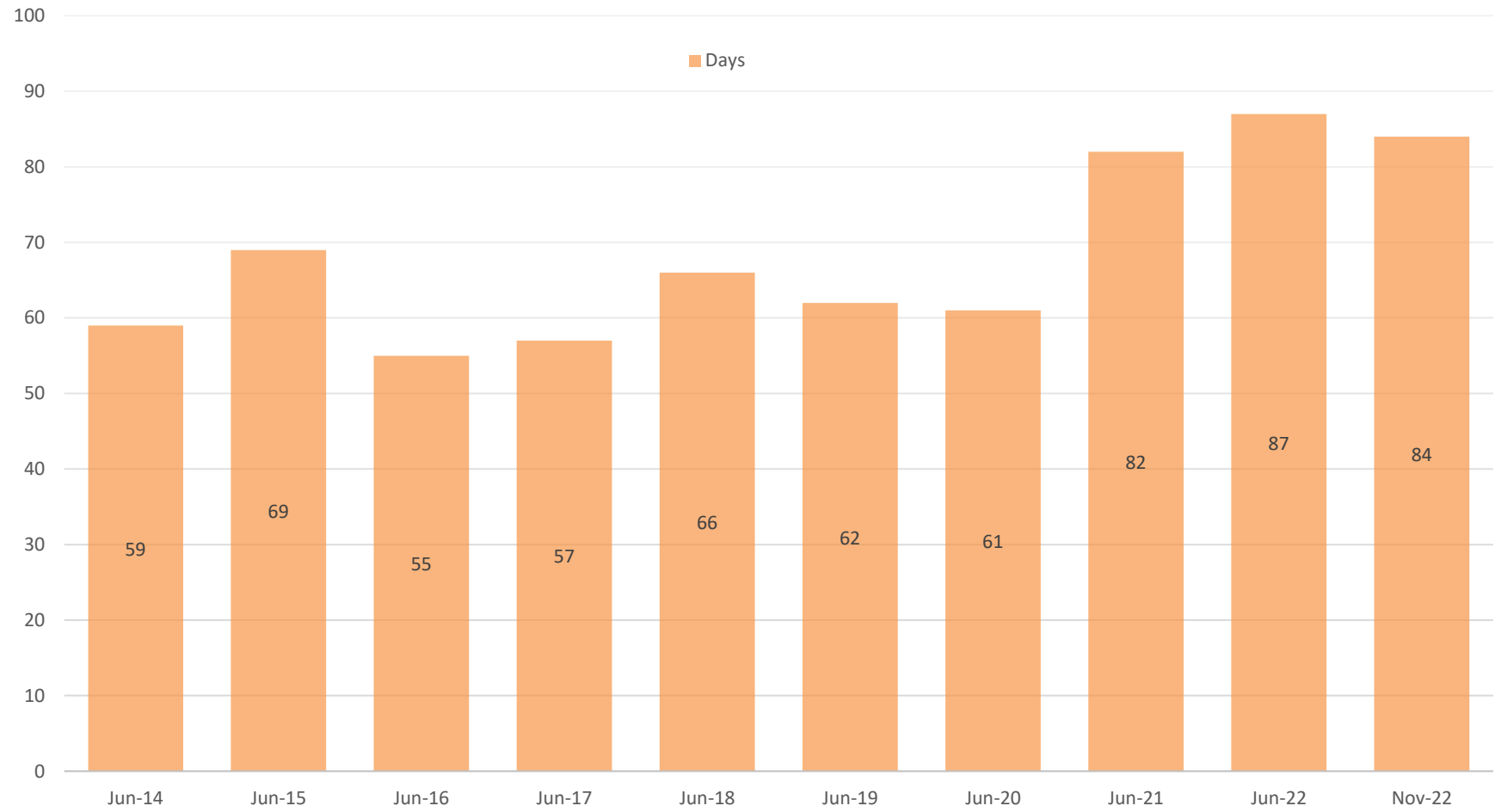
## PRISONERS ON LOCAL COURT REMAND AT 30 JUNE

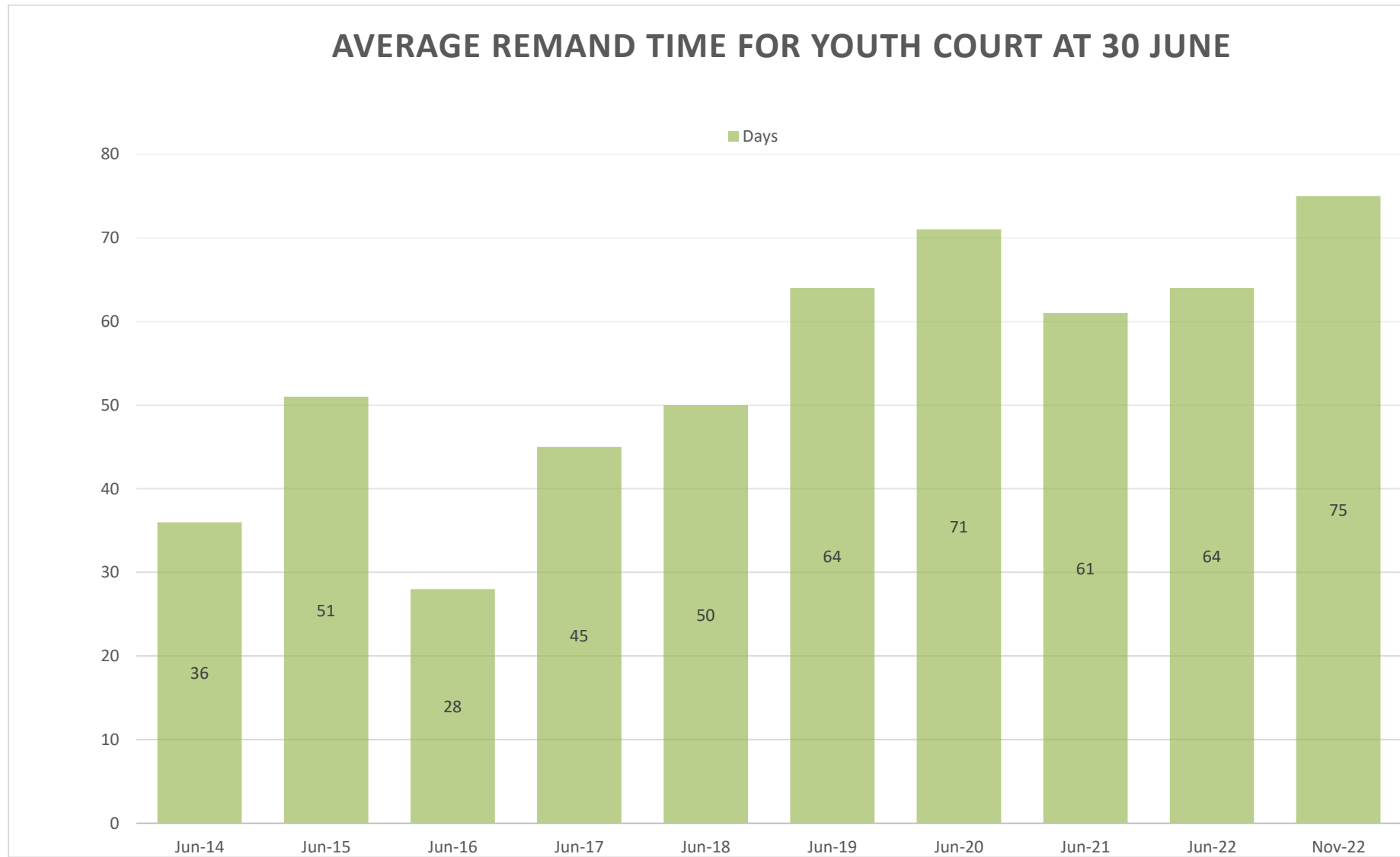


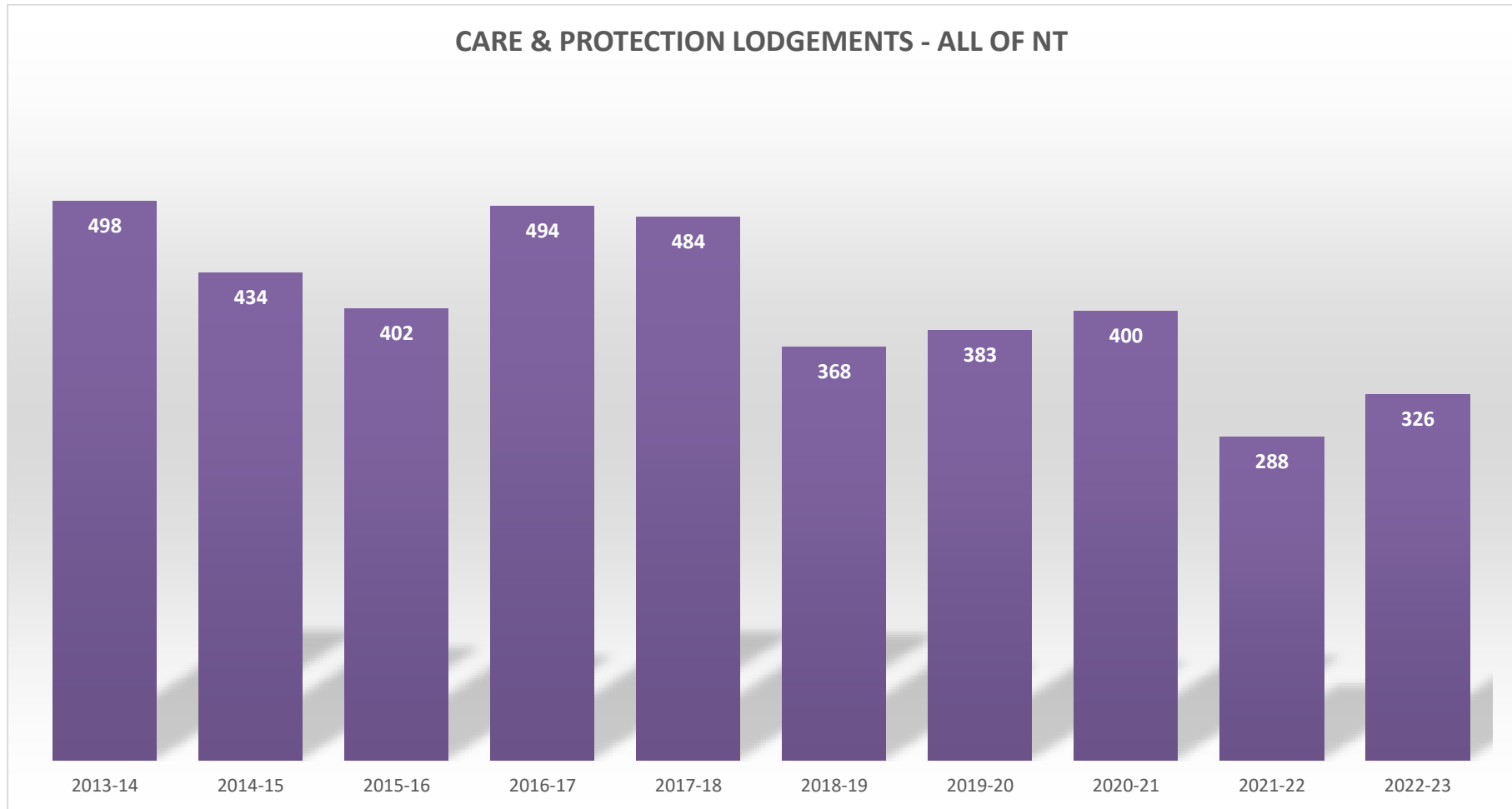
## DETAINEES ON YOUTH COURT REMAND AT 30 JUNE



## AVERAGE REMAND TIME FOR LOCAL COURT AT 30 JUNE

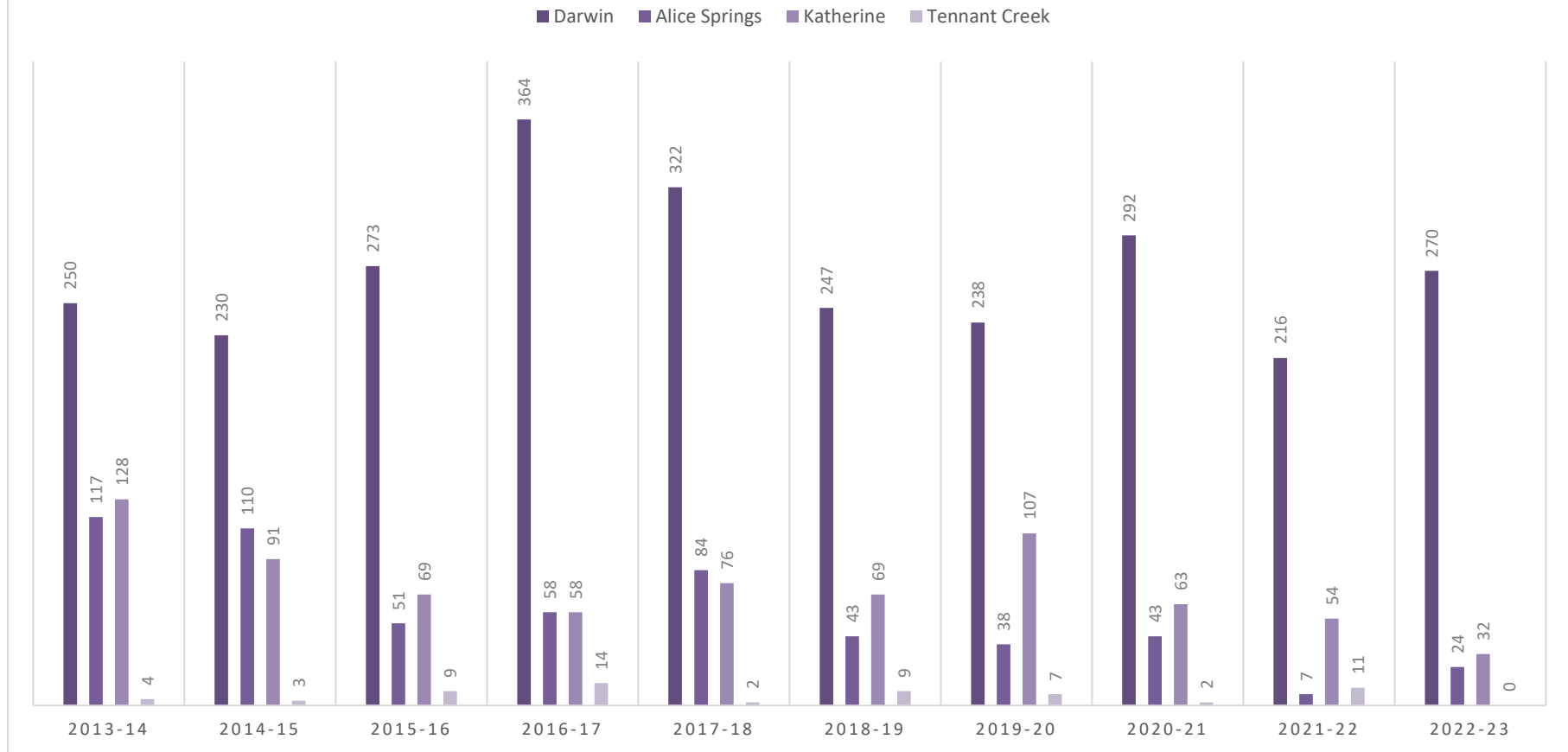






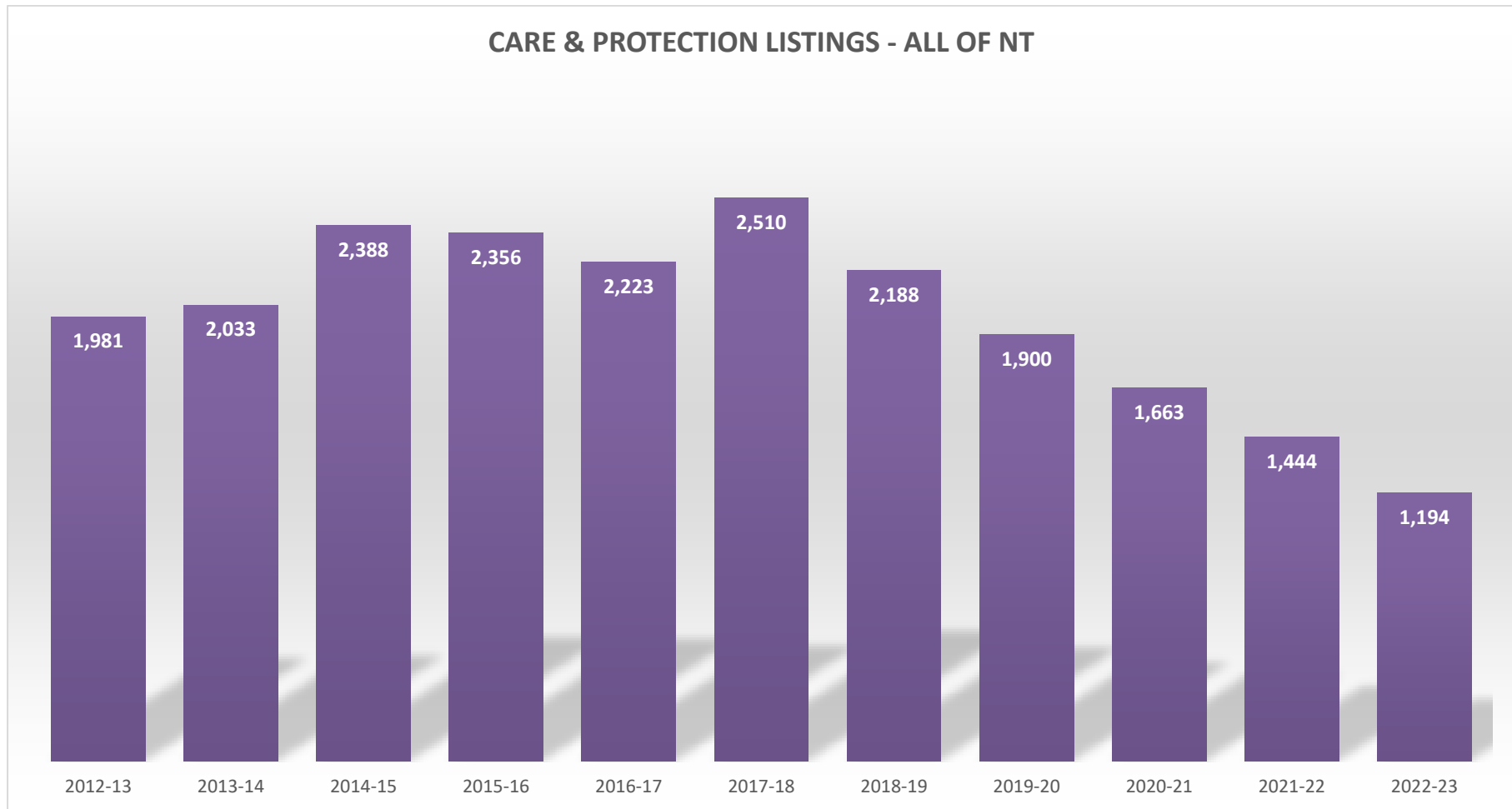

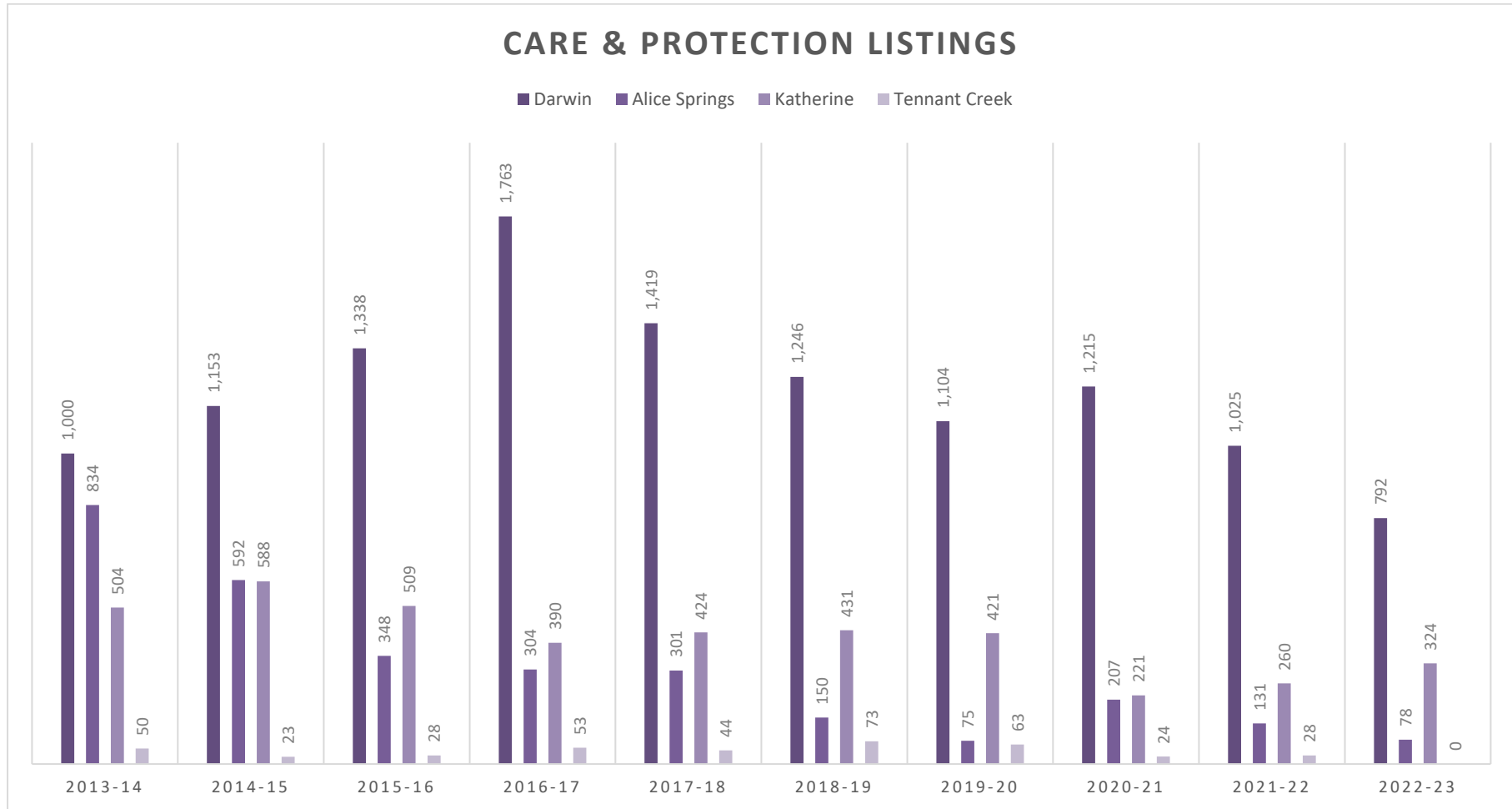
