#### **Question:**

How many people on temporary visas have been granted Special Benefit in relation to hardship associated with the coronavirus crisis?

#### **Answer:**

As at 24 April 2020, there were 1,209 temporary visa holders receiving Special Benefit who commenced payment between 1 March 2020 and 24 April 2020.

This includes all temporary visa holders, noting that there is no specific category of Special Benefit related to the Coronavirus.
