Subject: JSCOT public hearing 1 April 2019

I refer to the public hearing of the Joint Standing Committee on Treaties on 1 April 2019, at which this Department answered questions in relation to:

- *Agreement between the Government of Australia and the Government of the Kingdom of Thailand relating to Air Services;*
- *Agreement between the Government of Australia and the Government of the Democratic Republic of Timor-Leste relating to Air Services; and*
- *Agreement between the Government of Australia and the Government of Papua New Guinea relating to Air Services.*

During the hearing, Ms Susan Templeman MP, asked a question in relation to paragraph 4, Article 3 Grant of Rights, in the *Agreement between the Government of Australia and the Government of Papua New Guinea relating to Air Services*, which provides for:

4. If because of armed conflict, political disturbances or developments, or special and unusual circumstances, the designated airlines of one Party are unable to operate a service on their normal routes, the other Party shall use its best efforts to facilitate the continued operation of such service through appropriate temporary rearrangements of such routes as is mutually decided by the Parties.

Mr Josh Wilson MP sought further clarification in relation to the clause referred to by Ms Susan Templeman MP. I undertook to provide an answer in writing.

What was the reason behind including paragraph 4, Article 3 Grant of Rights, in the *Agreement between the Government of Australia and the Government of Papua New Guinea relating to Air Services*?

Answer:

The clause was included on request from the delegation of the Government of Papua New Guinea and was agreed by the Australian delegation as acceptable.
