ARIA AND AMRA RESPONSE TO THE INQUIRY INTO THE AUSTRALIAN FILM AND LITERATURE CLASSIFICATION SCHEME

We thank the Committee for providing the Australian Recording Industry Association (ARIA) and the Australian Music Retailers Association (AMRA) with the opportunity to provide evidence at the Committee hearing on 25 March 2011.

ARIA and AMRA do not require any corrections to be made to the Hansard transcript of evidence. However, as detailed in the Hansard, ARIA and AMRA would like to take the opportunity to submit a supplementary submission to the evidence provided at the Committee hearing to address certain issues and queries that ARIA and AMRA took on notice during the hearing. In particular, ARIA and AMRA wish to address the following:

- 1. Question from Senator Barnett relating to the relevance of the principles set out in the National Classification Scheme
- 2. Question from Senator Barnett relating to the sexualisation of lyrics
- 3. Question from Senator Barnett in response to the submission from Family Voice Australia
- 4. Question from Senator Crossin and Senator Barnett relating to international frameworks
- 5. Request from Senator Barnett relating to examples of each category of the labelling scheme
- 6. Request from Senator Barnett relating to the numbers of products in each category of the labelling scheme



Our response to these issues is detailed below:

Question from Senator Barnett relating to the relevance of the principles set out in the **National Classification Scheme**


Senator Barnett enquired of ARIA and AMRA as to whether either entity had "considered the principles that are set out in the code that are relevant to the implementation of the classification system in any comprehensive way...[and whether ARIA or AMRA] had any thoughts about that, as to whether you support them, or think they should be amended in some way".

The query was taken on notice.

At the Committee hearing, Mr. Harvey (Executive Director, Australian Music Retailers Association) noted to the Committee that "I think our view is that the classification scheme, at least to the extent that we are connected to it, works, and that the principles are sound'.

Both ARIA and AMRA are still of the same view and reiterate that the principles that underpin the ARIA/AMRA Recorded Music Labelling Code of Practice (the Code) are sound and we continue to support the application and effectiveness of the National Classification Scheme.

As submitted to the Committee in the joint ARIA and AMRA submission dated 14 March 2011, the Code is closely aligned to the National Classification Scheme, including the National Classification Code and Classification Guidelines. As the Committee can see from the table below (and as tabled to the Committee by Code Ombudsman Mrs. Una Lawrence during the hearing), the Code classifications are analogous to the National Classification Scheme:







In applying the Code, ARIA and AMRA members apply the similar principles that are linked to the community standards inherent in the National Classification Scheme

2. Question for Senator Barnett regarding the sexualisation of lyrics

Senator Barnett enquired of ARIA and AMRA as to whether ARIA or AMRA had reviewed the submission of Family Voice Australia. Senator Barnett enquired as to whether ARIA or AMRA "have expressed views about the use of lyrics and the sexualisation of music videos that seems to have increased rather than decreased over the last decade, based on the evidence of which I am aware"?

This question was taken on notice.

Neither ARIA nor AMRA are aware of the evidence that the Senator has referred to and as neither ARIA or AMRA are in receipt of any details as to what that evidence constitutes, we are unable to make a specific and reasoned comment in relation to the Senator's point.

Both ARIA and AMRA are aware of the discussion within the community on the subject of sexualisation in the media. There is no denying that music in all its forms is being included as part of that wider discussion. As to whether there is more or less sexuality over a given period we cannot conclusively provide a response. There does not appear to any empirical evidence that answers the question definitively. Any assessment is further complicated in that for every piece of independent research that suggests that sexualisation is an issue there is a contrary piece of research that says it is less of an issue than some elements within the community believe. For example:

are two studies that are likely to support the contention that the sexualisation of lyrics and music has increased. However, at the same time studies such as:

- Sousou SD. Effects of melody and lyrics on mood and memory. Percept Mot Skills. 1997; 85(1):31–40 and:
- Greenfield PM, Bruzzone L, Koyamatsu K,et al. What is rock music doing to the minds of our youth? A first experimental look at the effects of rock music lyrics and music videos J Early Adolesc. 1987;7(3):315–329

take a different view and in summary "refute concerns about the effect of lyrics, arguing that children and adolescents use music only for entertainment, that little or no attention is paid to the words, and if any attention is given, understanding tends to be limited and related to the experiences lived by the listener.¹"

Even after more than 10 years of examining the subject of the impact of lyrics on adolescents, the American Academy of Pediatrics (**AAP**) on one hand acknowledges that:

- Music plays an important role in the socialisation of children and adolescents
- Listening to popular music is considered by society to be a part of growing up
- Music provides entertainment and distraction from problems and serves as a way to relieve tension and boredom

- Adolescents use popular music to deal with loneliness and to take control of their emotional status or mood
- Music provides a background for romance and serves as the basis for establishing relationships in diverse settings. Adolescents use music in their process of identity formation
- Popular music provides adolescents with the means to resolve unconscious conflicts related to their particular developmental stage and that their music preference might reflect the level of turmoil of this stage²

Despite the extensive years of research the AAP still believes that further research is required in relation to the effects of popular music, lyrics and music videos on children and adolescents.³

Also amongst the AAP's recommendations was "the public, and parents in particular, should be aware of and use music industry's parental advisory warning of explicit content⁴".

The significance of this with respect to the Code is, in our view, the fact that the Code is inextricably linked to the National Classification Scheme. As we have stated elsewhere in this response, we believe our Code is unique in that respect. Our Code is structured so that any shifts in community attitudes via the National Classification Scheme will in turn be reflected in our own classification decisions under the Code.

The Australian music industry therefore is not the arbiter of what are or are not community values as it appears to be in the United States. For example, in the United States the Parental Advisory Label (**PAL**) Program does not at first instance appear to have any direct connection to other classification and censorship frameworks. As published on the Recording Industry Association of America (**RIAA**) website:

"The RIAA created and now administers the PAL Program. Individual record companies and artists decide which of their releases should receive a "PAL Notice" indicating that the release contains explicit content. Depending on a number of factors described in more detail in the Standards, a PAL Notice may take the form of the specific PAL Logo, or an additional indicator approved by the RIAA for such use⁵".

The Code's direct connection to the National Classification Scheme, through the Classification Board and its community consultation processes provides the framework on which the Australian recorded music industry and music retailers are obliged to make their classification decisions. As set out in the Code, the classification decisions made by our members therefore needs to reflect and currently do reflect:

- the standards of morality, decency and propriety generally accepted by reasonable adults; and
- the artistic or educational merit (if any) of the Product; and
- the general character of the Product, including whether it is of medical, legal or scientific character;
 and
- the persons or class of persons to or amongst whom it is published or is intended to be published.⁶

These principles which are set out in our Code are exactly as proscribed in Section 11 of the *Classification (Publications, Films and Computer Games) Act 1995.*⁷

Given the tied nature of the Code to the National Classification Scheme we are looking forward to seeing the outcomes of the Review of the National Classification Scheme currently being undertaken by the Australian Law Reform Commission⁸. We anticipate that the Code may be revised in light of the findings of that review once its recommendations are announced and enacted. We see this approach as being the most appropriate course of action in light of the issues raised by the Committee rather than any unilateral action as a direct response.

3. Question from Senator Barnett in response to the submission from Family Voice Australia

ARIA and AMRA also took on notice the request to provide a response to the submission made to the Committee by Family Voice Australia.

There is clearly a fundamental misunderstanding by Family Voice Australia as to the nature and extent of the Code. The Code, as approved by the Standing Committee of Attorney General (**SCAGS**) in 2002 and implemented from April 1st 2003, was very tightly drafted and designed to integrate with the National Classification Scheme. From the outset it was developed to dovetail with the classification criteria used by the then Office of Film and Literature Classification. That position has not changed since the implementation of the revised Code in 2003. However, it must be understood that the only remit of the Code is to classify the audio component of compact discs and other physical recorded formats. The Code does not relate to music videos.

To exemplify this, using a CD as an example, there are two key components that require classification:

- The audio recording (including the music embodied in the audio recording)
- The cover artwork/booklet (which may or may not contain lyrics)

The Audio Recording

The audio recording is classified under the Code. One of five possible classifications can be applied:

- No classification required: If the audio recording does not contain any coarse language and /or themes, then recorded audio product is not required to carry an advisory label. The vast majority of recorded audio products released each year do not require an advisory label.
- 2. The language or thematic material is of a Moderate nature: If the audio recording contains coarse language and thematic material that is of moderate impact, then it is classified using a Level 1 label. The classification of such recordings is carried out using the same criteria established by the National Classification Scheme for an M level film.
- 3. The language or thematic material is of a Strong nature: If the audio recording contains coarse language and thematic material that is of strong impact, then it is classified using a Level 2 label. The classification of such recordings is carried out using the criteria established by the National Classification Scheme for an MA level film.
- 4. The language or thematic material is considered to be suitable only for adults: If the audio recording contains high impact themes (including graphic description of drug use, violence, sexual activity), then it is classified using a Level 3 label which means that it is not to be sold to persons under the age of 18. The classification of such recordings is carried out using the criteria established by the National Classification Scheme for an R18+ level film. In this instance the same restrictions as apply to an R18+ film apply to our Level 3 classified products principally that it is not to be sold to minors.
- **5.** The recording is refused classification: if the audio recording contains lyrics which for example, gratuitously depict drug abuse; cruelty; suicide; criminal or sexual violence; child abuse; incest;

bestiality; or any other revolting or abhorrent activity in a way that causes outrage or extreme disgust to most adults, then these recordings would be refused classification and would not be permitted to be released and/or distributed by ARIA members or sold by AMRA members.

Cover Artwork / Booklet

Technically the cover artwork and booklet (including lyric sheets) fall outside the responsibility of the Code. For classification purposes cover artwork, lyric sheets and so on are considered <u>publications</u> and therefore any classification of this element of the product is undertaken by the Classification office within the Attorney General's Department. Practically the majority of the products released do not require any further classification other than what has already been applied to the audio component. However, if a distributor is concerned about the nature and content of the artwork or lyric sheet of the product they can either:

- Submit the cover artwork to the Classification Board for review and classification; or
- Modify the cover art by changing the artwork or removing the lyrics.

Music Videos

Music videos are not classified under the Code. Family Voice Australia has not recognised that any product carrying visual content, such as a DVD or enhanced CD is assessed and classified under the National Classification Scheme in accordance with the film classifications.

To reiterate, where a product includes both a separate audio (CD) and audio visual (DVD) product, referred to as a "dual pack", the product is classified by the Classification Board and as a result carries the appropriate G, PG, M, MA15+ or R18+ labelling. The National Classification Scheme takes precedence over the Code in these circumstances and only the National Classification Scheme label is applied.

Similarly, the broadcasting of music videos is also not within the remit of the Code. In this case the responsibility lies with the relevant broadcaster or their associated industry association such as FreeTV, Australian Subscription Television and Radio Association or the Australian Communications and Media Authority (ACMA) as appropriate.

In addition, it must be reiterated that radio broadcasts also fall outside the remit of the Code. In this case the responsible parties are the relevant broadcaster, Commercial Radio Australia, the Community Broadcasting Association of Australia or the ACMA as appropriate.

We suggest that with respect to the broadcast of music videos it would be more appropriate if the issues raised by Family Voice Australia are raised with the relevant industry or regulatory body.

Song Lyrics quoted by Family Voice Australia

Both the full sets of lyrics quoted in the Family Voice Australia submission come from a musical genre known as "Death Metal". The artists that were included within the Family Voice Australia submission, namely "Cannibal Corpse" and "Prostitute Disfigurement" are not considered mainstream artists and neither artist has ever entered the ARIA top 100 singles or albums chart in Australia. To give context to this in terms of the broadness of the appeal of these artists, it appears that the Prostitute Disfigurement track titled *Corpse Garden* has at 20 April 2011, had a total of 213 views globally on YouTube compared to more mainstream artists whose music videos are viewed by millions.

We understand why Family Voice Australia might choose these songs to exemplify their issues relating to the Code. However it must be noted that the nature of the material is at the very edges of music releases and are not representative of the vast majority of recorded music in Australia.

We must also note that the lyrics to the songs (that have been reproduced in the Family Voice Australia submission), if printed as part of the accompanying booklet, would be considered as a publication and thus may be subject to the review of the Classification Board.



However, the fact is that in relation to the particular Cannibal Corpse release cited by Family Voice Australia, this release may not categorically be refused classification under the Code. Each release must be reviewed and classified on the basis of the product supplied to the particular ARIA or AMRA member. In the instance cited, there was no cover artwork, the lyrics were not reproduced and the vocals are indecipherable. Based on the product that was supplied for classification it is difficult to find anything offensive in either of these acts if you are just listening to the recording or even watching them on YouTube. It is difficult to be offended when you have no idea of what is being said.

By extension these examples do not demonstrate a failure of the Code as asserted by Family Voice Australia. Similarly we cannot ban them as Senator McGauran suggested 9 on the basis that we "know what that group is up to"10. The Senator might be right, but it is procedurally unfair if we were to take the view that we should refuse classification for a particular release on the basis of the previous releases by an artist. Each release must be reviewed at face value and each Cannibal Corpse release (or in fact any release by an artist) would be reviewed and classified in accordance with the principles of the Code.

We dismiss the Family Voice Australia recommendation 13 with respect to the Code for two reasons.

Firstly, we believe the Code to be an appropriate response to the question of classification of audio products. We are of the view that it reflects the middle ground of public opinion or community values while acknowledging that there will always be dissenters at both ends of the spectrum - those that would say the system is too liberal and those who suggest it is not liberal enough. The Code provides a responsible and effective midpoint by implementing a system of graduated consumer advisory warnings to assist consumers with their purchases and to provide advice to parents when supervising the music purchases of their children.

Secondly, Family Voice Australia takes the view that audio recordings should be within the remit of the National Classification Scheme. Family Voice Australia is under the misapprehension that if the Code is absorbed within the remit of the National Classification Scheme that their concerns will dissipate. There is no evidence that the Classification Board would have classified these audio recordings differently.

We argue that the Code is already an extension of the National Classification Scheme. The Code and classification principles already mirror those of the National Classification Scheme as do the classification criteria. They cannot be precisely the same as the media is different but to the extent they can be - the two frameworks are aligned. The Code offers a balance between social responsibility and freedom of artistic expression.

As we have stated elsewhere in this response we await the outcomes of the Australian Law Reform Commission review into the National Classification Scheme with respect to the future directions of the Code.

Finally and importantly, there are significant practical considerations to consider if the Code was absorbed within the remit of the National Classification Scheme. In particular the volume of audio recordings in a variety of formats and packages would have a significant impact to the efficacy of the classification of audio recordings. According to the Director's Overview in the Classification Board Annual Report 2009-10, the Director of the Classification Board noted that in that reporting year, "the Board received 7,302 applications, including applications to classify 4,820 films, 1,101 computer games and 291 publications (228 single issue and 63 serial publications). These figures are generally consistent with the number of applications the Board has received over the previous two years"11. Based on these statistics it would appear that moving the responsibility of the classification of audio recordings from ARIA members and AMRA members to the Classification Board would increase the workload of the Classification Board and would require a commensurate increase in resource allocation.

In addition, classifying each audio product via the Classification Board would place undue time pressures on both ARIA and AMRA's members and may result in the local release of products falling behind release dates in other territories. Given the ease with which products can now be accessed internationally and the speed in which it can be delivered the resulting loss of sales would damage the local music and retail industries without effectively preventing local access.

4. Question from Senator Crossin and Senator Barnett regarding international networks

Senator Crossin enquired as to how some of the issues of classification have been addressed on an international level.

Anecdotally, international industry concerns on censorship and classification are far more focused on the use of censorship as a trade barrier in countries like China and in the Middle East than they are with providing advice and guidance to consumers. Matters relating to censorship and classification are not addressed on a global basis – but are addressed within a particular country's jurisdiction.

Comparable international markets and music retail industries such as the United States, Canada, New Zealand and the United Kingdom (**Comparable Territories**) each have their own voluntary consumer advisory system for recorded music – but none of these systems in our view provide the same level of consumer advice as the Code.

In these territories, a single warning label (or variation of the warning label) is used to advise consumers of the explicit content that is embodied on the audio product. Example of these advisory labels can be viewed at:

In comparison to the Comparable Territories, it appears that Australia is the only jurisdiction where a graduated series of warnings exists and where the classification of audio products is benchmarked directly against an overarching classification regime such as the National Classification Scheme. The consumer warnings outlined in the Code provide clear and detailed information to consumers regarding the specific nature of the content embodied on the audio product.

iTunes and other online providers use of the word "Explicit" on some products in accordance with the RIAA PAL Program that originates from the United States. The fact that Australia is a relatively small market does not encourage the large online international online retailers to adopt our Code for use on products sold from their overseas server to Australian consumers.

5. Question from Senator Barnett regarding examples of each category of the labelling scheme

Examples of each category of titles classified under the Code between 1 April 2009 and 31 March 2010 are annexed to this submission.

Question from Senator Barnett – Numbers of products in each category of the labelling scheme since 2003

The figures below consist of releases by EMI (Australia), Shock Records, Sony Music (Australia), Universal Music Australia, Warner Music Australia and Inertia.

Conclusion

Our view is that the Code represents the best possible outcome for all stakeholders. It does so through:

- Balancing the Code principles of morality and artistic merit
- The connection of the Code to the overarching classification and censorship regime being the National Classification Scheme
- The provision of graduated advice for consumers as to the content of the product
- The provision of an efficient process for the classifying of products that does not burden the Classification Board and at the same time allowing the industry to meet commercial objectives such as meeting global release dates
- A demonstrated low level of complaints which we believe indicates high level of compliance by ARIA and AMRA members and satisfaction of the Code by the community at large. ARIA and AMRA members take their obligations under the Code seriously and there is no evidence of systematic non-compliance, or failure in the operation or effectiveness of the Code over the past 8 years.

We thank the Committee once again for providing ARIA and AMRA with the opportunity to respond in detail to the questions that were raised as a result of our appearance before the Senate Committee on the 29 March 2011.
