Percentage of the aged care staff have completed foundation training

Question:

Senator SIEWERT: Can I go to the staff training issue. An answer to one of the questions taken on notice said that as of 9 September there were 173,554 aged-care professionals who had completed the foundation training. What percentage of the staff of the aged-care workforce is that?

Mr Lye: We could come back to you on that. It would be misleading to use that, because those modules that have been provided are over and above what training we would expect that staff had done in aged care. Some providers have not used that service, because they have their own standing arrangements. So putting that figure over the top of the estimate that we have of the number of staff in residential aged-care facilities would produce a dramatic underestimate of the number of people who were trained.

Answer:

The number of workers who completed the Department's eLearning modules, is not a measure of how many workers have attained IPC competency. Commonwealth law requires approved providers of aged care homes to meet the Aged Care Quality Standards (Quality Standards) to ensure quality care and services are provided to all care recipients. These e-learning modules are over and above what is already required.

Under the Quality Standards, providers are required to demonstrate their workforce is recruited, trained, equipped and supported to deliver the outcomes required by the Quality Standards. Providers may satisfy this requirement by mandating its staff complete the online e-learning program, or by an equivalent mode of study. There are a number of alternatives available, and used by providers, to attain these skills.

As at 9 October 2020, **1,494,713** aged care eLearning modules had been completed. Over **1,262,988** people have completed the COVID-19 foundation course on infection prevention and control (IPC). **184,842** people who completed the additional COVID-19 foundation course identified as an aged care worker.

Question:

Dr Hartland: Let me finish off the point that I was making. It hasn't moved places from the future into the present in the sense of not having them in the future. It has created more places in the current—

Senator WATT: Not 50,000 though.

Dr Hartland: I'll have to see if we can get a reconciliation of that for you, Senator. I don't think I have the material in front of me to show how the places have rolled out.

Senator WATT: Again, documents provided to the royal commission tell us that as of the 2018-19 budget there would be 162,514 home-care places by 2024. It is not the case that there will be 50,000 more cases on top of that by 2024, is it?

Dr Hartland: I've never told you that. I don't think anyone has ever said that.

Senator WATT: You haven't but ministers, including the Prime Minister, have repeatedly said that there are an additional 50,000 places. If that were true then there would be 212,504 places in 2024.

Dr Hartland: I don't think you are characterising the Prime Minister or the minister's statements correctly.

Senator WATT: I will give you an exact quote from the Prime Minister from 8 July 2020: 'Today I'm announcing an additional 6,100 in-home aged-care places, which will bring an additional 50,000 places at a cost

of some \$3 billion, which we have announced since the 2018-19 budget.' On 26 of August this year the minister said, 'What we've been able to do is invest \$3 billion since the 2018-18 budget to provide an additional 50,000 home-care packages.' They're direct quotes from ministers.

Dr Hartland: There is nothing incorrect about those quotes—

Senator WATT: Except that there aren't 50,000 additional packages.

Dr Hartland: That is not right. I am sorry.

Senator WATT: Perhaps you can come back on notice and demonstrate to me where these 50,000 additional places are, because the documents you provided to the royal commission, and that you answered questions on at the royal commission, show that there is nowhere near a 50,000 increase in the number of home-care places.

Dr Hartland: I've explained the difference to you, Senator. I can go over it again if the committee has time, but it might be helpful if we see if we can provide a different way of picturing it for you.

Senator WATT: I probably cannot take this any further, Chair.

CHAIR: Thank you, Senator Watt. Dr Hartland, you've taken that on notice. I will go to Senator Siewert.

Answer:

Since the Hearing on 29 September 2020, a further 33,000 Home Care Packages (HCPs) have been announced as part of the 2020-21 Budget and 2020-21 Mid-Year Economic and Fiscal Outlook. This brings the total figure of additional HCPs to 83,105 since the 2018-19 Budget (Table 1).

Table 2 below shows the details of the HCPs announced since the 2018-19 Budget. Figures bolded indicate when the additional HCPs have been counted towards the 83,105 figure, with notes at the bottom of the table verifying where only parts of the bolded figures have been counted. As Table 2 shows, many of the announcements have had impacts beyond one financial year. The bottom parts of the table reflect the impact of the announcements and clearly show that the announcements have had a positive impact on HCP volumes in each year from 2018-19 onwards. This impact extends beyond 2023-24.
