The government N.S.W. decided to rezone my Property - Nature Conservation as a Public state forest effectively sterilising it from production, with no just and adequate compensation payment.

It is hard for people not directly involved this to imagine the pain me and my family have gone through since 1990, it is little wonder there has been 550 suicides since 1980. My Property was not simply the site for a house, my farm land was the means of production, which has now been denied to me.

If governments take away a farmers ability to actively manage their land and take away their ability to manage their business, their physical, emotional and financial security is destroyed, governments must be made pay just terms compensation. Property rights are the foundation of society and it is impossible for citizens to enjoy the security offered by a Commonwealth in the absence of law protecting individual Property.

I have lost my Property without any Payment of just and adequate Compensation. My three Daughters have lost their inheritance. As well as the Property loss, I have lost 20 years of Income from the sale of Produce of wool, wheat, Cattle and the Sale Luccern hay. I have had the forced sale of stock being 400 head Cattle 2500 - Sheep - which were shot and buried in a Pit by the Bingara Shire on instruction of Shire Clerk Paul Henry. I had the loss of the sale of 40 head horses Australian Stock horses, being sacrificed sales. After 38 years of my developing my Property Building a new home, 25 miles fencing, sinking 18 dams, contouring 500 acres cultivation building Machinery shed 130 feet by 30 feet. Shearing shed and yards together with Cattle yards further Damages to me and my family was the loss of 1000 acres of wheat share farming agreement at Biniguy, N.S.W. which had five years to expire estimated valued at \$500,000.00 - over the 5 years loss.

I have recently visited my old Property to see infestation of wild Pigs, dogs goats and ferrii dexter Sheep. Pine growth has taken over many areas which cannot be ridden through on saddle horse or Motor Bike. The shearing shed and yards have been pulled down, and carted to the Bingara dump. The Cattle yards have been sawn down and also carted to the Dump. With the 20 years of Neglect, the Property looks abandoned by man.
