## IMPROVEMENTS IN ANIMAL WELFARE FOR AUSTRALIAN LIVE EXPORTS

Thank you for the opportunity to submit our comments to the 2011 Enquiry into Live Exports

- 2. Investigate and report on the domestic economic impact of the live export trade within Australia including:
  - a) Impact on regional and remote employment especially in northern Australia;
  - b) Impact and role of the industry on local livestock production and prices;
  - c) Impact on the processing of live stock within Australia.

## 3. Other related matters.

The MLA in our opinion failed in their duty to seek HKM Halal Kind Meats consent regarding the MLA Halal brand for meat export which requested ritual slaughter. It would have been clear to MLA – or "should have" that our organisation Halal Kind Meats was in a partnership programme with AFIC Australian Federation Of Islamic Council.

We feel MLA did in our opinion misrepresent our Halal Kind Meats programme— which is to phase out live exports by using our unique contacts with Muslim countries & others worldwide &— instead export pre stunned meat from new abattoirs which will be owned by the Australian public.

MLA by approving meat for export using ritual slaughter without full approval of all stake holders/ partners did we fear harm our image. It would be clear in our opinion that MLA ignored public information on the AFIC web site & other web sites clearly showing HKM Halal Kind Meats as partners with AFIC.

At no time did MLA contact these partners to seek our approval for MLA Halal meat export Ritual Slaughter brand. We are calling upon

authorities to cease the practise of ritual slaughter & for the halal MLA brand. We call upon RSPCA to review these practises in regards to the export of this meat & pre stun animals used in producing this meat for export. We call upon the MLA Government & other authorities to broaden their marketing in regards to meat to include promoting overseas opportunities to – re open or open new abattoirs in Australia & work also with our programme in marketing..
