The Department of the Prime Minister and Cabinet has examined the letters submitted by ASIO to the *Martin Place Siege Joint Commonwealth – New South Wales review*.

Question 1: Who rang you to ask about the Monis/AG Brandis letter on the morning of Monday 1 June before you then rang Katherine Jones from the Attorney General's Department?

Answer: I have checked my mobile records but am unable to identify or recall who rang me about the Monis/AG Brandis letter.

Question 2: Can you tell me how much of his correspondence was referred to ASIO from other agencies?

Answer: In the short time available (the hearing was only last night) we have searched our Review files. It appears that ASIO provided 16 letters to the Martin Place Siege Review team in response to the document discovery request. The attached table gives basic details of the letters by date, heading and recipient. Details of private citizens have been omitted.

Of the 16 letters, ASIO was either the primary recipient or a 'CC' addressee for eight letters. The remaining eight letters were all sent to non-government recipients including to the families of ADF personnel, private businesses, "Mujahids" in Pakistan and the families of the Bali bombers. I believe all of these letters were posted on the Sheikh Haron website.

None of the 16 letters appear to have been referred to ASIO by government departments, ministers or officials.

Question 3: Can you provide the email you sent to AGD at 5:30 pm 1 June?

Answer: The email is attached.

Question 4: Are you aware of any letters received by other Government departments or agencies which were referred to ASIO because of Security concerns?

Answer: No.
