

Employers should have to disclose on the Employee's Annual PAYG Summary Statement the superannuation guarantee amount paid for year, coded box for exceptions if 9.5 % not paid, eg over 65, <18, below threshold etc. The ATO cross checks this with employer's tax return. The individual crosschecks with their super fund.
