Australian Capital Territory (Self-Government) Amendment (Disallowance and Amendment Power of the Commonwealth) Bill 2010

Questions on Notice from Senators Humphries and Barnett

1. Question: When was the last time that the ACT Self-Government Legislation was amended?

Asked By: Senator Humphries

Answer: The latest compilation of the Act prepared on 6 July 2009 (page 51) indicates that the latest amendment was number 54 of 2009.

2. Question: How many times has a request been made to the Minister on a Review of the ACT Self Government Act.

Asked By: Senator Humphries

Answer: A review of the ACT Self-Government Act has been a longstanding concern of the ACT Government. The Chief Minister wrote to the then Australian Prime Minister, the Hon Kevin Rudd MP, on 12 May 2009 and 26 June 2009 regarding a review of the *Australian Capital Territory (Self-Government) Act 1988* (The Act). The Minister for Home Affairs, the Hon Brendan O'Connor MP, responded on behalf of the Prime Minister as follows.

- The Australian Government does not object to the ACT Government undertaking a review of the Act; however, a review should be driven by the ACT and its residents and that a joint review with the Commonwealth is not warranted.
- Should the ACT Government elect to undertake such a review the Australian Government would be interested in being informed of the outcomes.
- In September 2010 Chief Minister Stanhope wrote to the Prime Minister and Minister Crean indicating the ACT Government's continued commitment to a formal joint review of the Act.
- Minister Crean met with Chief Minister Stanhope on 24 November 2010 where the Australian Government's position was reiterated.
- Minister Crean and Chief Minister Stanhope agreed that the ACT Government would undertake a review of the Act and that the Australian Government would give serious consideration to the results of the review.

3. Question: Does it happen from time to time that the Administrator does not provide assent [to a Schedule 2 matter under the Norfolk Island Act 1979]?

Asked By: Senator Barnett

Answer: The Department is not aware of any instances where the Administrator has withheld assent to a Schedule 2 matter.

4. Question: How many of those would there be [schedule 3 matters that the Administrator has had to take advice from the Minister responsible for territories prior to giving assent, and how many non-Schedule 2 or 3 matters have been referred to the Governor-General]?

Asked By: Senator Barnett

Answer: The Norfolk Island Administration has provided the attached list of legislation reserved for the Governor-General and referred for Ministerial instructions (see <u>Attachment A</u>). However, the list is incomplete. When considering that list it is also important to bear in mind that the items listed in Schedules 2 and 3 of the *Norfolk Island Act 1979* (Cth) have been expanded over the years since self-government. For example, the addition of 61 items to Schedules 2 and 3 since 1985 has reduced the Bills referred for either Ministerial instructions or consideration by the Governor General. A list of the variations made to the Schedules is at Attachment B.

In relation to proposed laws referred to the Governor-General, the Office of the Administrator has advised that 224 Bills were referred to the Governor-General since 1979. The bulk of those matters referred to the Governor General occurred during the formative years of the Norfolk Island Legislative Assembly. In more recent times, there has been greater emphasis on early consultation to ensure inappropriate legislation is not referred to the Administrator. Over the past ten years only some 25 non Schedule 2 or 3 matters have been referred to the Governor-General.

5. Question: How often and when? [have you consulted with the Minister's Office on the issue of the labour Government's support for the Bill since the Bill was introduced]?

Asked By: Senator Barnett

Answer: The Department is in continuous contact with the Minister's Office and it is not possible to enumerate how often this occurs. Consultation was ongoing over the week of 14 to 18 March 2011.

6. Question: Did the Government give you advice to confirm its support for the original bill back in September [2010] when the ACT bill was first introduced by Senator Brown?

Asked By: Senator Barnett

Answer: The Department is not aware of any changes in the Government's policy relating to the self-governing territories.

7. Question: Let us know when you received that? [advice from the Government after the amendments were circulated on the first of March 2011, that their support would continue]

Asked By: Senator Barnett

Answer: The Department is not aware of any changes in the Government's policy relating to the self-governing territories.

8. Question: Well you have received legal advice, but you are saying it may or may not include constitutional advice? [Did the legal advice include constitutional advice?

Asked By: Senator Barnett

Answer: The Department is unable to disclose the content of legal advice.

9. Question: When did you receive it? [the legal advice].

Asked By: Senator Barnett

Answer: 11 March 2011.

10. Question: I would like the committee to have a copy of that advice.

Asked By: Senator Barnett

Answer: The Department is unable to release legal advice. A decision on the release of legal advice properly rests with the Minister.

11. Question: How many times has the ACT Govt introduced, or publicly announced their intention to introduce legislation to support gay marriage in one form or another? (Please feel free to speak with AGD, and advise to the best of your ability.)

Asked By: Senator Barnett

Answer: The Department is not in a position to advise on the precise number of occasions in which representatives of the Government of the Australian Capital Territory have publicly announced their intentions in relation to laws on same-sex marriages or civil unions. The Department is aware of the following in regard to the introduction and passage of legislation in the ACT relating to same-sex marriages, civil unions or civil partnerships:

- The ACT Government introduced the Civil Unions Bill 2006 into the ACT Legislative Assembly on 28 March 2006.
- On 11 May 2006 the ACT Government introduced 22 pages of amendments to the Civil Unions Bill, and the Bill was passed by the ACT Legislative Assembly.
- On 8 June 2006 the ACT Government introduced and passed the Civil Unions Amendment Bill 2006, to reduce the notification period for a civil union from one month to five days.
- On 13 June 2006 the Governor-General disallowed the ACT *Civil Unions Act* 2006.
- On 12 December 2006 the ACT Government introduced a new Bill (the Civil Partnerships Bill 2006) to replace the disallowed *Civil Unions Act 2006*.
- On 5 December 2007 the ACT Attorney-General indicated he wished to introduce an amended version of the Civil Partnerships Bill into the ACT Legislative Assembly.
- On 5 May 2008, following discussions with the Commonwealth Attorney-General, the ACT Government amended the Civil Partnerships Bill 2006 to remove provisions that related to a legally recognised ceremony for civil partnerships. The Civil Partnerships Bill was passed by the ACT Legislative Assembly on 9 May 2008, and commenced operation on 19 May 2008.
- On 26 August 2009 the ACT Greens introduced the Civil Partnerships
 Amendment Bill 2009 into the ACT Legislative Assembly. The Assembly
 passed the Bill on 11 November 2009 following the inclusion of a series of
 amendments put forward by the ACT Government. It commenced operation on
 19 November 2009.
- On 8 December 2009 the ACT Government introduced the Civil Partnerships Amendment Bill 2009 (No 2) into the ACT Legislative Assembly. The Bill incorporated a requirement that all civil partnerships must be registered in order to have legal effect. The Bill was passed on 10 December 2009, and commenced operation on 18 December 2009.
