Submission to the Standing Committees on Customs Legislation Amendment (Commercial Greyhound Export and Import Prohibition) Bill 2021

I welcome the opportunity to submit to this important inquiry into the *Customs Legislation Amendment (Commercial Greyhound Export and Import Prohibition) Bill 2021* (the bill). I commend the committee for taking on such an important matter.

Recommendation:

- 1. The committee recommend the passage of the bill.
- 2. The committee strengthens the bill by:
 - a. Strengthening penalties
 - b. Supporting greyhound retraining and adoption.

The key reasons to pass the bill are:

Animal Welfare: the primary reason to support the bill is the promotion of animal welfare. Greyhound racing and commercial breeding should not happen due to concerns about the treatment and welfare of the animals involved. Prohibiting the exportation and importation of greyhounds for racing, breeding, and commercial purposes can be seen as a step towards safeguarding the well-being of these animals.

Greyhounds used in racing are often subjected to intense training, confined living conditions, and potential injuries on the track. There have been cases of overbreeding, where large numbers of greyhounds are bred to maximize profits, leading to issues such as the culling of surplus dogs that are deemed unfit for racing. By studying and adopting successful international models, the bill can benefit from existing frameworks

Reducing Overbreeding: Prohibiting the commercial export and import of greyhounds may contribute to reducing overbreeding. This measure can help prevent the excess supply of greyhounds and potential welfare issues associated with surplus dogs in the racing and breeding industries.
