Answer:

1. The Regional Growth Fund (RGF) was established in the 2017-18 Federal budget.
2. The initial administered funding allocation for the program was \$272.2 million.
3. The RGF was intended to provide grants of \$10 million or more to support major transformational projects to deliver long-term economic growth and create jobs in regions, including those undergoing structural adjustment. The scope was expanded in February 2018 prior to the program guidelines being published, to enable strategically linked projects which together deliver economic benefits to a region or regions, to be included.
4. No additional funding has subsequently been allocated to the program.

Note that \$25m was transferred from the original RGF program appropriation of \$272.2m to the CDG programme as part of the 2021-22 Budget process¹.

- b. In 2019 a total of \$272.2m was awarded in Australian Government funding for 17 RGF projects. Two projects have since been mutually terminated and no Australian Government funding was spent on these projects.

7. The department established a team of staff to conduct the initial RGF assessments associated with stage 1 of the RGF application process, provide advice and recommendations to a Ministerial Panel for decision in conjunction with Cabinet or the relevant Committee of Cabinet, assess full business cases received as part of stage 2, and make recommendations to the Minister on the value with relevant money assessment of each full business case. Over time, the department has moved away from having dedicated departmental resources allocated to administer the program. Departmental resources are used to deliver a suite of regional grant programs concurrently, including the RGF.
8. There were:
 - a. 18 staff dedicated to the implementation (assessment phase) of the RGF program
 - b. This consisted of three Executive Level 1 (EL1) staff and 15 APS6 staff.
9. The department did not receive specific departmental funding to administer the RGF program as part of the budget process. The department continues to absorb costs associated with administering the RGF, and is unable to separate these costs out as staff work concurrently across a suite of regional grant programs.
10. Approved guidelines are in place for the RGF. These were publicly released on 02/03/2018 and are available on the department's website at www.infrastructure.gov.au/territories-regions-cities/regional-australia/regional-and-community-programs/regional-growth-fund
11. Draft guidelines were not provided for the program.
12. N/A
13. The then Minister advised State and Territory Ministers of the programs intended opening in March 2018. The department sought input from State / Territory Governments and relevant Australian Government Departments at the Initial Assessment stage of the program.
14. N/A
15. The department recommended an open, competitive selection process be undertaken for this merit based grants program. Stage one required submission of an initial application for competitive assessment. Successful applicants from stage one were then invited to submit a full business case that aligned with the program guidelines for a value with relevant money assessment.

Answer:

16. A two stage process was used to identify projects for funding from the Regional Growth Fund (RGF), as follows:

Application process - Stage 1

The fund opened for initial applications on 2 March 2018 and closed on 27 April 2018, which allowed eligible applicants to submit their project for consideration, without requiring them to commit significant resources to develop a full business case in support of their application. Eligible applications were merit assessed by the department.

The department consulted with state and territory governments and relevant Australian government agencies, including other Divisions in the department regarding any potential issues noted in the application. In addition, the department held an Interdepartmental Committee meeting with senior representatives from other agencies to discuss the Department's list of projects recommended to be invited to apply under Stage 2. The department then provided advice and recommendations to a Ministerial Panel that selected projects, in consultation with Cabinet, to proceed to Stage 2 of the application process.

Application process – Stage 2

Successful applicants from the Stage 1 process were invited to submit a Full Business Case that aligned with the program guidelines, for a value with relevant money assessment. This assessment considered project viability and sustainability, and eligible applicant viability. Projects assessed as being value with relevant money were approved for funding by the then Minister. One project was assessed as not being value with relevant money and was not approved for funding. One application was withdrawn by the applicant.

Where a project had been invited to submit a full business case under Stage 2 of the application process but was not successful at the end of the value with relevant money assessment, the RGF Guidelines allowed for the Ministerial Panel to reconsider unsuccessful applications from Stage 1 and invite them to submit a full business case at a later stage.

Three applicants from Stage 1 were subsequently invited to submit a full business case for assessment, and all three of those projects were subsequently approved for funding by the then Minister.
