Please consider this email a formal submission by me to the Senate Standing Committee on Community Affairs Inquiry into the National Disability Insurance Scheme Bill 2012.

The current disability system has many problems that need to be addressed.

My real concern is that care givers may not always be the best people to manage the money that will be available to the person with a disability and they may not make best decisions for people who haven't the ability to be able to direct their own lives and the way they want to live them. I have seen many times abuse of funds that were given to a person with a disability by their parent or care giver. The world doesn't necessarily produce perfect people who are in charge of them now and my concern is that if large sums of money are given to not so good care givers, who will use the money for themselves or not in the best interests of the person with a disability who will be far worse off than they were before the NDIS. Not that I believe something shouldn't change from the way it is now I do, but there needs to be some sort of competency test before someone is able to be legally responsible for the financial care of another human being who may not have the ability to protect themselves even from their loved ones. fortunately it will work for my family as my son has amazing family support and the family would always protect him even from each other if that were necessary.
