AFIS Congress calls upon the federal government to immediately cease the issuing of export permits for this trade and pass the legislation required and the bills before this parliament to permanently ban live animal exports:

### Lost Jobs in Australia

The majority of live animals exported for the Saudi religious festivals are slaughtered in Saudi abattoirs, frozen and shipped to poor Muslims – putting paid to the lack of refrigeration claim.

### Australia should be leading the way.

## Why the live animal export industry will end

The live animal export trade has been compared by many to the barbaric slave trade of the 1800's. It is not hard to see why. One day, these two industries will sit side by side on the most shameful pages of human history. Live exports hurt the economy and jobs in rural and regional areas..

Northern Territory and northern Western Australia, have deliberately geared themselves to produce animals specifically for the live export market. By restructuring to cater for the live export market, they have STOPPED supplying animals to local abattoirs and caused the abattoirs to shut down. Senators We have Muslim children and community unable to sleep and crying over the cruelty.

Under current circumstances it's probably somewhat indelicate to say we are potentially in the 'box seat'. But we are. We live in the right place in the world and this will be increasingly apparent as our region becomes wealthier.

We have the knowledge, capacity and the resources of land and water, if we use them sensibly, to be a major meat producer. The major region in Australia for cattle will be the north. The reason I say that is because I am working on a paper at present, which shows, from the best hydrological studies available, southern Australia and Queensland will lose 17 million hectares of land to salt by 2050. Eight million hectares of that area will be in WA.
