

Dear Secretary,

I apologise but my responses to questions on notice are a day late.

In response to the question on notice about what are 'the privacy protections in the digital ID bill that you think, as a bare minimum, need to be included in this bill', I say the following:

The Digital Identity Bill (public exposure draft) contains a range of privacy protections in addition to current privacy laws. A number of these provisions could be usefully repurposed and inserted into the IVS Bill. Some amendments would be required in some contexts. But at a general level, we recommend including the following provisions from the Digital Identity Bill:

- a 33 - an expanded definition of personal information
- s 34 - an expansion of the application of privacy protections beyond just APP entities
- s 36 - a provision that means that relevant contraventions are taken to be interferences with privacy, for the purposes of the Privacy Act
- s 40 - an additional role for the Information Commissioner of providing advice
- s 41 - a prohibition on collection of certain information (acknowledging that some of these prohibitions may not be workable given the nature of the IVS scheme)
- s 42 - requirements around express consent, which would require additional amendments
- s 43 - penalties for disclosure of restricted attributes without consent (acknowledging that some of these prohibitions may not be workable given the nature of the IVS scheme)
- s 45 - restrictions on biometric information, which as for s 42, would require additional amendments with respect to consent. The other clauses relating to biometric information could potentially be appropriate for this bill, but may be unworkable depending on the status of other amendments
- s 50 - prohibition of profiling
- s 51 - prohibition on use of personal information for enforcement purposes
- s 52 - prohibition on use of personal information for marketing purposes

In response to the second question on notice about criminal penalty clauses 'and whether there are any amendments or things that you would suggest' I say the following:

We note that the above provisions from the Digital Identity Bill often commonly involve civil penalty orders associated with violations. We would recommend a similar regime apply for the IVS Bill. In particular, we note the utility of expanding the consequences associated with a contravention (under s 36 of the Digital Identity Bill) which would allow this legislative regime to improve in the event the Privacy Act is reformed.
