**COMMUNITY CONSULTATION REPORT – PROPOSED INFRASTRUCTURE
UPGRADE OF RUSSELL BUILDINGS 5 AND 6, AUSTRALIAN CAPITAL
TERRITORY**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the Project – Proposed Infrastructure Upgrade of Russell buildings 5 and 6 Project (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that wherever feasible they could be addressed by Defence in its program of works.

Multiple activities were undertaken in accordance with the project's Stakeholder and Community Consultation Plan, namely:

- a. Correspondence sent by email to local groups, State and Federal members with individual briefings conducted where requested. A list of the members and groups consulted is at annex A, with a short description of the outcomes of the consultation. An example of the correspondence sent to the members and respective groups on 15 March 2017 is provided at annex B;
- b. Advertisements placed in the Canberra Times in the Public Notices section on 12 and 19 March 2017. An example of this advertisement is provided at annex C;
- c. Two Public Information Sessions were held on 22 March 2017 at Russell Offices Building 1 theatre within the Russell Precinct as detailed at annex D.

There were no issues raised by the Community through the Community Information Sessions as there was nil attendance.

In conclusion, no issues have been identified during Defence's community consultation that will impact on the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the Community about the Project and to provide opportunities for the Community to raise concerns and questions.
