CQUniversity responses

Question 1:

The following is number of domestic applications as at 30th July 2021 for Term 2 2020 and Term 1 2021. The applications for the following year may have some variation due to intake dates on TAC's. The applications for Term 2 2020, represent approximately a 38% increase over previous year – 2019.

Question 3:

CQU is currently overenrolled against its domestic student load for 2020, having experienced a very large increase in student demand in Term 2 2020. CQU saw its domestic undergraduate intake in Term 2 2020 increase by 34% over Term 2 2019. Many other Queensland universities have experienced similar enrolment increases, with the economic downturn and increase in unemployment attributable to COVID-19 being a key driver of that growth.

The University is expecting that increase in student demand to continue into 2021, however may not be in a position to fully service that increase. The University is experiencing increasing difficulties in securing clinical placements in key discipline areas such as Nursing due to the impact of COVID-19 on Queensland's health system, and is mindful of the implications of continuing to growing its enrolments further in excess of its funded load.

Further decisions will be made on this by the University's Executive later this year, however two scenarios for the University have been outlined below:

If the University were to grow its commencing student numbers to cater for the increase in student demand:

If Australia's international borders are open prior to Term 2 2021 for commencements of new International students in 2021, which is the expected likely situation (i.e. T1 2021 closed border, T2/T3 2021 open border):

- The closed border scenario assumes the majority of commencing students are commencing offshore studying a part-time workload via online learning, and will transition to on-campus study in Australia once restrictions are lifted.

University of New England

Q1. Domestic undergraduate applications received by July 30 (broken down by semester 2 intake and for Semester 1, 2021, if possible)

For Trimesters 1 and 2 2020 UNE received applications from 14,624 applicants.

Q2. Domestic undergraduate applications received by this time in 2019 (broken down by Semester 2 intake and for Semester 1 2020, if possible).

For Trimesters 1 and 2 2019 UNE received applications from 14,532 applicants.

Q3. Projected domestic undergraduate enrolments in 2021

Our most recent forecast for 2021 domestic student load is as follows:

Trimester 1: 3,630 EFTSL Trimester 2: 3,328 EFTSL Trimester 3: 1,786 EFTSL

At this stage the forecast is highly speculative as the ongoing impact of COVID-19 and possible implementation of the Jobs Ready Graduates package have not been incorporated. Note that the numbers are EFTSL only as we do not forecast student enrolments. This includes both commencing and continuing students which can be separated if needed.

Q4. Projected international student enrolments for 2021

Due to significant uncertainty we have not reforecast international student enrolments for 2021.
