The Secretary,

My submission is brief, heartfelt and based on 66 years of hard observations mixed with a knowledge of science, which it seems no longer taught.

My comments are set out below under your committee's terms of reference.

ne effect on household power prices, particularly households which receive no benefit from rooftop solar panels, and the merits of consumer subsidies for operators;

Only a fool would argue that the attempts by all Australian governments over the last 20 years to promote the use of renewables, such as wind power, before they are ready to take a significant future place in energy generation in economic, technical and social terms, hasn't been to the detriment of electricity consumers both economically and socially.

Few try to justify these errant policies economically, with their supporters generally preferring to argue that the cost burden that the consumers have borne is justified by the greater good arising from "saving the planet" or "reducing carbon pollution" or the utterance of other meaningless catchphrases.

The reality is that wind power will never provide dependable power in the volumes the planet's people presently demand and will increasingly yearn for. Worse still, it can never deliver reliable power and can't even delivery significant unreliable power without massive installations across every landscape, a situation which will never happen, as before this point could be reached the few who are blighted with the presence of these monstrosities today will become the many, and they will rise up and bring down the towers and the governments that have promoted them.

how effective the Clean Energy Regulator is in performing its legislative responsibilities and whether there is a need to broaden those responsibilities;

The Clean Energy Regulator needs to be depoliticised. Instead of acting in a political manner, promoting the need to reduce "carbon [unsaid: dioxide] pollution" it should be stripped of all staff who do not understand that their role should be to to promote:

- 1. cleaner coal burning (even less SOX, NOX and particulates than Australian coal fired stations produce today);
- 2. greater use of natural gas; and
- 3. greater use of hydro power in conjunction with water conservation.

the implementation of planning processes in relation to wind farms, including the level of information available to prospective wind farm hosts;
