






If we saw the same level of food insecurity in remote Aboriginal communities, in the cities, it would be an absolute scandal.




After three reports in over a decade, it's disappointing that the same issues are being raised 11 years later," Ms Burney said.

"Given the current pandemic, and when we were in lengthy lockdown periods when food products were very limited, we saw products walking off the shelves." he said.

"Now the time is perfect for all to figure out how we can best put in strategies and systems and processes so we don't find ourselves in a similar situation (ggain)."

Mr Paterson said poverty was a major contributor to Indigenous Territorians not having access to healthy food.

"It's a great opportunity for the Commonwealth Aboriginal Workforce Program and Jobsecker to be reformed in a way that enables the employment of those in the food security industry," he said.

"Currently they (welfare payments like JobSeeker) don't provide enough support for people to afford healthy food. They need to support people to affect to have long-term sustainable jobs so they have a good income and can afford healthy food."

Mr Paterson said the summit was seeking to establish a storage container in the Territory for non-perishable food items in the event of an emergency or natural disaster.

He said moving forward. AMSANT was seeking federal government funding for another summit in 12 months "given the firgency of frod security now and making sure we're well-prepared for any future disasters or pandemics".

Former senator and Olympian Nova Peris also attended the summit for a presentation of her Food Ladder project, which provides hydroponic greenhouses to remote communities.

The project, which Ms Peris is doing in partnership with former Territory MLA Ken Vowles, nims to help remote communities with food supply issues.

"The lockdown has been tough for remote people that have had problems with fond and supplies, "There is so much we think we can do to help" Ms Paris told the NT News last year.

"Ken and I want to give back through the foundation.

Thank you for your email dated 30 October 2022.

My responses to your questions are set out below:

1. Minutes of the Consultative Forum Meeting

I understand that you seek clarification of my response to your request for minutes and the list of attendees of the Pirlangimpi Consultative Forum Meeting (CFM) held on 5 October 2022. I noted that the minutes and attendance list of the CFM are not routinely published. By this I mean, these documents are not routinely made available to the public as they contain personal information and information pertaining to the business affairs of the CFM. I have previously invited you to contact me to discuss your request and to see if I can provide further assistance in relation to this matter. This offer still remains available.

2. Application

I understand that you seek clarification of the approval process and a copy of my assessment relating to the application for a commercial sublease from the Nova Peris Foundation .

I summarise the process and the basis of my decision below:

Background

Since the Pirlangimpi Township Lease was established in 2017, the Office of the Executive Director of Township Leasing, the Office of Township Leasing (OTL) has worked in partnership to empower Traditional Owners and Township residents to advance social and economic opportunities. In accordance with the terms of the Pirlangimpi Head Lease, the OTL engages in culturally appropriate decision making through the CFM mechanism which has been established to consider and provide advice on a range of matters under the Township Lease, including land development. The CFM is made up of Traditional Owners.

Process

The Nova Peris Foundation approached the OTL in February 2021 regarding the development of an unsurveyed lot for the purpose of establishing a food production and small business hub. Subsequently, the Nova Peris Foundation submitted a Commercial Sublease application (the Application) to the OTL dated 30 October 2021.

Following the lodgement of the Application from the Nova Peris Foundation, you were advised that the Application had been received and would be presented to the CFM.

Due to external factors such as COVID 19, cultural matters and other priorities of the CFM, the Application was not presented to the CFM until 5 October 2022.

Decision

On 5 October 2022, a CFM was held in Pirlangimpi. The Application was considered, and the CFM advised the Executive Director of Township Leasing (Executive Director) that they did not support the Application. The CFM requested that the Executive Director convey this to the Nova Peris Foundation.

As requested by the CFM, on 21 October 2022 I wrote to you advising that the Application was not supported by the CFM and consequently would not be progressed to the next stage of evaluation and assessment by the OTL.

Matters requiring clarification

The Nova Peris Foundation was invited to attend the CFM held on 5 October 2022. It should be noted that an invitation to attend a CFM is not standard practice and is generally only made if requested by CFM members after they have had an opportunity to consider a land development proposal. I acknowledge your advice that I misunderstood your previous correspondence, and that you did not wish to attend the CFM on 5 October as you were unavailable to do so. I also acknowledge your request that I have regard to the outcome of a meeting you held with the Tiwi Land Council and Munupi Pty Ltd directors, Munupi Clan Members and Tiwi Resources on 12 September 2022. In response to this last request, I must advise you that all consultations relating to land development proposals within the Township of Pirlangimpi must be undertaken through the CFM mechanism and I, as the Executive Director, must have regard to the voice expressed at the CFM. This is a requirement of the Pirlangimpi Head Lease.

3. Expectations and Priorities of the Office of Township Leasing

You have asked me to advise whether proposed developments which provide employment, health and social well-being benefits for the community are a priority of the OTL?

In response to this question, I note that the Pirlangimpi Township Lease was granted to the Executive Director to work in partnership with Traditional Owners to advance social and economic opportunities. The principles for the partnership are set out in the Pirlangimpi Head Lease, which imposes a responsibility on myself and the OTL to undertake strong community engagement practices and facilitate culturally appropriate land management decision making (including in relation to developments which promise the benefits outlined in the question above) through the CFM.

4. Community support

You have sought further clarification as to whether the community support has an impact on the decision?

I refer to my response under 'Matters requiring clarification' above.

I trust this provides you with the information you were seeking. Please let me know if you would like to meet with me to discuss this further and I will work with you to arrange a convenient time.

Re: Munupi Fresh Food Proposal

I refer to our recent conference at our office in Essendon with Constance Puruntatameri and yourself.

At the conference you submitted a number of documents confirming the support of the Munupi Clan for the Munupi Fresh Food Proposal, including the Minutes of the Meeting of the Munupi Clan held at the Piriangimpi Club on 12 September 2022.

At that meeting, the Munupi Clan voted on the Munupi Fresh Food Proposal presented by the Nova Pens Foundation to be approved, subject to approval by the sub-lease from the Office of Town Leasing ("OTL").

A subsequent meeting of the Consultative Forum Meeting ("CFM"), tasked with advising the Munupi Clan, has rejected the lawful wishes of the Munupi Clan without any explanation as to why the proposal was rejected.

In my view, the actions of the CFM and OTL cannot unreasonably deny the acceptance of the Munupi Clan's approval of the Munupi Fresh Food Proposal and the sub-lease must be granted. Not to do so is unlawful.

The Northern Territory and Australian Governments to provide long term investment in community controlled local food production and critical infrastructure to support greater food production, including the harvesting of traditional foods, in and around Aboriginal communities. This should include:

i. Funding for training for Aboriginal people linked to Agriculture jobs in and around Aboriginal communities.

ii. Assistance for Aboriginal communities to harvest traditional foods for community consumption and sale to both local and national markets

iii. Provide investment into community controlled primary industries which provide economic opportunities for Aboriginal communities

Growing and narvesting more food in and around Aboriginal communities can play an important role in increasing access and availability of healthy food for the community. Harvesting and growing more food locally sharters the pupply chain of fresh produce, fowering the cost and improving the quality and shelf life of the fresh food. By increasing the access and engagement in producing more locally grown food this can also support Aboriginal people's food sover ready and ensure the feed system is meeting the community's needs.

Participants at the Food Summit workshop and community consultations saw the need for more food production as not only an important aspect of increasing community food security but as an employment opportunity. It is clear the attractiveness of not only the increased access to traditional foods and healthy shop foods but the employment and health benefits from greater production and harvesting of food in and around remote communities has strong community support.

You can't be what you can't see. So if we want our communities to be healthy we need to make healthy food available. Have people growing it and eating it fresh. Nova Peris





We are writing on behalf of the Yirrkala School Council to express strong support for the establishment of a hydroponic greenhouse project at Yirrkala School. The Yirrkala School Council has tried since late 2017 to establish a greenhouse at the school. At that time, we worked directly with Food Ladder to approach philanthropic organisations and local Aboriginal corporations for support, but we not able to secure the funding needed. Now, with the presence of Nova Peris OAM through her newly established charity there is the opportunity to enable this to occur. Nova has a fantastic reputation that she has earnt from her achievements, and from giving back to community for nearly three decades. She is highly respected and trusted, thus able to gain the support of not only community, but of private, philanthropic and government sectors. We could not be more excited about the opportunity to work with Nova and her Foundation.

We see this project as a significant opportunity to enhance the learning and wellbeing of the children and teenagers who attend Yirrkala School. The project will support the children and families of Yirrkala on a number of levels and complement initiatives that are already happening in the school.

The main impact of the project will be on improving the diet of the students and their understanding about the importance of good nutrition. Many students come to school not ready to learn because of dietary issues that impact on their general health and on their dental health. The school has a School Nutrition Program that is funded by the Federal Government. This funding pays for the Canteen Manager and two Yolngu canteen workers. It does not cover the costs of the food. This hydroponic greenhouse will provide fresh vegetables and some fruits to be used in the meals provided by the School Nutrition Program. Students will have a major role in growing the food and preparing the meals. This gives the long-term benefit of ensuring children have a healthy diet and an understanding about the importance of making good food choices that will have a positive impact in their later lives.

Over the last four years, the school has placed great emphasis on improving the garden and grounds. The main stimulus for this improvement has come from the Yolngu groundsmen who have established beautiful spaces for the students to come to each day and feel happy

in their surroundings. This has had a positive impact on attendance and the calmness of students at the school helping them to be more able to engage in learning. The hydroponic greenhouse project will enhance this initiative and provide more opportunities for the students to work supported by the Yolngu ground staff who will act as mentors and instructors to teach the students about looking after the greenhouse equipment and grow the plants.


Yirrkala School has a Families as First Teachers Program (FAFT) for Mothers and children aged 0 to 4 years. A key goal of this program is to provide education to Mothers about health and diet including making decisions about healthy food choices and making healthy meals. The project would greatly enhance this program by involving the Mothers in growing the food and using the food to prepare meals. This project also provides an opportunity to offer a program to parents of school aged children after school hours and during holidays to provide this important education, advice and experience via this sustainable food system.

The Nova Peris Foundation and Food Ladder will support the school to develop curriculum and learning programs that increase the opportunities for the students to learn about the science and technology involved in running the equipment associated with the greenhouse.

This letter details some of the immediate benefits of the project to the children and families of Yirrkala, but as the project becomes more established there is potential for many more, including greater Yolngu employment, enterprise projects and the development of resources in Yolngu Dhäruk to increase the understanding and awareness of growing and eating healthy food. A key future goal of the project would be to collected the seeds of native food plants and cultivate these in the garden and greenhouse so that there is an easily accessible supply of these foods for the children at the school.

We hope that you will support this important project of the Nova Peris Foundation.
