Question:

What infection control protocols are in place for home care workers and who is responsible for monitoring these protocols, for example is it the subcontractor, the worker, or the staffing agency)?

Answer:

The *Guide for Home Care Providers* provides guidance on how to manage during the COVID-19 Pandemic. The Guide is available on the Department of Health's website at: https://www.health.gov.au/sites/default/files/documents/2020/05/coronavirus-covid-19-guide-for-home-care-providers.pdf.

Approved providers are responsible for ensuring that all subcontractors, workers or agency staff are aware of the infection control protocols.

The Aged Care Quality and Safety Commission (Commission) ensures approved providers meet their obligations with respect to the Aged Care Quality Standards. Approved home care providers have COVID-19 response plans based on the Communicable Diseases Network of Australia (CDNA) infection control guidelines, and the Australian Health Protection Principal Committee (AHPPC) advice on visits to vulnerable groups. A Regulatory Response to COVID-19 Statement (published 2 April 2020), which outlines the approach to minimise infection risks to consumers and staff, is available from: www.agedcarequality-gov.au/acqsc-regulatory-response-covid-19-statement-ms-janet-anderson-psm-aged-care-quality-and-safety-commissioner.

The foundation online infection, prevention and control (IPC) module was developed and implemented by the Department of Health for all health care workers. As at 14 September, this COVID-19 foundation course had 1,295,131 enrolments and 1,208,928 completions.

In addition to this course, there are nine aged care specific online training modules. As at 14 September, across all of the COVID-19 training courses in the portal there have been 2,993,283 enrolments and 2,792,794 completions. Detail data on enrolment and completion numbers is below.
