

Tasmanian Agricultural Productivity Group

Briefing Notes

The Tasmanian Agricultural Productivity Group Limited (TAPG) was formed in 1989. It is the only single body in the State representing intensive agriculture, fresh and processed food producers and associated service industries. The organization is entirely funded from member contributions.

TAPG is in a unique position as it represents the full range of primary, secondary and related activities in agriculture and forestry industries. No other specialist industry body has this vertical integration of membership. This allows for issues facing industry to be addressed by the Board with access to expertise from the continuum of growing, processing, marketing and their related industry services.

Aims of the Group

TAPG is an industry funded group which works with Government, statutory authorities, industry segment groups, other representative groups and individuals to:

- **Ensure the ongoing productivity and growth of the Tasmanian agriculture, forestry, food and related services.**
- **Provide a cooperative forum for the promotion, recognition and ongoing development of all sectors of Tasmania's agricultural, forestry, food and related industries.**
- **Reinforce public confidence in the safety and quality of Tasmanian produce.**
- **Promote the application of safe, efficient, sustainable and appropriate environmental practices.**
- **Provide a multi-sector approach to issues affecting the Tasmanian agricultural industry.**

- **Established TAPG Rapid Response Group as a working party of the Board, conversant with AGVET issues and empowered to respond to rapidly emerging chemical related issues or policy proposals**
- **Assisted the Tasmanian Irrigation Development Board in a number of forums designed to assist growers to take up water rights**
- **Promoted primary production through our organizational role with Devonport's "Taste the Harvest Festival"**
- **Developing a role as a "Partner Group" with the Tasmania Together Board**
- **Sponsoring "Boutique" producers within the wider agriculture industry**
- **Providing industry representation on both the Macquarie and Ringarooma Water Management Consultative Groups**
- **In partnership with Dairy Tas & TFGA instigated an Industry Workshop aimed at reducing the incidence of MCPA traces in the Duck River at Smithton**
- **High level representation on the Steering Committee for the "Innovative Farming Practices Project. This project was responsible for developing improved infrastructure to support agricultural production in Tasmania through the establishment of a CORS (Continuous Operating Reference System) network throughout Tasmania, and increased awareness and knowledge in the agricultural sector of how innovative and precision farming techniques utilizing satellite positioning technology can lead to improvements in on-farm efficiency, productivity and environmental performance.**
- **In conjunction with AgriFood Skills Australia, facilitated a series of seminars and workshops around "sustainability" May – August 2011**
- **Inaugural membership of the Food Industry Advisory Committee established by the Minister for Economic Development.**
- **Membership of the Rural Industry Training and Education Inc.**
- **Membership of the Primary Industry Biosecurity Action Alliance**
- **Joint sponsorship of further Controlled Traffic Farming developments in partnership with Cradle Coast NRM and the Tasmanian Institute of Agriculture.**
- **Established the Tasmanian Fresh Vegetable Marketing Group as a standing committee of TAPG. This group will take over the promotional/coordinating work previously carried out by the State sponsored Vegetable Industry Marketing Committee. It will also play a role in preserving the integrity of the IP generated by the now defunct VIMC.**
