Dear Committee

Thank you for the invitation to make a submission to the inquiry into Australia's youth justice and incarceration system. I have attached a report that might help the committee.

**Trevitt and Browne (2020) *Raising the age of criminal responsibility* (relating to terms of reference a, b, d and f)**

This report describes the moral, medical, and legal arguments and evidence for raising the age of criminal responsibility from 10 years, including the disproportionate impact of the existing criminal legal system on Aboriginal and Torres Strait Islander young people. Polling conducted for this report showed that most Australians support raising the age of criminal responsibility to 14.

There has been limited progress since the report's publication.

Though a 2020 report prepared for the Council of Attorneys-General (CAG) recommended raising the age of criminal responsibility to 14 without exceptions, this never made it to CAG for consideration and few jurisdictions have made progress in this direction.<sup>i</sup>

In the jurisdictions that have made progress, these reforms have often been scaled back, accompanied by expanded police powers over children, or may even be reversed.

The current status of the age of criminal responsibility in each jurisdiction is summarised on the next page.

The Institute would welcome the opportunity to discuss research findings in further detail at any committee hearing, should there be one.

### Current status of the age of criminal responsibility in Australia

Jurisdiction	Minimum age of criminal responsibility	Further details
Commonwealth	10 years <sup>ii</sup>	No public commitments.
Australian Capital Territory	12 years <sup>iii</sup>	After 1 July 2025 this will rise to 14 years with exceptions for listed 'serious offences' including murder. <sup>iv</sup>
New South Wales	10 years <sup>v</sup>	No public commitments.
Northern Territory	12 years <sup>vi</sup>	New Government has committed to lowering to 10 years. <sup>vii</sup>
Queensland	10 years <sup>viii</sup>	No public commitments.
South Australia	10 years <sup>ix</sup>	Proposal to raise the age to 12 has undergone public consultation, outcome not yet announced. <sup>x</sup>
Tasmania	10 years <sup>xi</sup>	Committed to raise age to 14 by 2029. <sup>xii</sup>
Victoria	10 years <sup>xiii</sup>	By 30 September 2025 this will rise to 12 years. <sup>xiv</sup> Previous commitment to raise age to 14 has been dropped. <sup>xv</sup>
Western Australia	10 years <sup>xvi</sup>	No public commitments.
