Dear Senator Ciccone,

On Tuesday 23 April the Department of Agriculture Fisheries and Forestry appeared as a witness before the Rural and Regional Affairs and Transport Legislation Committee. I would like to make the following corrections to the transcript.

1. During the hearing you said in relation to the Craik review's position on a container levy

*"What did the Craik review say about a container levy? Did it say the government had an option of either increasing the full import declaration charge or using a container levy?"*

In response the witness, Ms Saunders said

*"As you indicated, the Craik review suggested either option as a means by which we're going forward. As per evidence earlier today, the Craik review recognised that an alternative to the introduction of a container levy would be to increase the charge on the full import declaration, FID, which applies to container imports. As a result, certainly in terms of the government's deliberations, we have increased the FID for, say, cargo from \$49 to \$63, which I think is consistent with evidence earlier today."*

I wish to correct this answer by adjusting the last sentence of the answer.

*"As a result, certainly in terms of the government's deliberations, we have increased the FID for, sea cargo from \$49 to \$63, which I think is consistent with evidence earlier today."*

2. During the hearing you said in relation to the Full Import Declaration (FID) charge

*"What was the FID in 2018? I guess what I'm after is the FID charge that was in 2018 versus the FID rate in May 2022 versus what it is today"*

In response the witness, Ms Saunders said

*"I don't have that information available to me. I've got the figure. There's certainly the increase in 2023, which was \$49 to \$63, but I would have to take it on notice if you'd like the 2018 figure."*

I wish to correct this answer by confirming the category of the FID charge discussed.

*"I don't have that information available to me. I've got the figure. There's certainly the increase in 2023, which was \$49 to \$63 for sea cargo, but I would have to take it on notice if you'd like the 2018 figure."*

3. During the hearing you said in relation to revenue spending

*“What happens to that revenue? Does it go back to being spent on biosecurity?”*

In response the witness, Ms Saunders said

*“Yes, it does. Whilst I note that this committee's focused on the border protection levy...”*

I wish to correct this answer.

*“Yes, it does. Whilst I note that this committee's focused on the biosecurity protection levy...”*

The remainder of the Departments answers to the questions, provided at the Hearing, are correct.

I apologise for these errors and trust this further information will be of assistance to the Committee.
