CHAIR—That said, advice was not sought of you, of DEEWR, nor of Safe Work Australia in any respect related to that alleged injury, just by way of example.

Mr Griew—It was not, to my knowledge. I think I have already indicated I probably was not actually here then, but I understand that it was—

CHAIR—You might like to take that small vestige of 'gee it might be good in my view if a minister had asked' on notice. I am sorry to give you a question on notice. Could you take on notice the small vestige of hope that maybe a minister might have asked a question about it and you are just not aware of it?

Briefing/s undertaken to the Deputy Prime Minister post Energy Efficient Homes Package Memorandum of Understanding Committee meeting

DEEWR's submission confirmed that the Deputy Prime Minister's Department chaired two meetings of a Steering Committee of Commonwealth officials, union officials and industry representatives that were held in July and November last year. Given discussions at these meetings covered training requirements, implementation of the monitoring regime, and the importance of compliance, including an external audit, was the Deputy Prime Minister or her office briefed in relation to the outcomes of these meetings, and if so, when?

Answer

A Memorandum of Understanding (MOU) was developed to promote linkages between Job Services Australia providers and other Steering Committee members including the HIA, MBA and NESA. The Steering Committee members worked together to support jobs and skills development opportunities for job seekers. The Steering Committee played no role in the delivery of the Energy Efficient Homes Program.

While the Department of the Environment, Water, Heritage and the Arts (DEWHA) provided members with an update on the program, the Steering Committee was an overseeing body that provided advice on the MOU specifically not the Insulation program in general.

DEEWR did not brief the Deputy Prime Minister or her office on the outcomes from either meeting.
