## A SUBMISSION TO THE SENATE COMMUNITY AFFAIRS LEGISLATION COMMITTEE

In reference to The Families, Housing, Community Services and Indigenous Affairs and Other Legislation Amendment (Budget and Other Measures) Bill 2010.

The Community Affairs committee will examine Schedule 2 of the bill. This schedule will introduce an ongoing requirement for residence in Australia for a disability support pension. The amendments will close a loophole that has allowed continued payment of disability support pension to people who live permanently overseas but return to Australia every 13 weeks in order to retain their pension.

### SUMMARY

According to the 2010-11 Budget Papers of the Australian Government, the Disability Support Pension costs 12.9 billion dollars per year, which is 3.6% of the total Budget expenditure of 354.6 billion dollars. If this amount of 12.9 billion dollars is divided by the 22.51 million residents of Australia, this amounts to \$573.61c per person per year, or \$11.03c per person per week. It should be considered that this 11 dollars per week is an essential insurance policy, in case the Australian person is struck down by a debilitating and crippling illness, or is severely injured or paralysed in a motor vehicle accident, or has their back broken, their eyes destroyed, or their arm ripped off in a factory or agricultural accident, or is tortured by excruciatingly painful nervous system diseases.

One has to question the wisdom of begrudging the disabled this 11 dollars per week expenditure, particularly when Australia is now the ninth wealthiest sovereign nation on earth, according to figures from the International Monetary Fund. According to the Australian Bureau of Statistics, Average Weekly Earnings are about 1300 dollars per week.

Wayne Swan, the Deputy Prime Minister and Treasurer, put it best in his book titled "Postcode: The Splintering of a Nation", published in 2005. On page 140, Wayne Swan writes about the Disability Support Pension:

"Why does a welcoming, forward-looking, self-believing nation such as ours have to have plans like this to punish our most vulnerable citizens? Why does a rich country such as ours have to do this? Why, when we are trying to build a nation which offers a way of life second to none in the world, are we deciding to be this mean? A pension cut of 60 or 70 dollars a fortnight would mean little to a [Government] Minister - maybe the price of a quality bottle of red - but to a person with a disability it may mean the difference between affording additional expenses to manage their disability or not"

(page 140, "Postcode: The Splintering of a Nation", by Wayne Swan, Pluto Press Australia 2005)

A small number of Disability Support Pensioners, a fraction of one percent of the 750,000 people on the DSP, have sought relief from the pain and suffering of their disability, by travelling and living overseas, mostly in Asia, where the cost of living is as little as 20% of the cost of living in Australia, and where their pension therefore goes a lot further. Many of these people are severely disabled, living with severe pain and suffering. Many have described how they are much better able to manage and cope with their disability, with their pain and suffering, by living in Asia, where the cost of living is much cheaper, and where there are opportunities to seek the alleviation of pain and suffering through religious meditation.

Mr. Paul Donegan, an adviser to Minister Jenny Macklin, wrote a letter to a Disability Support Pensioner in October 2010, explaining the new legislation, and in the letter he stated that: "[the DSP] is designed to engage people of workforce age in activities in Australia that will lead to greater levels of economic and social participation". However, this is directly contradicted by a report of the Social Policy Research Centre titled "Disability Support Pension New Customer Focus Groups". This report was prepared for the Department of Family and Community Services in 2004. The conclusion of the report was that Disability Support Pensioners are overwhelmingly excluded from economic and social participation, and they experience high levels of stigmatisation, discrimination, ostracism, and insurmountable barriers to economic and social participation, including high levels of direct discrimination by employers.

On the 20th of October 2010, Minister Jenny Macklin issued a Media Release about this legislation, and in this Media Release, it is claimed that "This change is expected to save taxpayers around \$3 million a year when fully operational."

However, there is a great amount of anecdotal evidence to indicate that most Disability Support Pensioners who are affected by this change have already made preparations to return to Australia and re-establish their residence in Australia. There are anecdotal stories about several Disability Support Pensioners who have already made preparations to bring their spouses and children from homes in Asia, and re-establish homes and residences in Australia. There is much anecdotal evidence to indicate that almost all of the Disability Support Pensioners who are affected by this legislation are planning to travel and reside in such a way that their pension is continued. And so there will not be a saving of \$3 million dollars per year as claimed. On the contrary, because the Disability Support Pensioners will now be receiving Australian Health Care, Medicare, Pharmaceuticals in Australia, Rent Assistance, public housing, transport subsidies, telephone subsidies, Child Care and Education in Australia, and additional allowances for spouses and children, all of these additional government resources, subsidies and allowances will actually cost the federal government well in excess of \$3 million dollars a year.

The Committee is requested to call for an audit, by the Australian National Audit Office, or by the Treasury, to discover that in fact this legislation will not save taxpayers \$3 million dollars, it will actually cost taxpayers in excess of \$3 million dollars.

The Committee is also requested to closely examine The United Nations Convention on the Rights of Persons with Disabilities, signed by Australia on 30th of March 2007, and ratified by the Australian Parliament on 17th of July 2008, which reads in part:

"Article 18: Liberty of movement and nationality

1. States Parties shall recognize the rights of persons with disabilities to liberty of movement, to freedom to choose their residence and to a nationality, on an equal basis with others.."

The Committee is requested to determine if this legislation violates this Article 18 of the Convention.

A particular appeal is made to the Deputy Chair of the Committee, Senator Rachel Siewert. If one reads the website of the Australian Greens, it can be seen that Senator Siewert has made many speeches and statements in support of disabled people, and in support of the human rights of disabled people. In addition, the leader of the Australian Greens, Senator Bob Brown, is one of the foremost champions of human rights in Australia. A particular appeal is made to Senator Siewert, to call for an Audit to discover that this legislation will actually cost the government millions of dollars in additional spending and allowances for Disability Support Pensioners who have been forced to return and stay in Australia, and that in fact the government is attempting to spend millions of dollars in order to infringe the human rights of Disability Support Pensioners, and increase their pain and suffering.

A particular appeal is made to Senator Siewert, to discuss this issue with Senator Bob Brown and Adam Bandt, the Greens member of the House of Representatives, with a view to blocking this legislation in the House of Representatives and the Senate. And in its place, Adam Bandt should introduce a Private Members Bill into the House of Representatives, a Bill that will increase the overseas portability of the Disability Support Pension to 26 weeks, as it was before 2004. By virtue of their great success at the 2010 election, the Australian Greens have a mandate to take real legislative action and enact their values of equity, social equality and compassion.....values which have been lost and forgotten by other parties.

## DEPUTY PRIME MINISTER AND TREASURER WAYNE SWAN DEFENDS DISABILITY SUPPORT PENSIONERS AND THEIR RIGHT TO TRAVEL OVERSEAS.

In 2005, the then federal Shadow Treasurer, Wayne Swan published a book titled "Postcode: The Splintering of a Nation". This is essentially a manifesto about what Wayne Swan intends to do when he becomes Treasurer (and Deputy Prime Minister).

The blurb on the back cover states: "Australia is a prosperous country, but the benefits of this prosperity are not being fairly shared - the Australian nation has become a frayed patchwork of winners and losers from economic change.....Outlining what a reforming Labor government must do to promote economic equality and deal with a dangerous level of social exclusion, Wayne Swan sets out a blueprint to halt the splintering of the nation."

Here are a selection of quotes from the book, concerning Wayne Swan's attitude to Disability Support Pensioners:

"We should begin by examining our values. At every turn we are exhorted to 'dob in a dole bludger', resent the pensions paid to the 55-year-old former labourer whose back has finally given way after a life of shovelling, and accept as fair the golden handshakes given to company directors for losing millions of dollars that belonged to mum and dad shareholders." (page 11)

"Most people would have seen the occasional 'A Current Affair' or 'Today Tonight' story involving three or four young men living on the dole who surf by day and make do on baked beans and beer at night. The stories of these young people are used to suggest that hundreds of thousands of unemployed Australians live at the beach with no intention of looking for work. While there are many people on government benefits and low incomes living in and migrating to our sunbelt regions, few are the archetypical beach bum dole bludgers of tabloid TV fantasy." (page 35)

"The exodus of Disability Support Pensioners from capital cities and the dry farming regions of Australia [to coastal 'sunbelt' regions] suggest recipients are trying to achieve a balance between climate and lifestyle on the one hand, and manage financial costs such as housing on the other" (page 38)

"In the following 2002-03 Budget, there was no further action on the common workforce age payment. Instead, the Government announced its plans to remove 200,000 Disability Pensioners from the payment to Newstart through a toughening of the work test used to judge people's eligibility for the payment. This act of post-election bastardry was one of the most depressing things I have witnessed in my time in national politics. We were treated to the Government's attempt to justify the breaking of its pre-election promise by branding people with a disability as malingerers. Until that time I believed my opposite number, Amanda Vanstone, had legitimate claims to be called a liberal. But her enthusiastic embrace of the Government's campaign to push these cuts through the parliament exposed her as no more than a political hyena. The Minister's proposals could not be justified in terms of welfare reform. The cuts would remove the income and material assistance available to people with disabilities and ask them to go out and get a job. The question that no government member from the Prime Minister down will answer is, why you need to cut someone's pension to help them get work. The sustainability of the social security system is under threat only because the current government took the view during its first six years in office to consign welfare recipients - from job seekers to parents, to people with disabilities - to the scrapheap.

Why does a welcoming, forward-looking, self-believing nation such as ours have to have plans like this to punish our most vulnerable citizens? Why does a rich country such as ours have to do this? Why, when we are trying to build a nation which offers a way of life second to none in the world, are we deciding to be this mean? A pension cut of 60 or 70 dollars a fortnight would mean little to a Coalition Minister - maybe the price of a quality bottle of red - but to a person with a disability it may mean the difference between affording additional expenses to manage their disability or not. The cuts show the Howard Government is either completely oblivious to the situation, or is so uncaring that it is not capable of understanding how little so many Australians in this country have to live on. Nobody disputes the need for welfare reform - nobody. But the Coalition's cuts are not reform: they are a full frontal attack on the social safety net that protects disabled Australians from destitution. As a nation we desperately need welfare reform. But that cannot be achieved by 'nickel and diming' vulnerable pensioners." (pages 139-140)

"And as inequality grows, we are also seeing the emergence of a strange downward envy, as many of those just above the poverty line blame the poor just below them for their own plight. Pauline Hanson exploited this feeling of resentment, which often combines attacks on 'dole bludgers' and 'welfare cheats' with racial intolerance." (page 160)

On Tuesday, 7th of October 2003, Wayne Swan made a speech to the House of Representatives, opposing elements of the Family and Community Services and Veterans' Affairs Legislation Amendment (2003 Budget and Other Measures) Bill 2003, and in particular, Wayne Swan specifically opposed the reduction of overseas portability for Disability Support Pensioners. Here is an excerpt of his speech, taken from the Hansard:

Tuesday, 7 October 2003  
Page: 20653

Mr SWAN (Lilley) :

"I now move to the specific provisions of this bill relating to portability. The measure within this legislation that concerns the opposition is the plan to limit the generosity of the portability provisions relating to work force age social security payments. In particular, this bill seeks to reduce the allowable period of temporary overseas absence for portable social security payments from 26 weeks to 13 weeks. This new portability period will also apply to a range of payments, including the disability support pension and family tax benefit. Labor is particularly concerned about the impact of this measure on some of our larger communities that have a heritage overseas. This includes former UK citizens and also the Greek community.

There are good reasons why the portability provisions should be 26 weeks and not 13. Many families who have parents or siblings living overseas are called upon to go to their aid when they get sick or are dying. In some cases this may involve finalising a person's estate. Often there is a need for a person to spend considerable time overseas. There has never been any evidence presented that shows the current rules have been abused. In fact, the net savings the government is claiming for this provision amount to \$4.1 million, and I think they confirm the fact that the government also does not believe that the rules have been abused. These are mean changes that will have a direct impact on people who have loved ones in other countries and they are changes which we will be urging Senator Patterson to join with us in rejecting when this bill reaches the Senate."

#### **A PUBLIC OPINION POLL AND FOCUS GROUP: WHAT DO THE AUSTRALIAN PEOPLE THINK ABOUT DISABILITY SUPPORT PENSIONERS TRAVELLING AND LIVING OVERSEAS.**

The Australian Parliament is supposed to represent the democratic will of the Australian people. So it would be useful if there could be an opinion poll and focus group about "What the Australian People think about Disability Support Pensioners travelling and living overseas".

On the 28th of March, 2010, the Minister Jenny Macklin published a Media Release about the legislation before the Committee, The Families, Housing, Community Services and Indigenous Affairs and Other Legislation Amendment (Budget and Other Measures) Bill 2010. The media release stated: "The Australian Government will crack down on people on the Disability Support Pension (DSP) who live permanently overseas but return to Australia every 13 weeks in order to retain their pension."

On the 28th of March, 2010, The Sunday Mail newspaper of Queensland published an article reporting on this Media Release, an article titled "Welfare loophole allows disability pensioners to go on permanent vacation". On the website of this newspaper, [couriermail.com.au](http://couriermail.com.au), the article was also published, and readers were invited to post their comments on the website. 114 people posted their comments. This article and the 114 comments are reproduced below, and are also still available at the website, [couriermail.com.au](http://couriermail.com.au). Everything indicates that these 114 comments are the honest response of 114 Australian voters from around Queensland and Australia, and can be viewed as type of rough opinion poll and focus group about the issue of Disability Support Pensioners travelling and living overseas. The website, [couriermail.com.au](http://couriermail.com.au), probably keeps the ISP address of the people who posted the comments, and this is further evidence that the 114 comments are a true indication of the opinion of the Australian people about this issue.

A careful study and statistical analysis of these 114 comments indicates:

4 comments were made on March 27, 2010  
94 comments were made on March 28, 2010  
16 comments were made on or after March 29, 2010

25 commenters gave their address as Brisbane and suburbs  
23 commenters gave their address as other parts of Queensland  
18 commenters gave their address as other parts of Australia

70 out of 114 commenters - 61% - APPROVED of Disability Support Pensioners travelling and living overseas.

13 out of 114 commenters - 11% - DISAPPROVED of Disability Support Pensioners travelling and living overseas.

36 commenters mentioned the large difference in the cost of living between Australia and Asia.

14 commenters mentioned the additional costs to the Australian government in health care, housing etc, if the DSPers were forced to spend more time in Australia.

10 commenters alluded to the concept of "Downward Envy", that some people are strangely envious of poor people, and want to make the poor people suffer even more.

Welfare loophole allows disability pensioners to go on permanent vacation

A LOOPHOLE in welfare laws has been allowing hundreds of disability support pensioners to use their pensions to travel overseas most of the year and keep second homes in popular South-East Asian holiday destinations.

The jet-setting lives of 776 disability support pensioners were discovered by a joint Centrelink and Department of Immigration investigation, which found many were taking up to nine overseas trips a year.

The study uncovered 154 gold-class frequent flyers who spent all but eight weeks a year overseas. Of these, 71 spent less than a month in Australia and there were eight described as fly-in, fly-out pensioners who spent only a week a year in Australia.

The loophole allows disability support pensioners to keep claiming the pension, which is now more than \$700 a fortnight, if they return to Australia once every 13 weeks.

Thailand and the Philippines were the top two locations for welfare recipients living in second homes overseas.

In both countries, \$700 a fortnight is considered a small fortune, much more than the earnings of many working full-time, who would consider themselves relatively well off.

Community Services Minister Jenny Macklin said the Federal Government would close the loophole, which allowed the 154 worst offenders to spend most of their time overseas, costing taxpayers \$3 million a year.

Even though only Australian residents can lodge a claim for the disability support pension, and those on the DSP can only be absent from Australia for up to 13 weeks, there are cases of DSP recipients living permanently overseas and flying back to Australia every 13 weeks to continue receiving the pension, Ms Macklin said.

It is not known if those who claimed pensions while living overseas were working while overseas.
