Dear Ms Dunstone

I refer to my appearance before the Senate Select Committee on the establishment of a National Integrity Commission on 15 May 2017, and a question asked by Senator Hinch concerning the extent of cooperation between State anti-corruption agencies. In particular, Senator Hinch asked whether there is a Memorandum of Understanding (MOU) between agencies in this regard.

I can advise that last year the following agencies entered into an MOU: Independent Commission Against Corruption in South Australia; Crime and Corruption Commission (QLD); Corruption and Crime Commission (WA); Independent Commission Against Corruption (NSW); Integrity Commission (TAS); the Independent Broad-based Anti-corruption Commission (VICT); Australian Commission for Law Enforcement Integrity (CW).

The MOU was not a general commitment to cooperating with one another. Rather the agency heads agreed to provide staff to a requesting agency to investigate allegations of misconduct by staff members in the requesting agency.

I can say that there are good levels of cooperation between agencies. A very good example is the Australian Public Sector Anti-corruption Conference which is jointly hosted by a number of agencies every two years. The next conference will be hosted by the CCC (QLD) and ICAC in Sydney in November this year. I have attached a copy of the brochure for this conference for the Committee's information.


Chris Currie
