### **Consolidation of Federal Anti-Discrimination Laws**

We refer to your commitment to 'harmonise and consolidate Commonwealth anti-discrimination laws to remove unnecessary regulatory overlap, address inconsistencies across laws and make the system more user-friendly' (the Consolidation Project).

The Consolidation Project provides a unique opportunity to strengthen and modernise our anti-discrimination regime and improve our laws to ensure that they promote equality, provide comprehensive protection against discrimination and establish reporting and measurement frameworks. Strengthened equality laws would have a normative and educative impact and contribute to social cohesion, higher productivity and participation, and improved outcomes in areas including education and health.

Accordingly, the undersigned individuals and organisations call on the Government to commit to a Consolidation Project that addresses issues beyond regulatory inconsistencies and overlap and aims to modernise and strengthen Australia's anti-discrimination regime and promote equality and fairness for all.
