#### Handling of a letter sent by Mr Man Haron Monis to the Attorney-General

#### 1. Further question on notice from the public hearing on 23 June 2015

On 9 July 2015 the Secretariat, on behalf of Senator Collins, drew the department's attention to the following part of the transcript of the hearing on 23 June 2015 and requested an answer to the question as to whether the department still has a copy of the note from Mr McKinnon.

Mr McKinnon: Senator, that note was from me.

**Senator JACINTA COLLINS:** Okay. So, Mr McKinnon, can you explain your misapprehension as to when the first contact had occurred?

**Mr McKinnon:** That was not the first contact. It was the time when we said we were confident we did not have the letter. I was just wrong by a couple of hours.

Senator JACINTA COLLINS: So the note itself said precisely what Mr Sheehan said on Friday?

Mr McKinnon: That is right.

**Senator JACINTA COLLINS:** Do we still have a copy of that note?

**Mr Sheehan:** We would have in the department, I think. I do not have it here, but we would still have it, I think. I will have to check.

#### Response:

A copy of the note from Mr McKinnon is attached (Attachment B).

As stated by Mr Sheehan at the hearing on 23 June 2015, the first advice that PM&C gave to the department about the letter in question was 12.15pm on 1 June 2015. Mr McKinnon's evidence as set out above refers.

Further, it was only on 2 June 2015 that PM&C advised the Attorney-General's Department that PM&C had four of the five documents (refer email of 12:07pm on 2 June 2015).

#### 2. Request for further information on 10 July 2015

On 10 July 2015 the Secretariat, on behalf of the Senate Legal and Constitutional Affairs References Committee, requested the following information in relation to its inquiry into the handling of a letter from Man Haron Monis to the Attorney-General:

- i. noting that a Question Time brief contains factual information and is intended for the use of the minister in the Senate or House of Representatives and that the Department of Prime Minister and Cabinet has provided its PPQ, each version of the Question Time brief;
- ii. attachments to the emails provided;
- iii. a description of what has been redacted from the emails, and in cases where names have been redacted, the position title and minister's office or relevant agency, and the reasons for the redactions; and

iv. the name of the officer whose file notes were received by the committee on 2 July in relation to the handling of the letter from Man Haron Monis and the Attorney-General and a transcription of the file notes (the scan is illegible).

#### Response:

i. Each version of the Question Time brief (QTB)

Notwithstanding the general practice of not disclosing QTBs, we have attached the following emails with attached Question Time briefs, redacted as appropriate:

- Email of 28 May 2015 at 10.53am from AGD to AGO with QTB (Attachment C)
- Email of 28 May 2015 at 11:07am from AGD to AGO with revised attachment to QTB (Attachment A)
- Email of 2 June 2015 at 1.19pm from AGD to AGO with QTB (Attachment D).

The emails and attached QTBs have been redacted to remove identifying details for non-SES officers, phone numbers and email addresses, information that AGD considers to be out of scope, and information that may prejudice the coronial inquest or other proceedings.

In addition, consistent with its continuing concern to ensure there is no prejudice to the coronial inquest or other proceedings or disclosure of personal information, the department has not provided the copies of correspondence that form Attachment B to the 28 June 2015 QTB.

#### ii. Attachments to the emails

In addition to the attachments to emails that were provided on 2 July 2015, and the three attachments provided in response to the question above, the following three emails had attachments:

• Email of 1 June 2015 at 1.54pm from AGD to AGO attaching a spreadsheet and copies of correspondence

Consistent with its continuing concern to ensure there is no prejudice to the coronial inquest or other proceedings or disclosure of personal information, the department has not provided the copies of correspondence attached to the email and has also redacted details of the subject of the correspondence in the spreadsheet (at Attachment E), except where details are already public.

• Email of 1 June 2015 at 1.57pm from AGD to PM&C forwarding the email of 1 June 2015 at 1.54pm with the same attachments

These attachments are identical to those attached to the email of 1 June 2015 at 1:54pm discussed above.

• Email of 4 June 2015 at 3.05pm from PM&C to AGD (Attachment F) attaching a letter.

Consistent with its continuing concern to ensure there is no prejudice to the coronial inquest or other proceedings, the department has not provided the letter attached to the email of 4 June 2015. Further details on the letter are set out below in response to the third request.

iii. A description of what has been redacted from the emails, and in cases where names have been redacted, the position title and minister's office or relevant agency, and the reasons for the redactions;

Documents were redacted to remove identifying details for non-SES officers, phone numbers and email addresses, information that AGD considers to be out of scope, and information that has national security implications or may prejudice the coronial inquest or other proceedings.

Attachment G is a list of emails and notes provided to the Committee on 2 July 2015 and subsequently. The list identifies the department, agency or minister office that sent or received the emails and, where names have been redacted, the position title.

iv. The name of the officer whose file notes were received by the committee on 2 July in relation to the handling of the letter from Man Haron Monis and the Attorney-General and a transcription of the file notes (the scan is illegible).

The file notes received by the committee on 2 July 2015 in relation to the handling of the letter from Man Haron Monis and the Attorney-General were written by Mr Iain Anderson, acting Deputy Secretary, National Security and Criminal Justice Group. A transcription of the file notes is attached (Attachment H).

These notes were redacted to remove identifying details for non-SES officers.

#### 3. Further question on notice from the public hearing on 19 June 2015

On 20 July 2015 the Secretariat, on behalf of Senator Collins, drew the department's attention to the following question taken on notice at the hearing on 19 June 2015:

**Ms Jones:** It was part of a broader conversation that we were having about a range of matters. I mentioned that I had recalled detailed conversations about a letter from Monis seeking legal advice from the minister. During the course of that conversation it became clear that the letter we had had quite a detailed discussion about—and there were several that were provided to the review where Monis had written to ministers asking for legal advice—was not the 7 October letter to the Attorney-General. So at that point I became aware of the fact that I could not conclude conclusively that as a member of the review team I had seen the 7 October 2014 letter from Monis.

Senator JACINTA COLLINS: Can you describe the letter that was in your mind?

Ms Jones: It was one of several letters that Monis had written to different ministers at different times. In terms of a detailed description of the letter, I may have to take that on notice just because of the issue of the coronial inquest and the provision of documents there and whether there are any concerns about being specific about the details of that letter. I can take that on notice and clarify whether there are any issues about revealing the details of that letter.

#### Response:

The department has not provided a copy of the letter from Man Haron Monis seeking legal advice that Ms Jones' referred at the hearing on 19 June 2015 in order to ensure there is no prejudice to the coronial inquest or other proceedings. The department is able to advise that the letter, which is dated 6 November 2008, included the question 'Is it legal or illegal to contact the Muslim cleric mentioned above when Muslims have a question about their religion?'

A description of the letter of 6 November 2008 is also contained in the report of the Martin Place Siege Joint Commonwealth – New South Wales review (page 9):

'Hizbullah Australia' – a group registered by a close associate of Monis – sends a letter to the then Commonwealth Attorney-General (with copies to the then Prime Minister, Opposition Leader, Foreign Minister and to ASIO) stating the group is now registered in Australia and hopes to begin activity as an Islamic organisation. ASIO assesses the letter to have been written by Monis.

#### **MONIS – CORRESPONDENCE**

- During the period 19 October 2007 and 7 October 2014, Man Haron Monis, also known as Sheikh Haron, wrote to numerous Ministers and Departments.
- Monis' letters were addressed to a range of Commonwealth Ministers, including current and former Prime Ministers, Attorneys-General, Premiers (Queensland), and public officials.
- Those letters were often copied to a broad range of other Commonwealth
  Ministers, Premiers and public officials, including the Director of the
  Commonwealth Director of Public Prosecutions, the Director-General of ASIO,
  and the Commissioner of the AFP.
- While some of those letters were provocative and even offensive, they did not cross the line into inciting violence.
- Nor did they not raise law enforcement or security concerns.
- A number of responses to those letters, including letters referred from other Ministers and Premiers, were provided by a range of individuals, including former Attorneys-General (Ruddock), myself, and officers of the Attorney- General's Department.
- Each of those letters sought to address the issues raised by Monis and provide information that would be helpful to him.

Copies of all correspondence to and from Monis at Attachments A and B.

## Was the correspondence referred to intelligence, security or law enforcement?

- Each item of correspondence received by the Department is carefully assessed.
- Departmental officers liaise with other Government agencies, including law enforcement and security agencies, where an item of correspondence raises concerns.

## Why wasn't correspondence referred?

- The correspondence from Monis handled by AGD did not raise law enforcement or security concerns.
- Monis was known to relevant areas within AGD as a person who wrote to Government, largely alleging discrimination against the Muslim community or alleging corruption or injustice by Government or its agencies.
- He was also well known to security and police agencies.

- The Siege Review also noted Monis frequently contacted intelligence and security agencies frequently.
- He claimed to have information on the 9/11 terrorist attacks and the 2005 London bombings.
- He also claimed to have pertaining to a 'missing Israeli Airman' and contacts
  with access to information on alQa'id, and alleged a number of Australia-based
  events, including the 2009 Victorian bushfires were terrorist attacks.
- On all occasions, Monis information was assessed a not being credible.

## Were Agencies complacent about Monis?

- The Siege Review found no evidence that ASIO or law enforcement became complacent or dismissive of Monis.
- Rather, "each time security or law enforcement agencies received new information, it was assessed against their broader intelligence holdings and in accordance with their policies and procedures" (page 17).
- Monis was the subject of many law enforcement and security investigations and assessments over the period of his residence in Australia. However, the Siege Review noted that "none of these investigations or the continuous assessment of information related to Monis in the intervening periods provided any pointers into the Martin Place siege" (page 15).

## Letters provided to Martin Place Siege Review

- In response to a request for copies of correspondence between the Attorney-General or the Department and Monis, AGD provided all correspondence to the Siege Review.
- The Siege Review's report noted Monis "was a prolific writer of provocative and offensive letters, but did not cross the line into inciting violence" (page 17).

## Letters provided to the NSW Coronial Inquest

- In response to a request from the NSW Coronial Inquest, Government correspondence to and from Monis held by AGD was also provided to the Inquest. Those documents have been tendered in evidence.
- The Government is providing ongoing cooperation with the coronial inquest.



Dear Mr/s Haron

Thank you for your letter of 7 October 2014 to the Attorney-General, Senator the Hon George Brandis QC, regarding correspondence with Caliph Ibrahim, the leader of the Islamic State. The Attorney-General has asked me to respond on his behalf.

The Islamic State is listed as a terrorist organisation under Part 5.3 of the Criminal Code Act 1995. Under the Criminal Code, it is an offence to direct the activities of, be a member of, recruit for, provide training to, receive training from, provide funds to or receive funds from or provide support to, a terrorist organisation. It is also an offence to associate with a member of a listed terrorist organisation in certain circumstances where such association intentionally provides support to that organization. The penalties for these offenses are severe, and could be up to 25 years imprisonment.

The Attorney-General's Department does not provide legal advice to the members of the public and cannot address your specific question about the legality of corresponding with Caliph Ibrahim. Should you have further concerns about the legality of your proposed actions, you might like to consider obtaining professional legal advice.





- A test and review of the Department's lock-down procedures;
- The Department's business continuity, crisis management and heightened security arrangements were exercised;



administrative oversight, a small number of items of correspondence were not provided to the Siege Review. The talking points will be updated once AGD has completed a thorough investigation of this matter.

Thank you for your letter of 7 October 2014 to the Attorney-General, Senator the Hon George Brandis QC, regarding correspondence with Caliph Ibrahim, the leader of the Islamic State. The Attorney-General has asked me to respond on his behalf.

The Islamic State is listed as a terrorist organisation under Part 5.3 of the Criminal Code Act 1995. Under the Criminal Code, it is an offence to direct the activities of, be a member of, recruit for, provide training to, receive training from, provide funds to or receive funds from or provide support to, a terrorist organisation. It is also an offence to associate with a member of a listed terrorist organisation in certain circumstances where such association intentionally provides support to that organization. The penalties for these offences are severe, and could be up to 25 years imprisorment.

The Attorney:General's Department does not provide legal advice to the members of the public and cannot address your specific question about the legality of corresponding with Caliph Ibrahim. Should you have further concerns about the legality of your proposed actions, you might like to consider obtaining professional legal advice.

#### AGD handling of Monis corrrespondence


- In early January 2015, AGD conducted a comprehensive search of all documents and correspondence related to Man Haron Monis and passed relevant documents to PM&C.
- 2. The correspondence in question (letter from Sheikh Haron dated 7 October 2014) was discovered during this search.
- 3. On 2 February 2015, AGD became aware that this correspondence had been omitted from the correspondence provided to the Martin Place Siege Review due to an administrative error related to a spreadsheet.
- 4. On the same day, AGD advised the Review team by telephone that an additional item of correspondence and response had inadvertently not been provided to the Review due to an administrative error. The Review team member responded that the text of the Review had been finalised and AGD therefore did not provide the document.
- On 27 May 2015 at the Senate Legal and Constitutional Affairs Committee Budget Estimates hearing, Katherine
  Jones, Deputy Secretary, National Security and Criminal Justice Group, AGD, who was also a senior member of
  the Review, provided evidence that the correspondence "was provided to the review".
- 6. After further discussions with another colleague on the Review, Ms Jones concluded that her evidence at the Estimates hearing on 27 May 2015 was incorrect and that she was recalling a discussion of a separate document and not the correspondence in question.
- 7. Ms Jones will correct her evidence to the Senate Committee at the earliest opportunity.

#### Additional Background

- On 1 June 2015, the Department became aware that another four items of correspondence had not been provided to the Review. This was due to the same administrative error that occurred in January. These items are:
