



Surely a reading of Sir David Attenborough's book, A Life on Our Planet: My Witness Statement and a Vision for the Future (2020) and Danielle Celermajer's book, Summertime: Reflections on a Vanishing Future (2021) are sufficient for one to realise that the future of life on Earth is currently



in grave crisis. I recall the Australian poet Judith Wright's Introduction to the first edition of her book, The Coral Battleground, which was published in 1977 and reprinted in a new edition (with various preambles) in 2014:

This story has no real beginning and no one knows what its end will be. It is a part of the history of the Great Barrier Reef, that great complex structure of coral reefs and living organisms that stretches 1200 miles along the coastline of Queensland, sometimes near the shore, sometimes many miles out to sea, in a scattered or concentrated succession all the way from the northern tip of Fraser Island to beyond Cape York in the north. The Reef's story goes back far beyond the time when Cook's Endeavour found its way northwards to Torres Strait and the first white men stared down in awe at its crags and underwater gardens, and navigated among them as reef after reef threatened their keels.

Flowers turned to stone! Not all the botany Of Joseph Banks, hung pensive in a porthole, Could find the Latin for this loveliness, Could put the Barrier Reef in a glass box Tagged by the horrid Gorgon squint Of horticulture. Stone turned to flowers It seemed — you'd snap a crystal twig, One petal even of the water-garden And have it dying like a cherry-bough.

"Five Visions of Captain Cook", Kenneth Slessor

Ever since that voyage of the Endeavour, ships have passed through the Reef's waters between the coastline and the Outer Barrier, and many of them have been lost. From the wooden sailing-ships to today's great steamships, cargo vessels, and now the huge tankers, they fear the Reef and its treacherous waters and weather. But if the Great Barrier Reef could think, it would fear us more. We have its fate in our hands, and slowly but surely as the years go on, we are destroying those great 'water-gardens', lovely indeed as cherry-boughs in flower under their once-clear sea, but far more complex, far more alive, teeming with myriads of varied animal lives. The Great Barrier Reef has killed many ships and men over the years; but it has drawn and fascinated everyone who has ever seen it, and men have fallen in love with it as well as despoiled it. This is the story of the battle of a few people who loved it; the battle to save that thousand-mile stretch of incomparable beauty from the real destroyers — who are ourselves.

The story will say little of the Reef itself. It is a political story, but also it is a story of people in their interactions. Its complications stretch far beyond Australia, for the Reef has its enemies, and its lovers, in many countries and in the whole complicated structure of the world, its industry, its science and its commerce.

For many thousands of years it saw no men at all;the Aborigines were not seafarers and few if any of the Pacific Island voyagers can have been blown so far as to see it. But the Endeavour's voyage brought it into the world and exposed it to all the dangers of a civilisation that lives by exploiting everything in land and sea. The Reef will never be alone again until that world ends;and then it may not be a living assemblage. It may be a dead, blackened and crumbling hedge of limestone rock, its gardens withered and its creatures decimated.

Meanwhile, there is a story to be told.



Almost fifty years later and the Great Barrier Reef is now on the point of extinction. It is one of many such crises which are afflicting the natural world and for which we humans are responsible.

Towards the end of his life, the Cambridge literary critic F. R. Leavis (1895 — 1978) was reproached by one of his pupils for believing that the university could save our civilisation. In response, Leavis said: "But I don't want to save our civilisation — on the contrary; I want to save humanity and life from it and its accelerating developments as it completes its conquest of our lives." The greater battle now is a matter — profoundly urgent and decisive for all life on Earth — of trying to save the natural world from humanity. We are now on the verge not only of our own destruction but also, and more sadly and unconscionably, that of the other (innocent) creatures who inhabit the planet. In a letter to The Manchester Guardian on 15th December 1953, Leavis remarked: " ... those who live on literature have reason to reflect whether their host may not be in danger of dying under them." Not only our civilisation's epitaph but also humanity's.

D. H. Lawrence (of whom Leavis wrote in 1948: "Lawrence, in the English language, was the great genius of our time") was aware of this crisis a century ago; and so, in Lawrence's wake, was Leavis. In his last book, Thought, Words and Creativity: Art and Thought in Lawrence (1976), Leavis spoke of this crisis when he wrote of "the paradox to which [Lawrence] commits himself".

Today, we are essentially oblivious of the demise of that which David Attenborough — after a lifetime of expressing his respect, admiration and affection for the natural world and its inhabitants — now at this late stage in his life exhorts us to protect. We are witnessing, amongst other things, the loss of one of the Great Natural Wonders of the World but are endlessly and mindlessly preoccupied merely with what Judith Wright called the world's "industry, its science and its commerce". "Vitally, the human race is dying. It is like a great uprooted tree, with its roots in the air. We must plant ourselves again in the universe" (DHL).

To ratify the Global Ocean Treaty is absolutely essential to any effort to try to halt the current destabilisation of our planet. We urge you to do so.
