**COMMUNITY CONSULTATION REPORT
FACILITIES FOR THE LAND 200 TRANCHE 2 BATTLEFIELD
COMMUNICATIONS SYSTEMS FACILITIES PROJECT**

1. This letter is to inform the Parliamentary Standing Committee on Public Works of the nature and extent of community consultation undertaken by the Department of Defence as part of the proposed LAND 200 Tranche 2 Battlefield Communications Systems Facilities Project (the Project).
2. The aim of this consultation was to ensure the community, base residents and other stakeholders were:
 - a. well informed about the project's details through the use of effective and proven communication channels, and
 - b. provided the opportunity to raise any concerns or to seek further information so that, wherever feasible, Defence could address these in its program of works.
3. The stakeholder and community consultation activities listed below were delivered in accordance with the project's comprehensive community engagement strategy, namely:
 - a. Advertisements for these activities appeared in relevant local and national newspapers between 8 and 19 September 2018. A synopsis of Defence's advertising activities and copies of the newspaper advertisements are at Annex A.
 - b. Formal letters offering individual briefings were emailed to key stakeholders. This included Local, State and Federal elected representatives, State Departments and Authorities, and Community Groups. An example of the correspondence to key stakeholders is at Annex B. A list of stakeholders that received an invitation, and the status of each invitation, is at Annex C.
 - c. Two Community Information Sessions were undertaken, one at the Townsville Returned Services League (Hyde Park, Townsville, QLD), and one at Quest Apartments (Singleton, NSW). Details regarding community session attendance, information, and a record of any issues raised are at Annexes D to F respectively.

4. Overall, information about the Project has been well received. The feedback from those consulted to date has been supportive, with interest around local industry and Indigenous Community engagement opportunities for local residents.

5. No issues that would impact the proposed works were identified during Defence's community consultations. Defence is satisfied that it has taken all reasonable steps to inform the community about the Project, and has provided opportunities for the community to raise any concerns and questions.

The proposed works aim to provide classrooms and associated facilities to support the training requirements for the new Battlefield Management System being introduced under the LAND 200 capability Project. 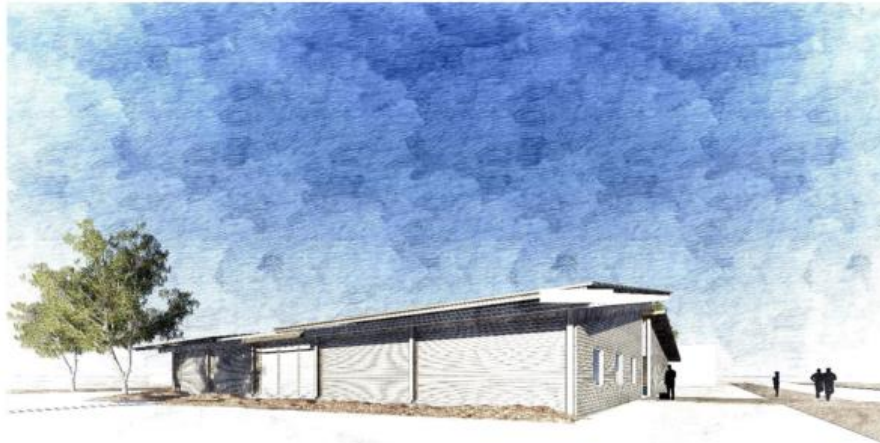

Render of Building G2725



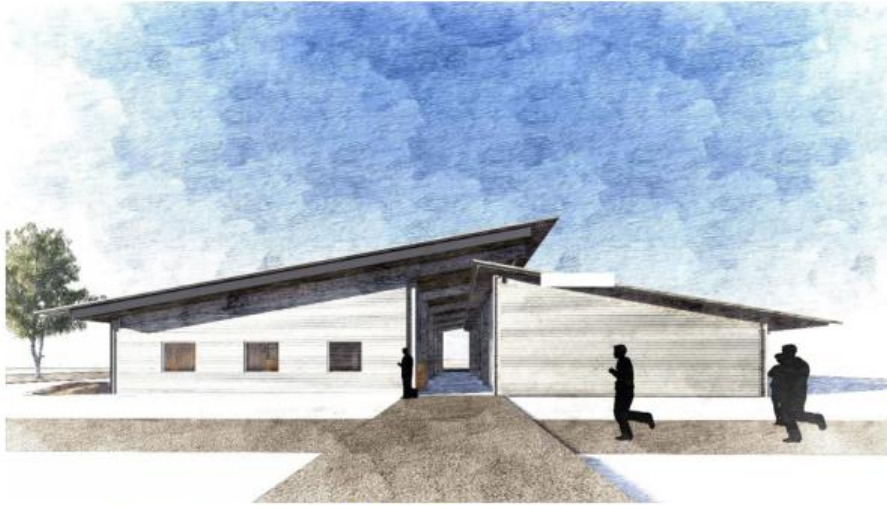

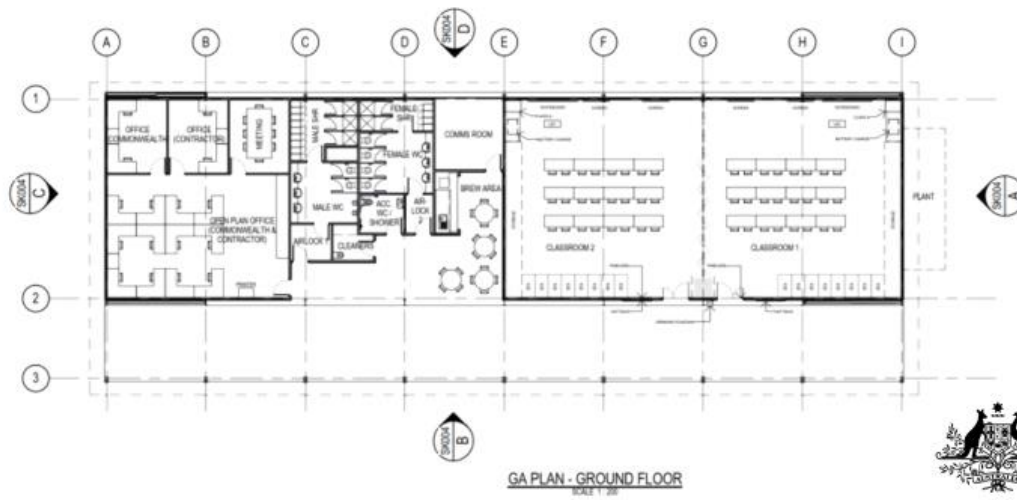

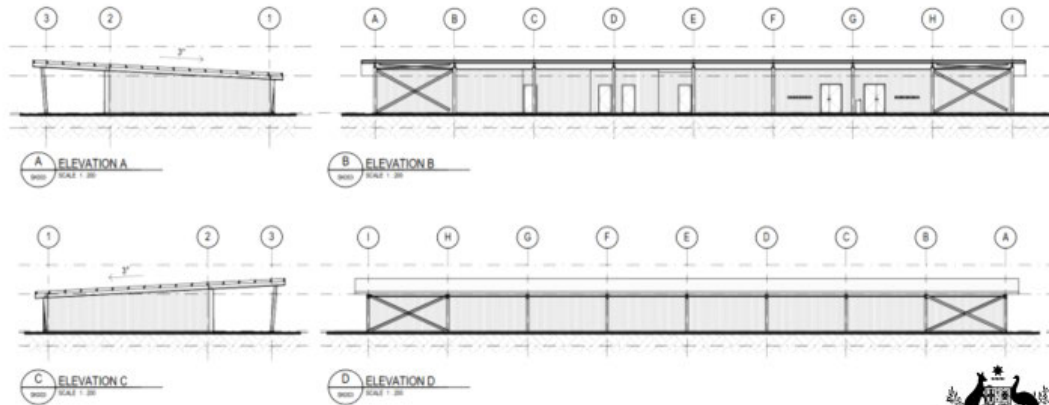

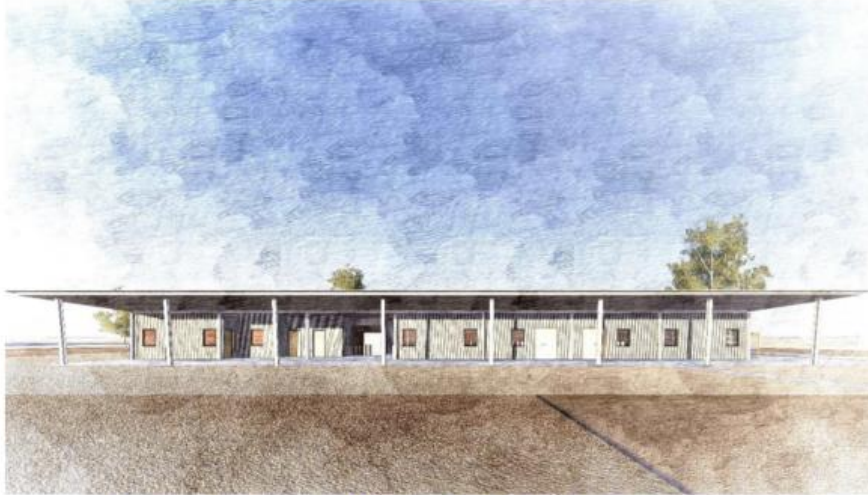

Tenderers for the project will be required to submit plans detailing how local industry will be engaged/utilised for the works and their Indigenous Procurement Policy.
