Question:

Senator PATRICK: Just in relation to that: where do you get your input advice, and where is this advice contained in a detailed form so that it can be digested in a simple form by members of the public, but perhaps more relevantly in a technical form by people directly responsible for the health care of their own patients—that is, doctors and medical professionals. Where do they get access to that advice?

Prof. Cheng: There are a range of Commonwealth materials; I'm sure the Commonwealth can provide the links to you. There are guides that are aimed at consumers and at providers, and they cover both that question of risk and of benefit. They cover how the decision might be made for an individual, recognising that these are averages we are dealing with and that individuals have their own circumstances and concerns and so on that they bring forward. For people who get vaccinated, there is advice to providers and to patients about what to look out for, what the risks are of that and what they should do if they have a complication.
