Questions on Notice from Senator Malarndirri McCarthy,

- 1. How many sacred sites are there in the Beetaloo Basin?
- 2. How many gas related Authority Certificates have been issued in the Beetaloo Basin by the Aboriginal Areas Protection Authority?
- 3. Please provide a list of Authority Certificates, including details of the applicants, and the timeframes for consultations with custodians.

Preamble

The Aboriginal Areas Protection Authority (the Authority) is an independent statutory body established by the Northern Territory Aboriginal Sacred Sites Act 1989 (The Sacred Sites Act), with the primary purpose of protecting Aboriginal sacred sites across the Northern Territory. The Authority holds records of sacred sites, and consults with custodians of sacred sites to issue Authority Certificates in relation specific development proposals. Authority Certificates provide instruction to development proponents for the protection of sacred sites in relation to their development activity. Authority Certificates provide an indemnity against prosecution under the offence provisions of the Sacred Sites Act provided the terms of the certificate are abided by. The Sacred Sites Act provides certainty for custodians that their sacred sites will be protected, and certainty for developers through the provision of clear direction for the protection of sacred sites. It is an offence to enter or work on a sacred site in the Northern Territory, and an offence to breach an Authority Certificate.

The Authority is governed by a 12 member Board of whom ten are senior custodians of sacred sites and who are nominated by NT Land Councils and appointed by the Administrator of the Northern Territory. In addition there are two Northern Territory Government representatives on the Board. Mr Bobby Nunggumajbarr from Ngukurr is the Chair of the Authority, and Ms Valerie Martin from Yuendumu is the Deputy Chair.

Question 1: How many sacred sites are there in the Beetaloo Basin?

Within the Beetaloo Sub-Basin, the Authority has records of 80 sacred sites, of which 45 are known to be water-related, as shown on the attached map (Attachment 1). There are likely to be many additional sacred sites in the Beetaloo Basin not depicted on the attached map, but as the area has not been completely surveyed, some sacred sites are not yet recorded by the Authority.

All sacred sites in the Northern Territory are afforded protection by the Sacred Sites Act whether the Authority has a record of them or not.

Question 2: How many gas related Authority Certificates have been issued in the Beetaloo Basin by the Aboriginal Areas Protection Authority?

Since 1997 the Authority has issued a total of 23 Authority Certificates for petroleum exploration activities¹ in the Beetaloo Sub-Basin, as listed in Table 1. Some important caveats on these Authority Certificates include:

- Some were issued as a variation of a previous Authority Certificate, for example a change to the proposed activities or subject land
- Many were issued in accordance with an agreement between custodians and the petroleum company, facilitated by the Northern Land Council (NLC) who undertook consultation with custodians

The Authority has two current applications for Authority Certificates for petroleum exploration activities in the Beetaloo Sub-Basin:

- Sweetpea Petroleum; EP136 two applications
- Imperial Oil and Gas; EPs 167, 168 one application

Question 3: Please provide a list of Authority Certificates, including details of the applicants, and the timeframes for consultations with custodians.

A list of issued Authority Certificates is presented in Table 1.


Where the Northern Land Council is listed as the Responsible Organisation, Authority Certificates have been issued on the basis of agreement in accordance with s22(1)(b) of the Sacred Sites Act. In such cases the Authority has assessed to its satisfaction that an agreement is an agreement for the purposes of the Sacred Sites Act.






