To Whom It May Concern

I am writing as Chair of the Sydney Airport Community Forum, in response to the consultation regarding the Airports Amendment Bill.

The Forum has discussed this Bill in depth at its last meeting and all members were supportive of most of the proposals within it. However, there are 2 issues which raised concerns with some members of our committee.

Firstly, a large number of members voiced concerns about the automatic approval for applications from airport-lessee companies for reduced consultation periods, should the Minister not respond within 15 business days. Although members understood the purpose of this change, there was concern that the default was one of acceptance rather than rejection. Many members felt that automatic acceptance set a dangerous precedence and could lead to accidental abuse. It is the view of many in the committee that the change be made so that the request is automatically *declined* should the Minister not reply within the desired timeframe.

Secondly, some members raised concerns about proposal to increase the current \$20 million monetary trigger for Major Development Plans to \$35million. It was explained that this was a figure that was regularly raised to keep it within a practical level, although a couple of members were concerned that \$15 million represented a very large rise.

Thank you for the opportunity to respond to this consultation. I hope you will consider the issues raised here.
